

**"717 Supply 2024 Silverado 2500 Bison" Sweepstakes  
(the "Sweepstakes")  
OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER OR WIN. Purchasing a product will not increase your chances of winning.**

- 1. SWEEPSTAKES DATES:** The Sweepstakes begins at 5:00 p.m. Eastern Time ("ET") on April 10, 2024 and ends at 11:59 p.m. ET on May 8, 2024 (the "Sweepstakes Period"). For purposes of these Official Rules, all times are given in Eastern Time.
- 2. ELIGIBILITY:** Open to: i) legal permanent United States residents of the forty-eight (48) contiguous United States and the District of Columbia who are at least eighteen (18) years of age or older or nineteen (19) in Alabama and Nebraska and twenty-one (21) in Mississippi, or ii) a legal resident of Canada (excluding residents of the province of Quebec) and at least the age of majority in his/her province or territory of residence as of the date of entry (the "Entrant"). Employees, officers and directors of 717 Supply LLC (the "Sponsor") and each of its subsidiaries and affiliates, distributors, vendors, advertising/promotion agencies, and any others engaged in the development, production, execution or distribution of the Sweepstakes, including, but not limited to, National Sweepstakes Company, LLC (the "Independent Administrator"), and the entities supplying the Grand Prize (collectively referred to herein as "Sweepstakes Entities") as well as their immediate family members (spouses, siblings, children and parents, regardless of where they live) or members of the same households (whether related or not) of such employees, officers and directors are not eligible to participate. All federal, state, provincial and local laws and regulations apply. Sweepstakes is void in Quebec, outside of the forty-eight (48) contiguous United States, the District of Columbia, Canada and wherever else prohibited or restricted by law.

Upon completion of the purchase, Entrant will automatically receive the entry or entries for each purchase of \$1 at the Website. *Sponsor may offer more entries during specific timeframes of the Sweepstakes and will post those offerings on the Website.* Neither Sponsor nor Independent Administrator is responsible for any entry that is lost, late, misdirected or undeliverable, whether due to system errors, omissions, interruption, deletions, defects, delay in operations or transmissions, theft or destruction or failures, faulty transmissions or other telecommunications malfunctions, entries not received resulting from any hardware or software failures of any kind, lost or unavailable network connections, failed, incomplete or garbled computer or telephone transmissions, typographical or system errors and failures, faulty transmissions, technical malfunctions, or otherwise.

**B. Entries must be postmarked by May 8, 2024 and received by May 15, 2024. Each postcard is considered two hundred and fifty (250) entries into the Sweepstakes. NO ENVELOPES WILL BE ACCEPTED. Entries submitted or completed by anyone other than the Entrant are void. No mechanical reproductions will be accepted. All entries submitted become the sole property of Sponsor and will not be returned. Sweepstakes Entities are not responsible for lost, late, misdirected, illegible, postage due or damaged mailed entries.

*During the time frame in which more entries are offered via purchase, mail-in entries (follow directions for mail-in entries above) with the words "ADDITIONAL ENTRIES" hand written in the bottom left hand side of the postcard will earn "ADDITIONAL ENTRIES" if their entry is postmarked on the specified date(s). If the "ADDITIONAL ENTRIES" offer falls on a Sunday, the mail-in entry must be postmarked the Monday immediately following the offer.*

**C. TEXT SIGN UP:** Sign up for text alerts at [www.717supply.com](http://www.717supply.com) by click on the "5 free entries" button on the Website. Provide your mobile number to receive five (5) entries into the Sweepstakes. Normal Internet access and usage charges imposed by Entrants online service will apply. Such activity will be subject to the charges pursuant to their wireless service provider's rate plan. Entrant further understands that by participating via mobile phone, if they are a potential prize winner, the Sponsor may contact them via mobile phone, which will be subject to the charges pursuant to their wireless service provider's rate plan. Please consult wireless service provider for more information. Entrants are solely responsible for any related equipment and Internet access charges, if any.

**Regardless of the method of entry, there is a limit of fifty thousand (50,000) entries per Entrant during the Sweepstakes Period.** Any attempt by any Entrant to obtain more than the stated number of entries by using multiple/different identities, and/or any other methods will void that Entrant's entries and that Entrant may be disqualified from the Sweepstakes. Entry information becomes property of Sponsor and will not be returned. Sponsor and/or Independent Administrator will not verify receipt of entries for Entrants.

Without limitation, Sponsor reserves the right in their sole discretion to disqualify any Entrant whose social media account that, in their sole opinion, refers, depicts or in any way reflects negatively upon the Sponsor, the Sweepstakes or any other person or entity; does not comply with these Official Rules; or if Sponsor receives notification about any potential infringements or breaches of law or any other reason set forth herein.

- 4. WINNING/ODDS:** There will be one (1) random drawing held on or about May 16, 2024 in Rochester, NY in which one (1) grand prize winner (the "Grand Prize Winner") will be selected from among all eligible entries received during the Sweepstakes Period. Odds of winning the grand prize (the "Grand Prize") will depend upon the total number of eligible entries received during the Sweepstakes Period. The random drawing will be conducted by the Independent Administrator, whose decisions are based upon its sole discretion and interpretation of these Official Rules and are final and binding in all respects.
  - 5. NOTIFICATION:** Potential Grand Prize Winner will be notified via e-mail or mail within two (2) business days of the date in which the potential Grand Prize Winner is selected (the "Notification"). In order to claim his/her Grand Prize, the potential Grand Prize Winner must respond to the Notification within the time frame indicated by providing the Required Documents (as defined in the "PRIZE CLAIMS" section below). In the event that: (a) the potential Grand Prize Winner fails to respond to the Notification; (b) the potential Grand Prize Winner fails to supply the Required Documents; (c) any Notification is returned as undeliverable; and/or (d) it is determined by the Sponsor, in its sole discretion, that the potential Grand Prize Winner is not eligible in accordance with these Official Rules, such potential Grand Prize Winner will be disqualified and an alternate Grand Prize Winner will be selected at random from among all remaining non-winning eligible entries received during the Sweepstakes Period.

PRIZE:** One (1) Grand Prize Winner will receive a 2024 Silverado 2500 Bison having an approximate retail value ("ARV") of \$94,920 (Color, Options and Accessories to be determined at the sole discretion of the Sponsor) and \$50,000 cash to be awarded in the form of a check (the "Grand Prize"). **The vehicle has 1,000 miles.** Grand Prize Winner must have and provide a valid U.S. Driver's License and provide proof of existing Vehicle Insurance Coverage (Comprehensive or Liability) at time of pick-up or delivery. Grand Prize Winner will be solely responsible for any applicable registration, license, title and insurance fees, all taxes (federal, state, local, sales and/or income) and any expenses not listed herein related to the acceptance and use of the Grand Prize. Sponsor does not make, nor is Sponsor in any manner responsible or liable for any warranty, representation or guarantee, express or implied, in fact or in law, relative to the Grand Prize, including but not limited to its quality, fitness for purpose or mechanical condition; the only representation/warranty/guarantee that may be provided, if any, are those of the manufacturer and/or dealer. Grand Prize Winner must accept delivery of the vehicle or pick up the vehicle within 7 days of notification that the vehicle is ready if the Grand Prize Winner lives within a six (6) hour drive of 2200 Woodview Drive, Unit B, Harrisburg, PA 17112. In the event the Grand Prize Winner lives outside of the six (6) hour drive, the Sponsor will provide either: i) one way coach class airfare for the Grand Prize Winner to a major airport nearest Harrisburg, PA to pick up the vehicle or ii) ship the vehicle to the Grand Prize Winner's residence. The ARV of the airfare or shipping will be determined at the time the Grand Prize Winner is selected.
