- To avoid injury, always use oven mitts or pot holders when handling hot cookware.
- Use caution when removing lids as steam may accumulate inside the cookware.
- Do not leave your cookware unattended while in use.
- Never allow gas flames to extend higher than the bottom of the pan.

Induction is the safest heating method because it transfers magnetic energy to the cookware, creating even heat distribution without wasting energy.

## Utensils

The NuWave Culinary Team recommends the use of high-heat-rated, silicone-based tools for cooking foods. Do not use metal utensils while cooking. Never attempt to cut foods while they are in the cookware. Any misuse of the coating will void the warranty; refer to the Limited Warranty.

## Recommended Heating

Your NuWave Duralon® Blue Ceramic Non-Stick Cookware can handle high heat. It has been tested at temperatures up to 900°F, coming out unscathed.

However, long-term or repeated exposure to such heat can cause food to scorch, burn, or discolor the cookware and potentially damage the coating. Therefore the maximum recommended ambient temperature in an oven is 500°F, while maximum safe temperature for your glass lids is 350°F. You may sear foods in your cookware at high heat for short periods of time but note that keeping the temperature down to 450°F or below will increase the useful life of the ceramic coating from 30%–50%. For best results, allow pan to heat between 280° F~300° F for up to 1 minute before inserting and cooking foods. Avoid preheating empty pans above 300° F.

## Smoke Point

If using oil, do not exceed the oil's smoke point.

The smoke point of oil is the temperature at which it begins to break down to glycerol and free fatty acids, producing bluish smoke. The smoke point also signifies the beginning of flavor and nutritional degradation.

Oil Type	Smoke Point
Rice Bran Oil	490°F
Grapeseed Oil	485°F
Canola Oil	435°F
Extra-Virgin Olive Oil	405°F
Peanut Oil	440°F
Sesame Oil	410°F
Sunflower Oil	440°F
Almond Oil	420°F

Smoke points can vary dependent upon many different factors. Consult the list of common oil types (*right*) and their median smoke point. Always practice caution when cooking with oil.

# MAINTENANCE

## CLEANING AND CARE

**NuWave Duralon Ceramic Cookware is an investment that is meant to last for years. The following instructions will not only help you properly maintain your cookware, but they will also help to extend your cookware's life to the fullest.**

**While NuWave Duralon Cookware is 100% dishwasher-safe, we highly recommend hand-washing your cookware with a mild liquid soap in order to maximize the longevity of the non-stick coating.**

### **Always:**

- Let your cookware cool on the counter or stovetop, away from heat, before washing it.
- Wash your cookware with a mild liquid dish soap and a non-abrasive cloth or sponge for longest life.
- Rinse your cookware thoroughly and dry it with paper towels or a soft cloth.
- Use silicone or wooden tools when cooking.
- Use a hanging rack to store your cookware (where possible).

### **Never:**

- Use harsh abrasives, metal scrubbers, or heavy-duty cleaning chemicals. They will damage the Duralon coating, inhibiting functionality and voiding the warranty.
- Run cold or warm water over hot cookware and do not immerse hot cookware in water. This can also damage the Duralon coating.
- Scrape the surface of your cookware with metal.
- Store your cookware stacked in such a way that the coating can be scratched or otherwise damaged.
- Heat your cookware above 450°F.

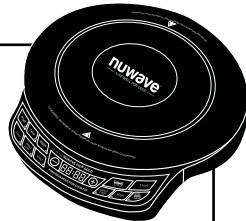

# LIMITED WARRANTY

## THE MANUFACTURER WARRANTIES

NuWave, LLC warrants that this NuWave Duralon Blue Healthy Ceramic Non-Stick Cookware will be free from manufacturer defects for 10 YEARS from the date of purchase, under normal household use, and when operated in accordance with the Manufacturer's written instructions. This Limited Warranty does not cover the ceramic coating and is valid only for the original purchaser and cannot be transferred. The Manufacturer will provide the necessary parts and labor to repair the product at the NuWave LLC Service Department. After the expiration of the warranty, the cost of the parts and labor will be the responsibility of the owner.

## THE WARRANTY DOES NOT COVER

The Limited Warranty is voided if repairs are made by an unauthorized dealer, or the serial number data plate is removed or defaced. Normal deterioration of finish due to use or exposure is not covered by this Warranty. This Limited Warranty does not cover failure, damages or inadequate performance due to accident, acts of God (such as lightning), fluctuations in electric power, alterations, abuse, misuse, misapplications, corrosive-type atmospheres, improper installation, failure to operate in accordance with the Manufacturer's written instructions, abnormal use, commercial or rental uses, or resold units.

## EXCLUSIONS

This warranty does not cover:

- Damage to the rim of product such as dents or scratches caused by utensils or stacking during cleaning or improper storage.
- The ceramic coating damage is caused by appliances such as mixers.
- The ceramic coating damaged and/or discoloration caused by sharp utensils, scouring pads, steel wool, abrasive cleansers not rated for nonstick surfaces, including bleach and other similar products.
- Commercial, professional, or workplace use.
- Warping, metal separation or discoloration due to high heat or prolonged heat exposure when empty.
- Any replacement of non-defective cookware as part of a set or component (for example other pieces in the set or matching lid).
- Damage arising from thermal shocks to the interior and exterior of the product, improper use (for example-boil dry), and failure to follow the use and care instructions.
- Workplace, Professional, or Commercial use.
- Normal wear and tear, such as discoloration, scratches, stains on the interior of

the product that do not materially impact the nonstick properties of the cooking surface.

- Accidental or unintended damage.

NuWave LLC reserves the right to void the Limited Warranty, where allowable by law, for products purchased from an unauthorized dealer.

## TO OBTAIN SERVICE

The owner shall have the obligation and responsibility to pay for all services and parts not covered by the warranty; prepay the freight to and from Service Department for any part or system returned under this warranty; and carefully package the product using adequate padding material to prevent damage in transit. The original container is ideal for this purpose. Include in the package the owner's name, address, daytime telephone number, a detailed description of the problem, and the RGA (Return Goods Authorization number).
