


GETTING STARTED

The Wireless Magnetic Power Bank will arrive with a partial charge. It is recommended to charge the battery to 100% upon arrival and after each use.

POWER ON/OFF

Press the Power Button to turn on the Power Bank. After ±30 seconds, it will turn off automatically if not charging a device.

BATTERY LEVEL DISPLAY



2.1 BATTERY LIFE LEVEL

The number displayed is the percentage of battery remaining in the power bank.

2.2 FAST CHARGING ICON

Illuminates when a phone that supports fast charging with fast charging cable or wireless charging.

2.3 WIRELESS CHARGING ICON


This icon is always present, indicating the ability to wirelessly charge.

RECHARGING THE POWER BANK

To recharge, use the included Type-C Charging Cable and any USB power source (i.e. a wall adapter, computer USB port, car charger, etc. – not included). Once plugged into a power source, the Battery Level Display will illuminate with the current percentage of battery. As the power bank charges, the level will blink and count up. The power bank is fully charged when the level has reached 100%.



CHARGING & COMPATIBILITY



WIRELESS CHARGING

MagSafe® is a technology developed by Apple™ that is built into the internal engineering of select iPhone® models (iPhone 12 and newer).

The magnet of the Power Bank will align with the wireless charger inside the iPhone to provide a faster charge and ensure the Power Bank stays in place.

- Press the Power Button to turn on the
 Power Bank
- Align it with the charging coils on your device. If it is compatible with MagSafe, the Power Bank will secure to the device via magnetic connection.
- The device will begin to charge.

iPhone models compatible with MagSafe: iPhone 14, iPhone 14 Pro, iPhone 13. iPhone 13 Pro. iPhone 12 and iPhone 12 Pro.

CHARGING & COMPATIBILITY

WIRELESS CHARGING (cont'd)

No MagSafe? The wireless charger is compatible with phones that are enabled with wireless charging.

- 1. Press the Power Button to activate wireless charger.
- Align the Power Bank with the charging coils on the back of the phone.
- 3. The device will begin to charge.

Note: If the device does not begin to charge, adjust the positioning on top of the Wireless Charging Pad until there is a successful connection.

Refer to your smart phone's manual to confirm wireless charging compatibility.



USING A CONNECTED CHARGING CABLE

- A. USB Charging Port
- B. Type-C Charging Port
- Connect a compatible charging cable to one of the ports.
- Connect the other end of the charging cable to compatible device.
- The device will begin to charge automatically.

Note: Multiple charging methods may be used at once, but will slow down charging speed and more quickly decrease the power bank's battery level.



USING THE MAGNETIC RING

By adding the Magnetic Ring to the back of a device or case, a more secure connection between the Power Bank and the device will be made to limit charging interruptions.

- 1. Peel the brown adhesive protector off the magnetic ring.
- 2. Place magnetic ring adhesive-side down onto the back of the smart phone or case.
- 3. Line up the ring on the power bank with the magnetic ring.











Use the Magnetic Ring with wireless-enabled devices not equipped with MagSafe technology.

Wireless charging placement differs by device. Scan the code for troubleshooting and tips on applying the magnetic ring.

Use of the Magnetic Ring is at the consumer's discretion and Boundless will not be held liable for any damages to devices incurred during loss of magnetic connection.

USING THE STAND

The Magnetic Foldable Stand is stored flat on the backside of the Wireless Magnetic Power Bank.

- Looking at the back of the unit (side opposite of the wireless charging ring), lift off the magnetic foldable stand using the tab at the top.
- Pull the tab down, creating a triangle with the folding magnetic flap.
- Line up the tabbed edge of the stand with the matching outline.

The magnet will set the stand in place. To disengage, lift the magnetic flap up and lay back flat.
