It is agreed and understood that the undersigned is an agent of the applicant and is able to enter into and make binding agreements on its behalf. All amounts charged under this account are payable in full within the terms established for this account. All payments are due and payable at the office of SMRT Commercial Lighting Controls. Any dispute arising out of this contract, or any transaction between the undersigned and SMRT Commercial Lighting Controls, including the sale of products and or services, shall be determined by the laws of the state of Pennsylvania.

Distributor payments paid in over 30 days are late, are subject to cancellation of Stocking Distributor status, and can revert to Non-Stocking Distributor status & Non-Stocking Distributor terms and conditions. An additional 1.75% per month interest charge (21% annual percentage rate) or the maximum rate permitted by applicable law, will be charged on all invoices not paid within 30 days. This rate is based on your past due balance at the end of each billing period.

In the event of default and referral to an attorney or collection agency, i agree to pay all costs of collections including reasonable attorney fees. The acceptance of products and or services purchased at quoted or published prices made pursuant to this agreement constitutes a written contract between recipient /customer of the goods and for the purpose of Pennsylvania general laws. Unless otherwise specified, payment of all goods and services are NET 30 days from day of shipment. Bills that go unpaid for 90 days, will be pursued by attorney or collection agency with the undersigned agreeing to pay all costs associated with collecting the amount(s) due.
