

Official rules and information relevant to lotteries

ELIGIBILITY

- Participation is reserved exclusively for persons 18 years of age or older and physically located in the province of Quebec at the time of ticket purchase.
- The following individuals are not eligible to participate in the draws: Hockey Lac St-Louis employees, volunteers assigned to the draw, employees of the company providing the draw technology, members of the Hockey Lac St-Louis Board of Directors, all persons with whom these employees and members reside, as well as the immediate family of these employees and members

HOW TO PARTICIPATE

- Tickets will be sold through an online platform administered by Hockey Lac St-Louis employees.
- Participants who purchase tickets via the online platform receive a scanned stub via email listing the numbers associated with the package purchased.
- All individual ticket numbers corresponding to the purchase are collected simultaneously for the electronic drawing of the winning number by a random number generator.
- Each participant will be required to provide contact information to purchase tickets and be eligible for the draw.

DRAW AND COMMUNICATION WITH THE WINNER

- The date and time of the winning ticket draw for each draw will be announced on the website www.tirage-5050.ca and will be printed on the participant's ticket.
- The winning number and prize will be announced on the website <u>www.tirage-5050.ca</u> following the draw. The winning number will also be announced on the official Facebook account of Hockey Lac St-Louis.
- In the event that the advertised (posted) number and the official winning number are not identical, the latter shall prevail.
- The person holding the winning ticket must claim the prize by contacting Hockey Lac St-Louis by email, by transmitting his purchase email and his proof of identity. The holder of the winning ticket will have fourteen (14) business days from the time of the announcement to claim the prize. In order to facilitate the awarding of the prize to the winner, Hockey Lac St-Louis will also use the contact information provided by the ticket purchaser to communicate with him/her during the claim period.
- In the event that the selected entrant has not claimed the prize within fourteen (14) business days, the prize money will be invested in a program approved by the Régie des alcools, des courses et des jeux du Québec.

- Winner will be required to complete a Declaration and Release Form prior to taking possession of the prize.
- The amount of the prize to be won (winner's prize) represents 50% of the total amount collected and advertised (grand prize). In the event that the advertised (posted) amount and the total amount collected are not the same, the latter shall prevail.
- The prize will be paid by bank transfer in Canadian dollars, following the obtaining of the winner's banking information, within 60 working days following the draw. In some cases, draw prizes may be paid by cheque.
- Winner's prize is not transferable and must be accepted as awarded without substitution.
- Only the holder of the winning ticket can claim the prize.
- Hockey Lac St-Louis assumes no responsibility for any other person who claims to have an
 interest or right to receive the entire prize or a portion thereof associated with the winning ticket.
- The odds of winning depend on the total number of tickets sold.
- Tickets are subject to verification by the draw organizers. Any fraudulent ticket will be automatically rejected and will not be eligible for a prize. Raffle ticket will be void if there is evidence that the ticket was stolen, unissued, ineligible, altered, counterfeit, defective, printed in duplicate or printed/produced in error. Unauthorized persons who copy, sell or alter tickets are subject to prosecution.

OTHER GENERAL CONDITIONS

- No official tax receipt will be issued for the purchase of Raffle Tickets, as required by the Canada Revenue Agency.
- All ticket sales are final. There will be no refunds issued to anyone for any reason. All tickets
 purchased including the draw numbers on those respective tickets that are part of the draw are
 non-refundable, even if a ticket purchaser made an error in selecting the number of tickets they
 wish to purchase.
- If the integrity of a draw is compromised in any way, Hockey Lac St-Louis will advise the Régie des alcools, des courses et des jeux du Québec (RACJ) and consult with the RACJ on the best way to proceed. Hockey Lac St-Louis must receive the approval of the RACJ before cancelling the draw and/or modifying the draw rules.
- Hockey Lac St-Louis and all sponsors and partners of this draw program administer it in good faith. No partner (nor employee or representative of any partner) can be held responsible for any error, malfunction of the system or any decision made in relation to the administration of the program.
- The winners release Hockey Lac St-Louis, its advertising and promotional agencies, their employees, agents and representatives from any and all liability for any damages they may suffer as a result of accepting or using the prize.
- This draw program is subject to all applicable federal, provincial and municipal laws and regulations. All decisions made by the organizers are final and without appeal.
