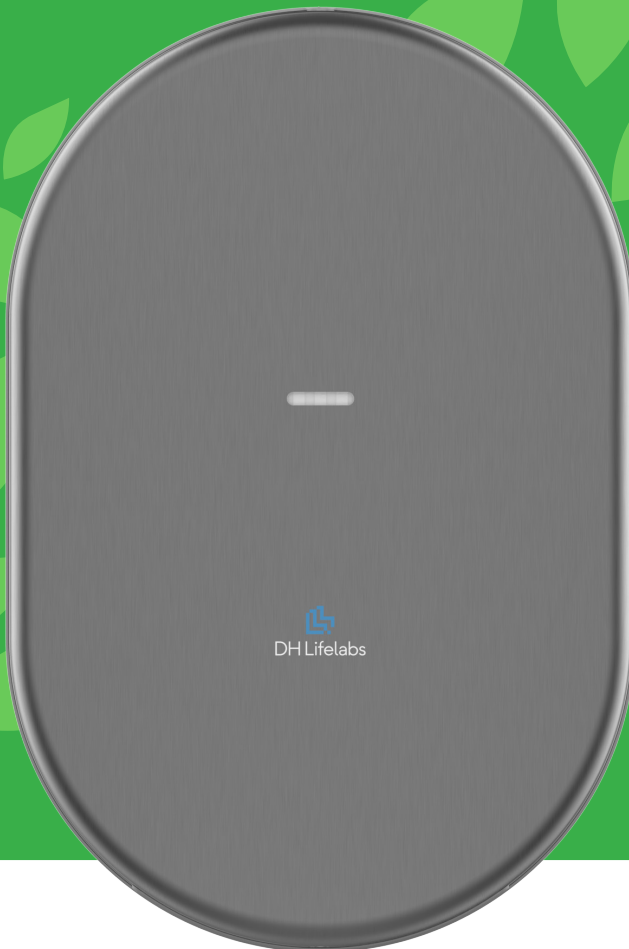

## Sciaire Storm HD100 / HD110

Sciaire Storm is an advanced automatic air purifier designed for public washrooms, in various settings such as shops, restaurants, offices, and homes. It combines bi-polar air ionization technology and HEPA filtration to deliver rapid and effective air purification. The device has two key modes, a hand drying mode for immediate individual use and an air purification mode after use to clean the environment.

- ! WARNING: Ensure the device is fully assembled in accordance with the instructions before use. If casing is removed or handled improperly the internal components of the unit may cause harm or become permanently damaged.
- ! Use this unit only in the manner intended by the manufacturer.
- ! This device complies with the maximum allowable concentration of ozone of 0.05 parts per million by volume (ppmv) in a 24 hour period.
- ! The unit is intended to be permanently connected to the power supply.
- ! Ensure that the mains supply (voltage, frequency, and phase) complies with the device's rating label.
- ! This device is not intended for use by persons (including children) with reduced physical, sensory or mental capabilities, or lack of experience and knowledge, unless they have been given supervision or instruction concerning use of the device by a person responsible for their safety.
- ! The device should be provided with a fused spur, isolator switch capable of disconnecting all poles, having a contact separation of at least 3mm.
- ! The device is designed for dry, internal location only. Do not allow the area around the device to become damp or wet.
- ! All metal parts in contact with this device MUST be earthed, including any wall covering.
- ! Always use the device with the accessories provided.
- ! Do not move the device while it's wired.
- ! Do not use the device with damaged wires. It must be replaced by a suitably qualified service engineer in order to avoid a hazard.
- ! If the device is not working properly, has received a sharp blow, has been dropped or damaged, do not use the device and contact customer support for repair.
- ! Troubleshooting and internal maintenance must be performed by qualified service personnel.
- ! Wear gloves when inspecting and cleaning the device.
- ! Do not use any power wash equipment for cleaning on or near this device.
- ! Do not use the device for drying hair or other items.

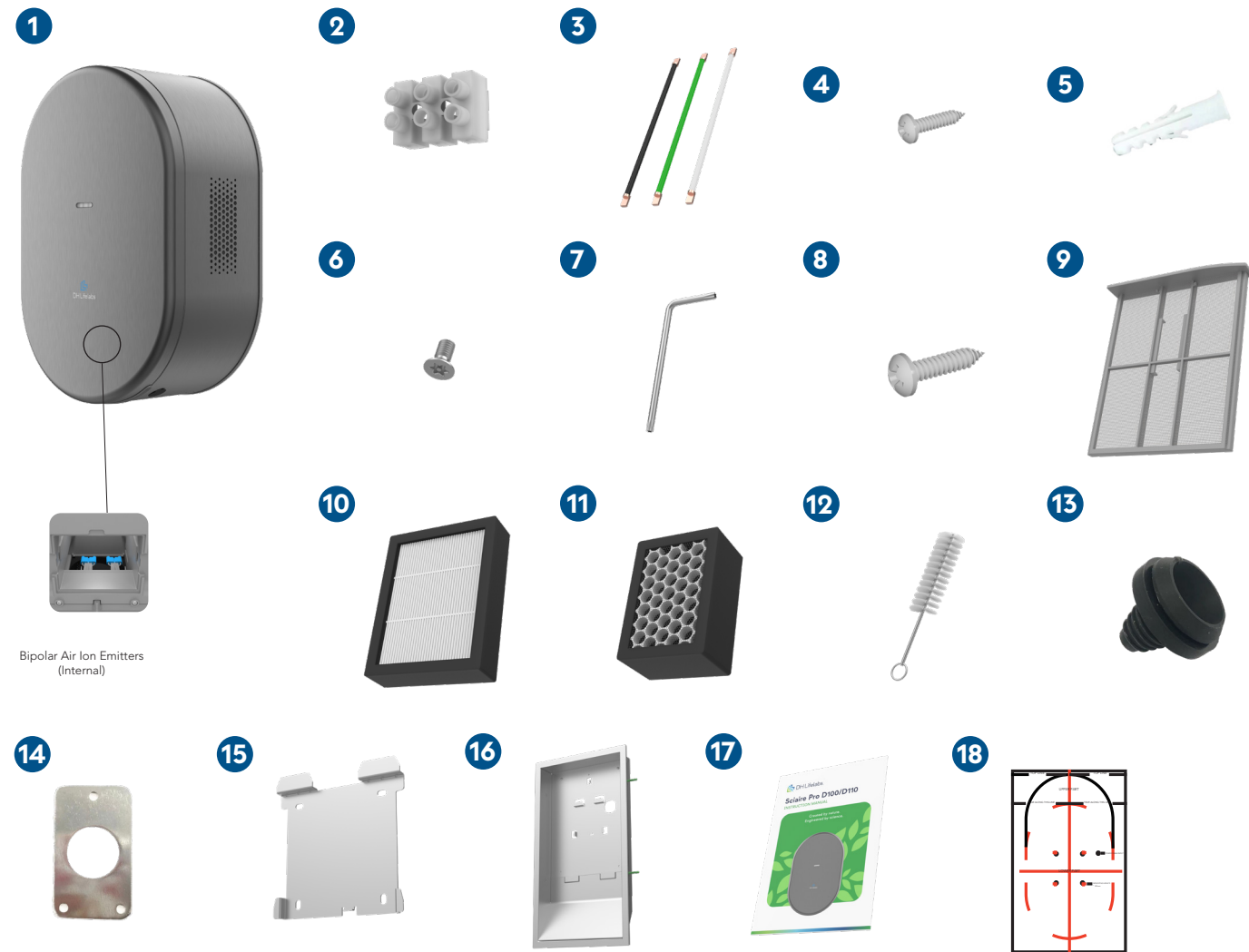
- ! Do not obstruct air inlets or outlets. Do not cover the device while in use.
- ! Do not use the device in the following places:
  - Where the ambient temperature is below -10°C or above 40°C
  - Where the device may come into direct contact with water
  - Where the device is under direct or strong sunlight
  - Where condensation may form within the device.
  - Locations where corrosive, neutral, or reductive gases are present.
- ! This device is intended for indoor use only.
- ! Consult local and national accessibility codes and regulations for relevant installation guidelines. Conformity and compliance is the responsibility of the installer.
- ! Make sure electricity is switched off at the main panel before installing, maintaining or cleaning this device.
- ! Ensure that the conduct and wires are long enough to connect to the backplate and the terminal block.
- ! Ensure no pipe work (gas, water, air) or electrical cables, wires or ductwork are located directly behind the drilling/mounting area.
- ! Choose a completely flat, vertical wall capable of supporting the full weight of the device.
- ! Install the device in a location where it will be easy to use and ensure that there is adequate space around the device for cleaning and maintenance.
- ! Avoid installing the device in locations where people or doors might bump into the device.
- ! If the device is installed too low, water may splash onto the device when the floor is being cleaned. (The bottom of the device must be mounted at least 15 inches/381mm above the floor). This is also required to gain access to the HEPA filter for cleaning and/or replacement.
- ! Check that the electrical supply corresponds to that shown on the rating sticker of device. Do not connect the device to any electrical supply other than that stated on the rating label of the device. Permanent damage or improper, unsafe operation of the device may result.
- ! To avoid contact with water from the user's hands, do not install the device above any electrical equipment.
- ! Do not use sealant when fixing the device to the wall. This device is not suitable for mounting onto porous wall surfaces (e.g. plaster) without a back panel, to avoid discoloring or damage to unprotected walls.
- ! Before installation, please consider the flow of traffic through the washroom. We are not recommended to put the device in an area of the washroom that makes people steps in front of high footfall areas. You can install the device as near to the sinks as possible to minimize water spillage onto the floor from hands. You should also consider the mounting height of the devices, and who will be using it.

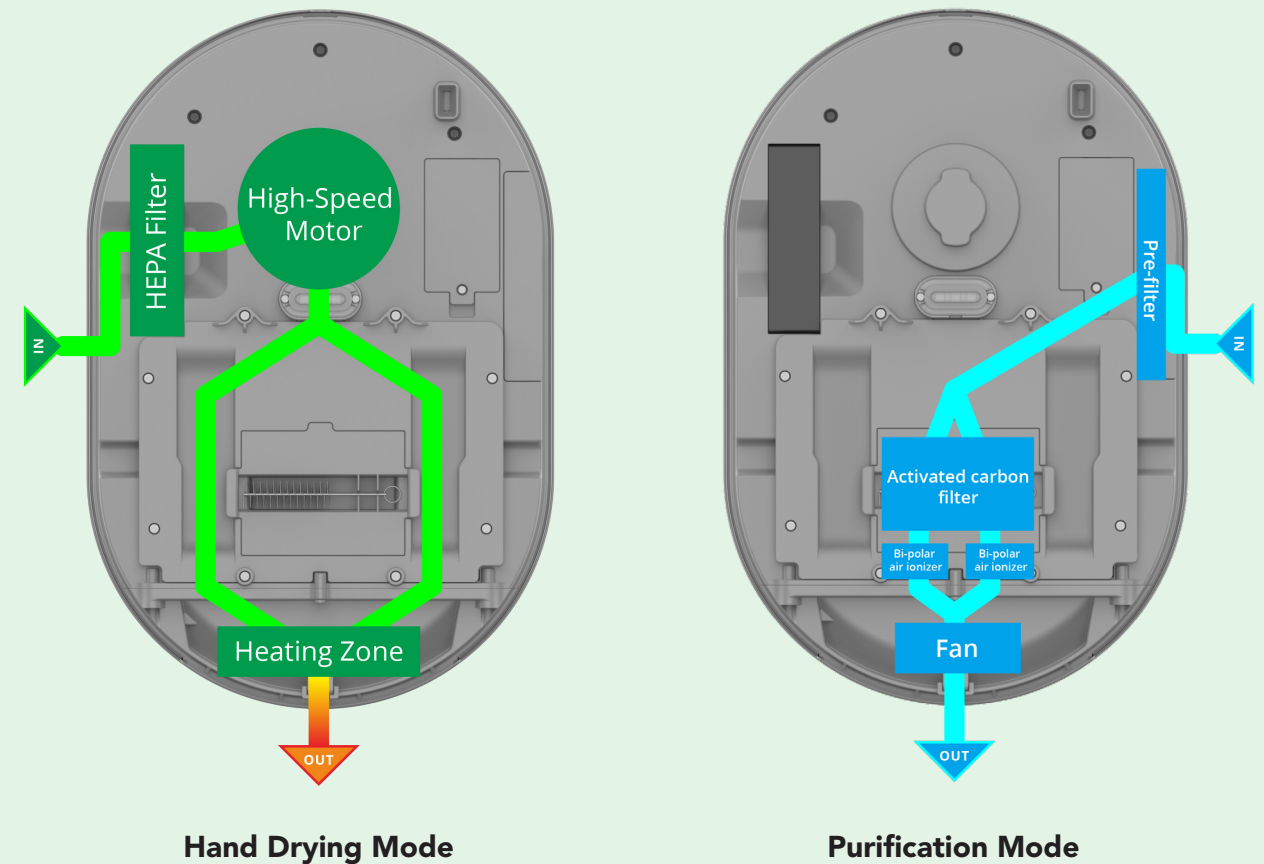
# Device Summary

## Purification Mode (Activated After Using Hand Drying Mode)

1. Air comes in the right side of the device by first passing through a pre-filter, filtering large particles. Air is then passed through an activated carbon filter to absorb odors.
2. Air is then passed through Bi-Polar Air Ionizers, generating positive and negative ions, which work to actively neutralize airborne viruses and bacteria in the air.
3. The powerful motor circulation system continues to draw in ambient air, passing through the filters and distributes positive and negative ions throughout the environment, to help continuously disinfect the air.

## Hand Drying Mode

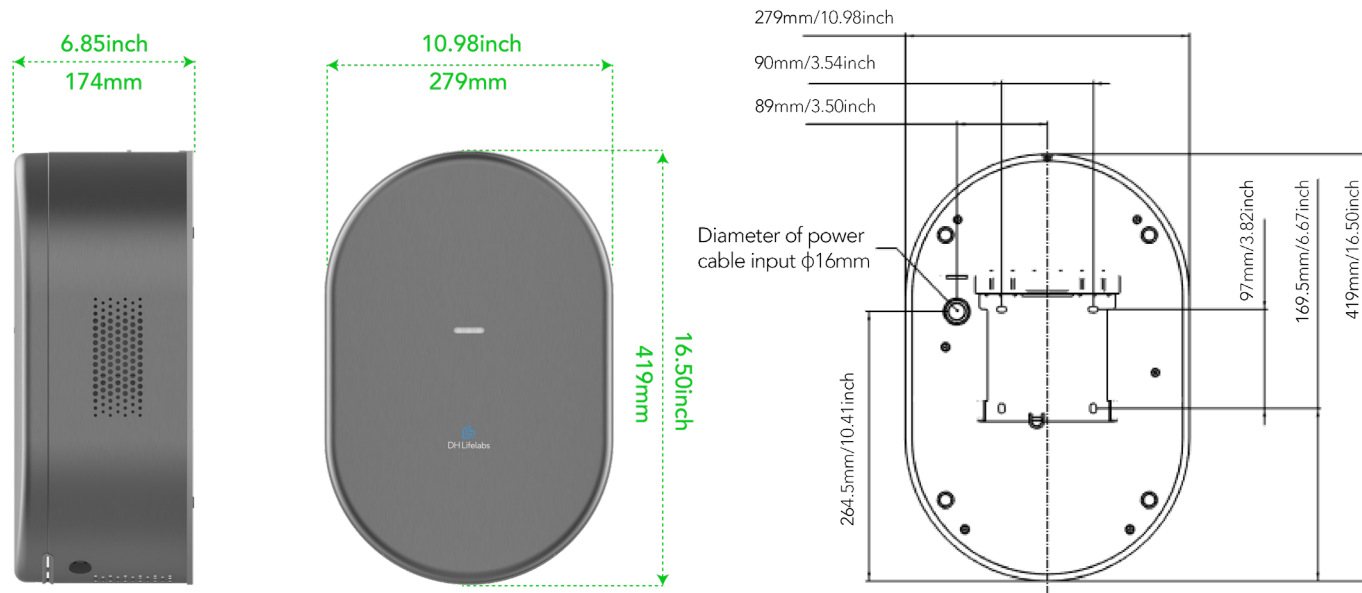
1. Air is pulled into the left side of the device by first passing through a HEPA filter. The HEPA filter captures pollutants and particles down to 0.3 microns in the air.
2. The filtered air is heated and distributed at the base of the device to dry your hands using a powerful motor.

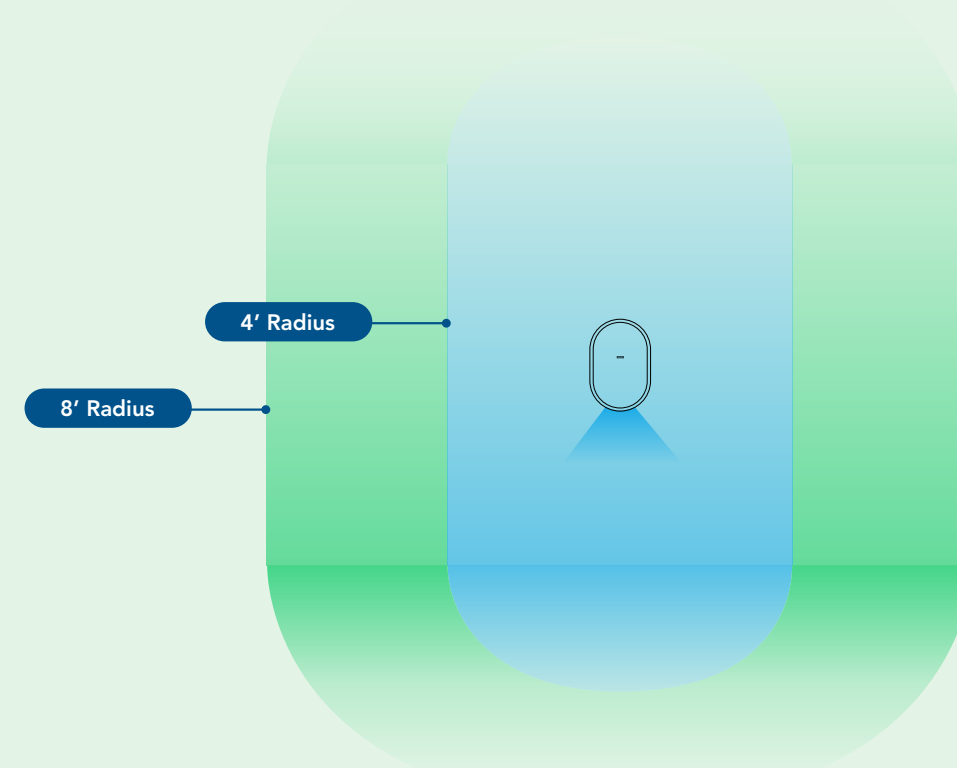
## Before Placement and Installation

Before installation, please consider the traffic at various locations in the restroom. We do not recommend placing this device in front of crowded areas in the restroom. Refer to the suggested mounting heights on the next page.

- 1 DO NOT place the device too close to the door.**
- 2 DO NOT place the device too far away from the sink(s).**
- 3 DO NOT place above reflective surfaces.**
- 4 DO NOT place the device in direct sunlight.**

### Efficiency Radius

Installing the device at a 4-foot distance will have a great cleaning and deodorization effect. It is still effective at an 8-foot distance. Efficacy depends on specific environmental conditions of the space, including air flow, space size and frequency of hand drying use.



## Packaging

1. Remove the device from the box. Confirm all items shown in the Product Overview are included. It is recommended to retain the packaging in case of storage or repair purposes.
2. Place the device on a cloth to avoid marking its surface, and to confirm installation location prior to setup.

## Electrician may be needed for power wiring/rerouting wiring.

1. It is imperative that the location of the hole drilled for the power cable input wires matches up with the appropriate placement of the device.
2. There is a recommended height for each segment of user. The height is to be measured from the floor to the bottom of the device.
3. To mark the proper placement for the power cable input hole, refer to the placement sticker included in the packaging. Do not remove the backing to the sticker if not immediately installing device after electrical work is complete. Utilize the sticker to mark the wall for the exact location of the power input for accurate electrical wiring placement.

### 1 Position Installation Sticker

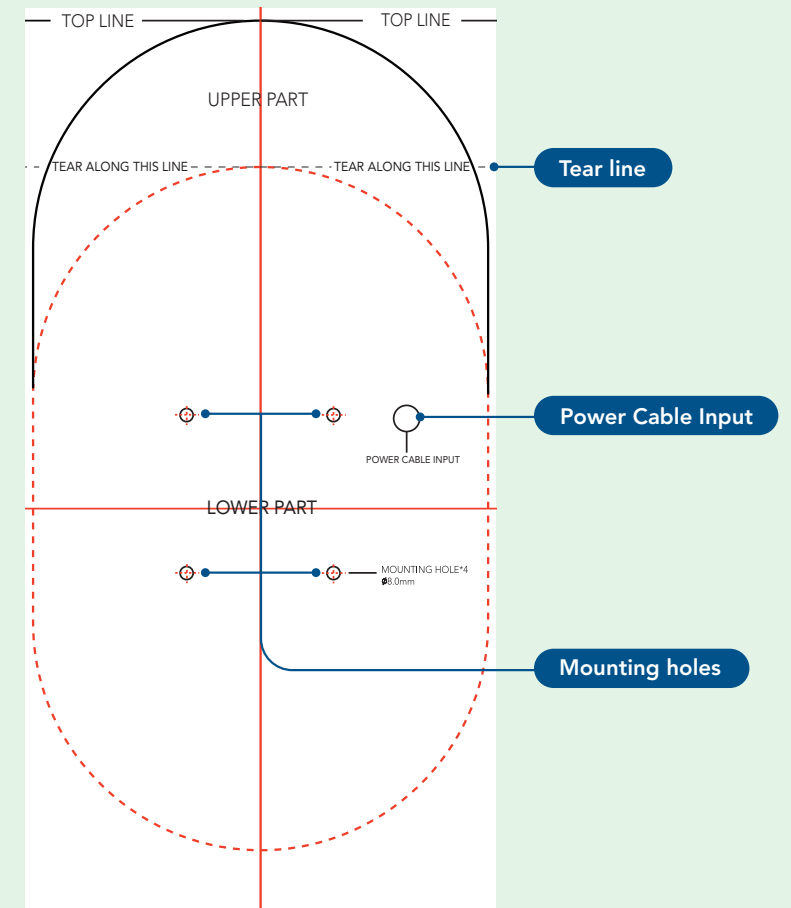
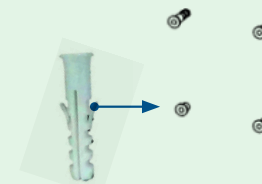
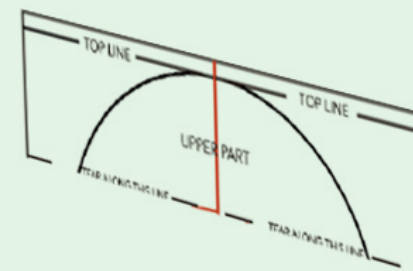
Position the installation sticker on the intended wall based on the location of the power cable input. The power cable input may be newly installed for accurate placement of the device. Ensure the diameter of the hole for the power cable input is as displayed on the sticker.

### 2 Drill Mounting Holes

Drill 4 mounting holes according to the marks.

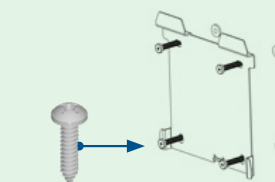
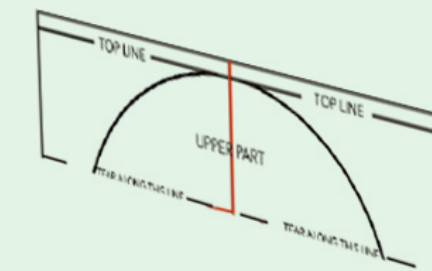
### 3 Insert Expansion Tubes

Tear off the lower part of the sticker along the line. Insert the expansion tubes (4) into the mounting holes.

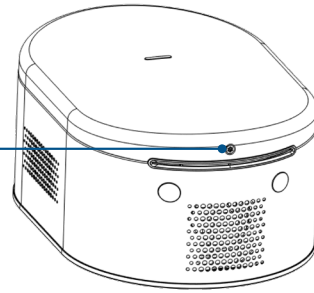
Align the holes of the mounting bracket and the mounting holes on the wall. Insert the wood screws to the holes. Tighten the wood screws to fix the mounting bracket to the wall.



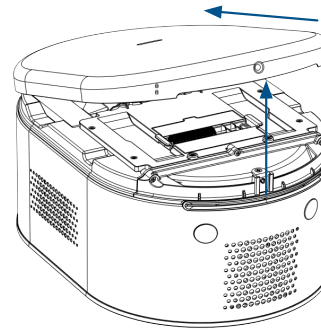
### 5 Remove Front Cover

Use the anti-theft wrench to loosen the anti-theft screw in the bottom part.

### 7 Remove Power Supply Cover

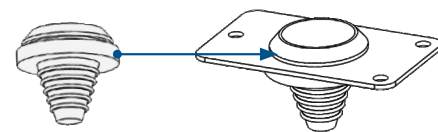

Loosen the screw on the cover of the power supply unit and take off the cover.

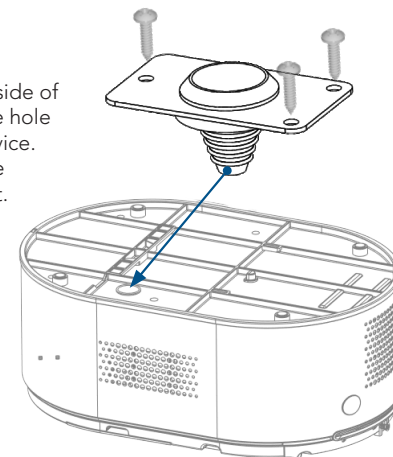


### 8 Install Gromet & Small Bracket

Trim the gromet to a moderate size. Install the trimmed gromet to the small bracket.

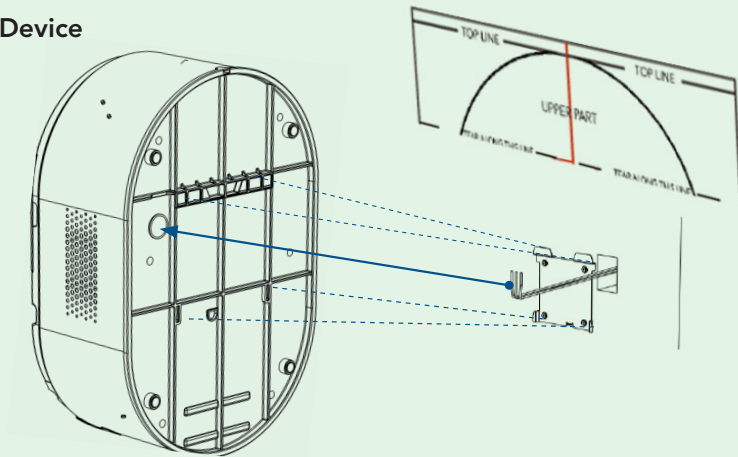


Install the protruding side of it into the power cable hole on the back of the device. Install the unit with the tapping screws to fix it.



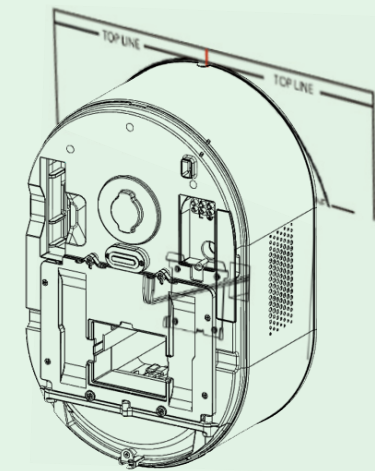
### 9 Pass Power Cables Through Device

Hold up the device. Pass the power cables through the hole on the back of the device.



### 10 Mount Device to Bracket

Align the top of the device to the TOP LINE labeled on the positioning sticker. Slide the device down until the mounting slots on the back of the device snaps into the mounting bracket. Check to make sure the device is secure and does not wobble.



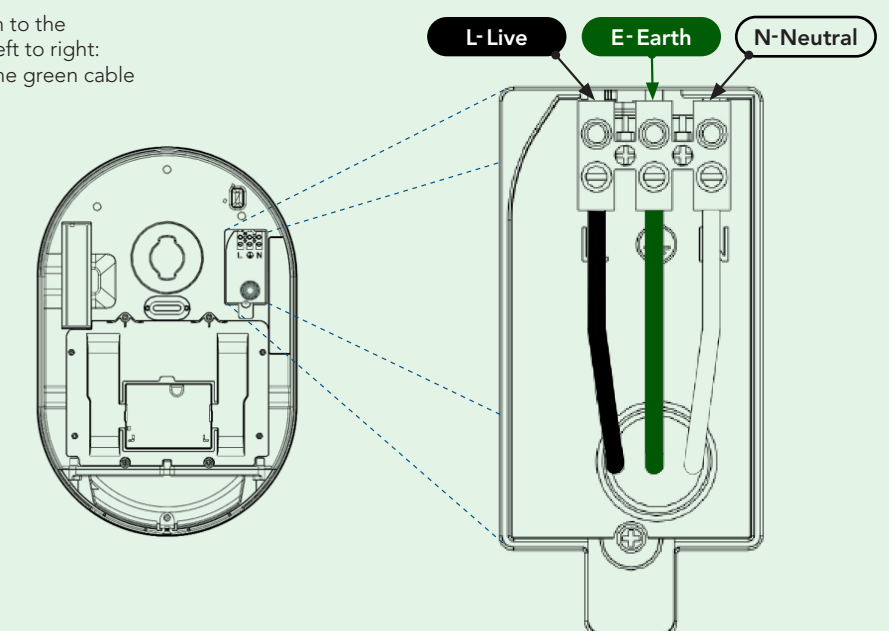
### 11 Connect the power cables to the terminal

Organize the power cables and connect them to the corresponding terminal ports. In order from left to right: first is the black cable (L-Live). Secondly, it's the green cable (E-Earth). Last, the white cable (N-Neutral).

**Left:** Black cable (L-Live).

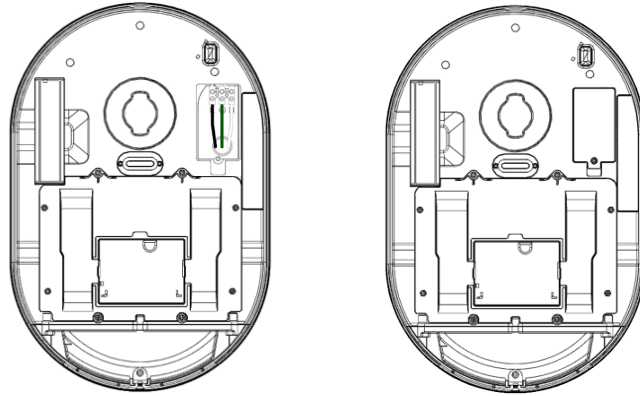

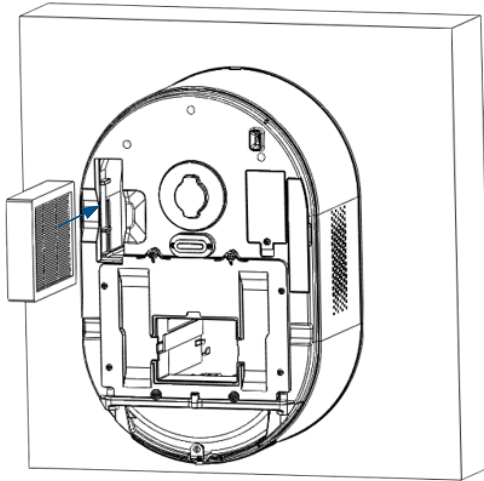
## 12 Install the Cover for the Power Supply

Reattach cover for the power supply unit and secure it.

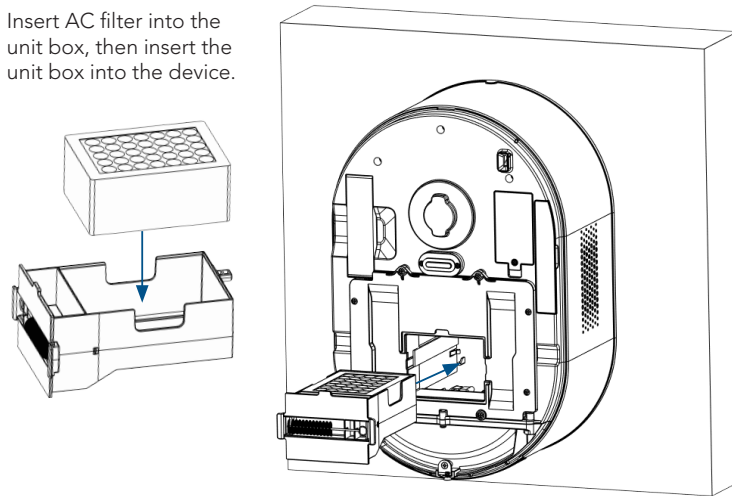


## 13 Install the HEPA & AC filters

Tear off the package of the HEPA filter and insert it to the unit.

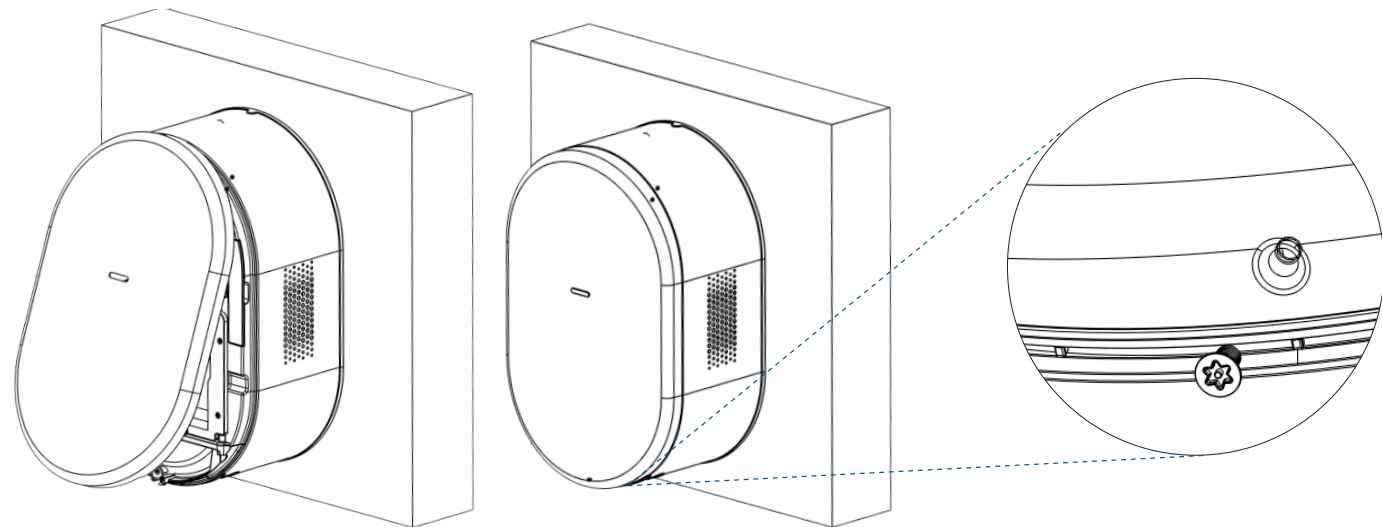


Insert AC filter into the unit box, then insert the unit box into the device.



## 14 Resecure Front Cover

Install the top-end of the cover first, then snap the bottom-end until the edge of the cover coincides with the edge of the device. Screw in the anti-theft screw with the anti-theft wrench to attach the cover to the device. Once complete, tear off the upper part of the positioning sticker.

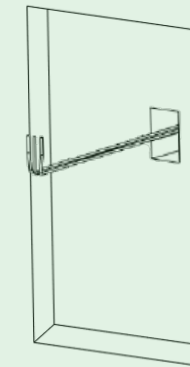
### 1 Create Installation Frame

According to the installation height and power cable position, create a frame in the wall with size:

**Width:** 366 mm

**Middle:** Green cable (E-Earth)

**Right:** White cable (N-Neutral).

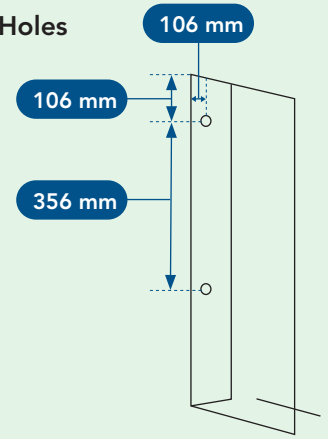


### 2 Drill Mounting Holes

Drill 2 holes on both sides of the wall frame according to these measurements.

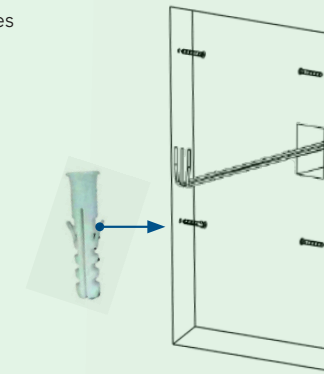
**Drill bit:**  $\phi$  8.0mm.

**Hole Depth:** 60mm

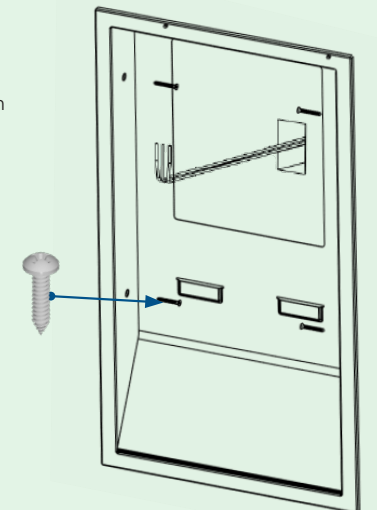


### 3 Mount ADA Compliance Kit

Insert 4 expansion tubes into 4 mounting holes.



Align the ADA compliance kit to the wall and secure it with 4 wood screws.

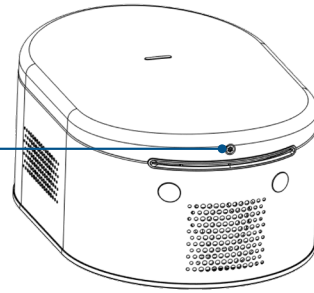




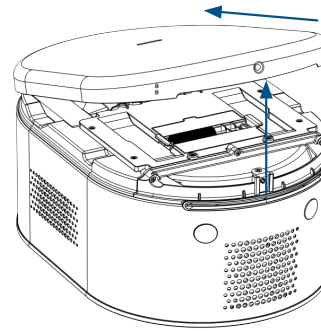
#### 4 Remove Front Cover

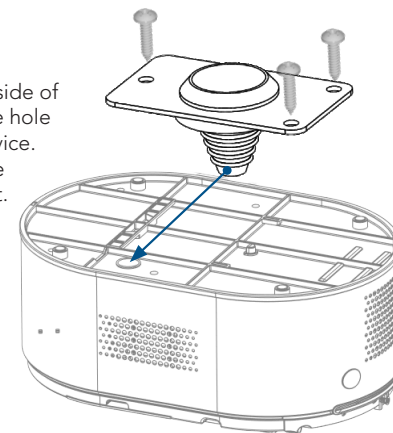


#### 6 Install Gromet & Small Bracket

Trim the gromet to a moderate size. Install the trimmed gromet to the small bracket.

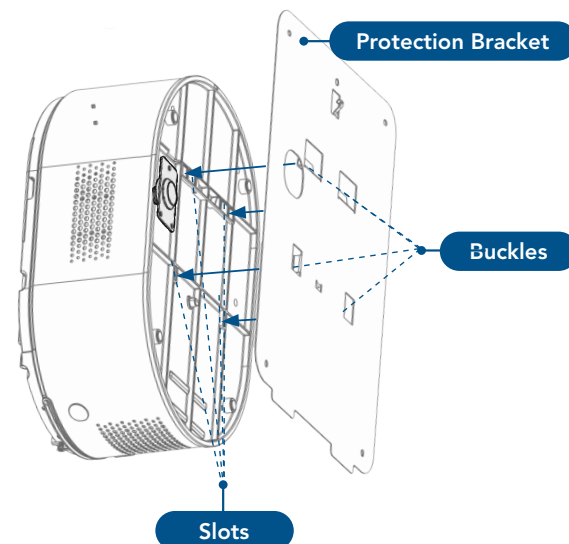


Install the protruding side of it into the power cable hole on the back of the device. Install the unit with the tapping screws to fix it.

With the back of the device facing up, install the protection bracket. Snap the buckles on the protection bracket to the slots on the back of the device. At this point, installation of this part is complete, as shown in the figure above.



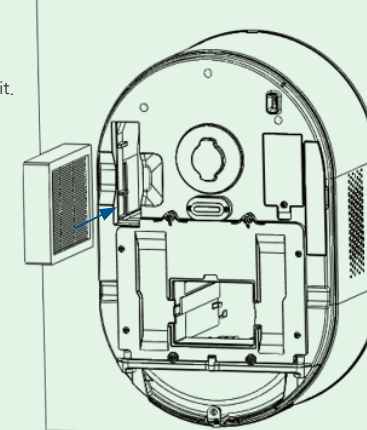

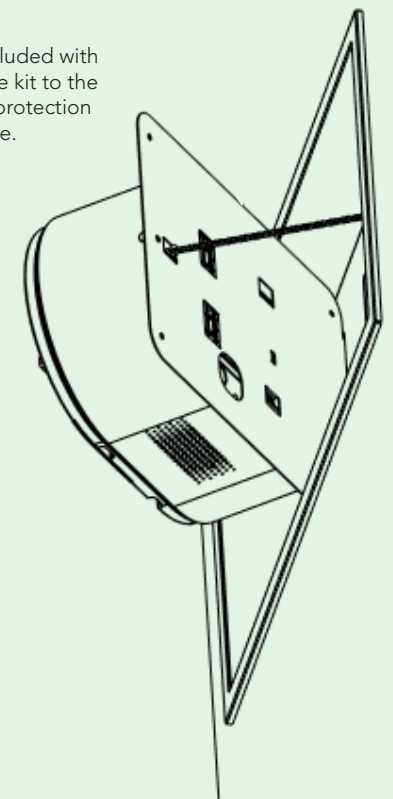


#### 10 Secure Device to ADA Compliance Kit

Insert the bottom of the protection bracket into the slots at the bottom of the ADA compliance kit.

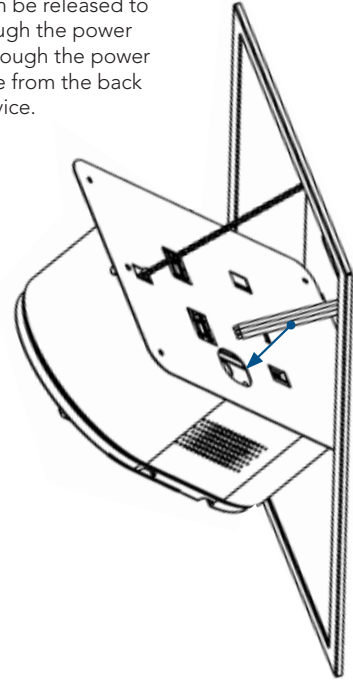


Attach the chain included with the ADA compliance kit to the top rear slot of the protection bracket of the device.

Hands can be released to pass through the power cables through the power cable hole from the back of the device.

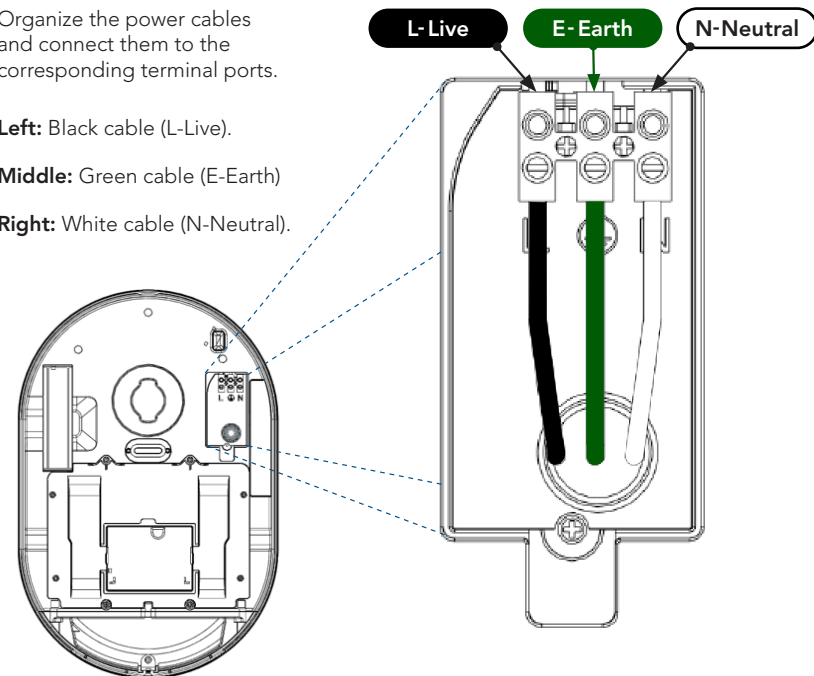

The device has two sensors to each side of the air output. Place hands separated and parallel to the device to trigger sensors.



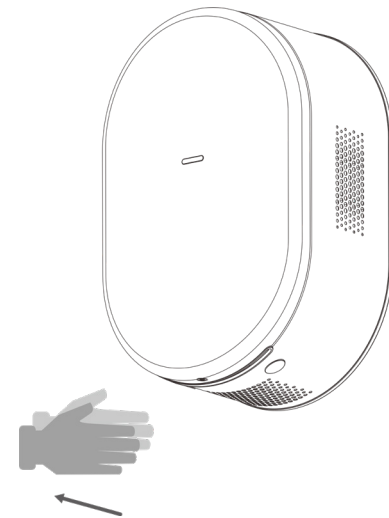

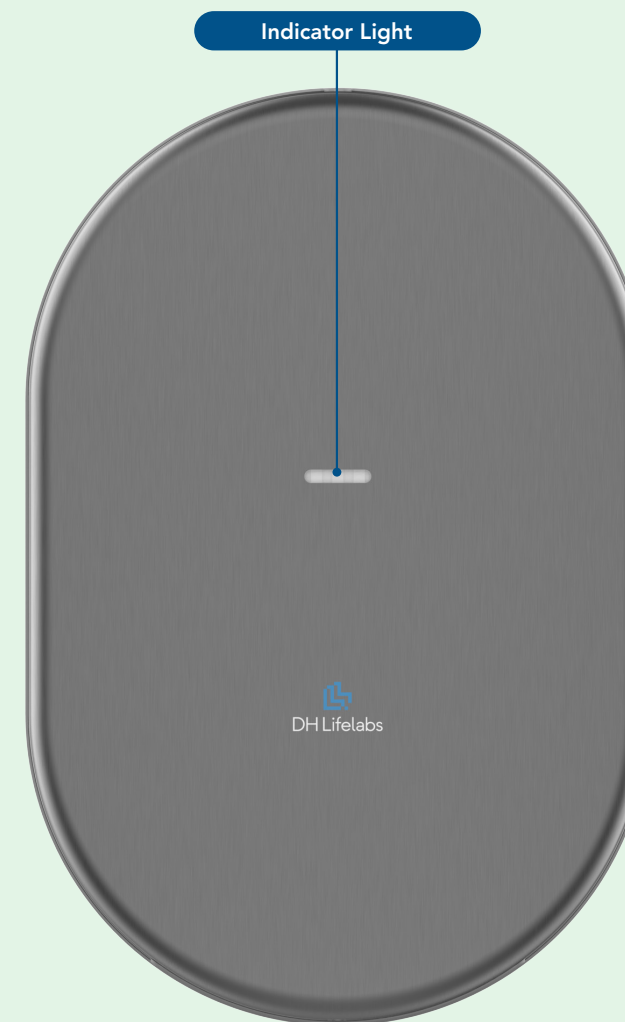
When the hands are dry, pull your hands out completely.













After powering on, the device needs to be triggered once to enter normal operating mode.

The maximum working time of hand drying is 30 seconds. If the device works for more than 30 seconds, it will stop for protection.

### Activated Carbon (AC) Filter Replacement

The AC filter should be replaced every 6 months or when indicated by the alternating flashing red and blue light. This interval is only a recommendation. The filter may need to be replaced earlier or later depending on how often it's used and the environment surrounding the device.

1. Remove the security screw and open the front cover.
2. Remove the old AC filter from the unit box and dispose according to local regulations.
3. Remove protective packaging from the new AC filter and insert it into the unit box.
4. Locate the cleaning brush on the front of the unit box and use to clean the PlasmaShield emitters (see page 19) and replace brush back in the front of the unit box.
5. Install the unit box in the device.
6. Install the cover and secure with screw.

### HEPA Filter Replacement

The HEPA filter should be replaced every 18 months or when indicated by the alternating flashing red and green light. This interval is only a recommendation. The filter may need to be replaced earlier or later depending on how often it's used and the environment surrounding the device.

1. Remove the security screw and open the front cover.
2. Remove the old HEPA filter and dispose according to local regulations.
3. Remove protective packaging from the new HEPA filter and insert it into the device.
4. Install the cover and secure with screw.

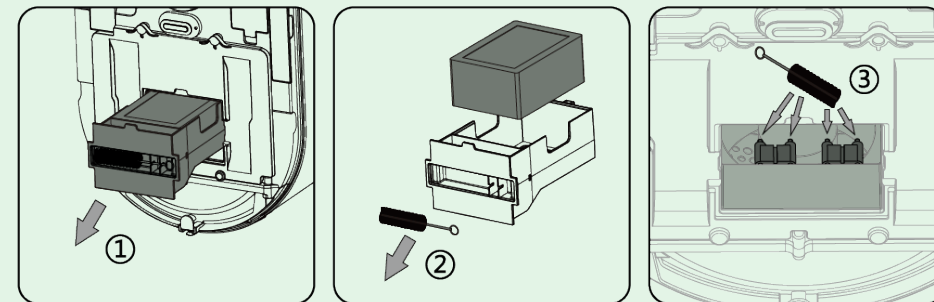
## Cleaning and Maintenance



**THE DEVICE MUST BE ISOLATED FROM THE POWER SUPPLY BEFORE ANY REPLACING FILTERS**

- ! CAUTION: ALWAYS WEAR SUITABLE GLOVES WHEN CLEANING.

- !
  - Remove any dirt from the sensor area.
  - Use a dry cloth to clean the exterior of the device. Do not use any chemicals or cleaners.
  - It is recommended that the interior of the device be inspected at least once a year and cleaned as necessary, or if performance degrades. Heavy use or an environment containing a high amount of lint, dust or other particles, requires more frequent cleaning. Particles on the air inlet, pre-filter and other internal parts of the device can reduce efficiency and shorten the lifespan of the parts.
  - Use cleaning brush located on the front of the AC unit box to clean the PlasmaShield emitters. This can be done when replacing the AC filter.



- It's recommended to clean the pre-filter with water every 3-6 months to increase efficiency.
- When the device is not used for an extended time, store it in a cool dry place. Do not store the device where it might be exposed to excess moisture or direct sunlight.
- The device may not operate effectively in very low temperatures. The device can be damaged when exposed to sub-freezing temperatures.
