### RELOCATION OF STURT STREET MEDICAL TO WINDERMERE STREET

The UFS Medical practice at 1008A Sturt Street, Ballarat relocated to new premises at 4 Windermere Street in central Ballarat in June, 2022.

The new, larger building offers better parking facilities for patients and now includes on-site pathology services.

#### **COVID CLINICS**

July 2021 saw the relocation of the UFS COVID-19 testing clinic and the vaccination clinic to the one location at 309 Dana Street, Ballarat, with distinct entrances for infection control.

During the financial year, **39,341** PCR tests were performed and **51,719** COVID-19 vaccinations administered at the clinics.





## COVID VACCINES IN PHARMACIES

In September 2021, COVID vaccination services were introduced in 15 UFS pharmacies.

This additional service increased the community's access to these critical vaccines.

In the period from September 2021, to 30 June, 2022, a total of **19,291** COVID vaccines were administered in our pharmacies.

#### DEFIBRILLATORS FOR THE COMMUNITY

In late 2021, UFS purchased 14 defibrillators to be placed in our pharmacies, to ensure that these critical life saving devices are more widely available in the community.

Easily accessible defibrillators are a great asset to a community and UFS was delighted to make this investment in the health and wellbeing of our community. The availability of a defibrillator can mean the difference between life and death for somebody who suffers a sudden cardiac arrest. Every minute is critical, as getting a defibrillator on a patient within 10 minutes gives them the best chance of survival.

The new defibrillators are semi-automatic, so the device gives the user instructions on what to do.

Our pharmacies also have first aid and CPR-trained staff on-site able to assist in an emergency. UFS Medical centres and the UFS COVID-19 Vaccination Clinic have defibrillators on-site as well.






#### WORKHEALTH SERVICES EXPANDED IN UFS MEDICAL

Our occupational health service, WorkHealth, has relocated to a dedicated re-purposed area of the Doveton Street medical practice, allowing for improved integration between the service, GPs, nurses and allied health services. Consultations continue to be available at workplaces as well as at the Doveton Street medical centre. Specialised medicals in rail safety and aviation are recent additions to this ever expanding service.



## CHAIRMAN'S REPORT

On behalf of the Board, I am pleased to provide the 2022 Chair's Report.

As a nation we have made significant progress in adjusting to COVID-19. While the ebb and flow of case numbers and the possibility of new variants remains, we have increasingly adapted to a new normal of living with the virus.

It is a testament to both the resilience of the UFS business model and the hard work and dedication of our people that your company achieved solid operational and financial results across its core business. Full year revenue and profit exceeded our plans. As a Board, we remain committed to maintaining a conservative balance sheet and a strong funding and liquidity profile. As we move into the new year, we have every confidence in our ability to continue to deliver our strategic ambitions. We are confident that the underlying strength of our business will prevail, and our long-term view remains positive.

A key priority for the Board this year was the selection of a new Chief Executive Officer to succeed Lynne McLennan after more than 21 years in the role. Following an intensive and competitive internal and external selection process, the Board unanimously appointed Matt Vagg as Chief Executive Officer, effective 1 August 2022. Matt has over 20 years' experience across several business entities, in particular 11 years at GMHBA Health Insurance where he was Chief Operating Officer – Health and Retail, responsible for a business spanning health services and health insurance.

His experience within the mutual sector provides him with a close affinity to UFS' mission and our member and community focus. Matt's demonstrated skill in strategic planning, business analysis, team development and growth, government and stakeholder engagement make him eminently qualified to lead UFS into the future. One of Matt's key priorities will be to set out the new strategic priorities and a performance framework for the business.

Lynne retired from UFS on 12 October 2022, after 21 years of dedicated service and leadership which resulted in UFS transitioning from a pharmacy only business to a very successful and highly valued regional health service destination offering medical, allied health and well-being in addition to the expansion of pharmacy services. The Board of Directors and all our employees are grateful for all that Lynne has contributed to the company during her tenure and are committed to continue building on the solid foundation that she has established.

There have been some changes to the Board, with Peta Clark stepping down in April 2022 and Ian Schrader retiring in October

2022. Peta Clark made an outstanding contribution to the Board over the last 17 years, serving as Chair for seven plus years. With her corporate accounting experience in both the profit and notfor-profit sector, along with her numerous board roles, Peta was a balanced and effective member of the Board. Ian Schrader has been a stalwart member of the Board for 45 years, serving as Chair for seven years. Ian's vast knowledge of Friendly Societies and the history of UFS, along with his commercial background made him an invaluable adviser in the growth of UFS and mentor to many new directors. I take this opportunity, on behalf of my fellow directors, to thank both Peta and Ian for their dedication and service to the company. We shall greatly miss their wise counsel and friendship around the board table. We will further broaden the Board's skill set through the appointment of new Non-Executive Directors in due course.

Our results showed that through this challenging period UFS continued to deliver exceptional service for our members, customers and patients while supporting our people and our communities. We substantially increased our giving program making major donations to emergency relief organisations across the communities we serve, thus ensuring we remained true to our Purpose and Values.

Managing through the uncertainties of the economy and world events has been a dominant feature of the year. More recently we have seen inflation rise to levels not seen for 22 years, driving higher cost of living, higher energy prices and supply chain pressures across a broad range of goods and services. This, coupled with the aftermath of the last two years, has been increasingly challenging for the business; workforce shortages from burnout, job/career changes – "the great retirement", finding new talent and retaining existing people is impacting organisations world-wide. I am particularly proud of the way the Board, management and all our people have continued to work through these exceptional circumstances. I thank them all for their tireless service and support and flexibility as we addressed business as usual needs during these times.

Corporate governance is a key role of the Board and management. Each of the directors possess skills and experiences that result in a balanced, effective, and efficient Board to lead UFS through the next growth phase and into the future.

I thank my Board colleagues and the entire UFS team for their energy, commitment, professionalism and focus on delivering on our priorities over the year.

## CHIEF EXECUTIVE OFFICER'S REPORT

The last twelve months have demonstrated the extraordinary capacity of UFS staff to continue to adapt in the difficult circumstances caused by the COVID-19 pandemic entering a third year. The expansion of the COVID-19 vaccination program through the UFS COVID-19 Clinic, UFS Medical and UFS Pharmacies posed significant logistical challenges, particularly during the early months of scant supply. Numerous compliments and positive feedback were received from our members about the excellent professional service received from UFS staff and doctors providing testing and vaccination services.

UFS business development activities have continued during the year in order to ensure our facilities and services meet the current and future needs of members. The development of a new purpose-built medical centre at 4 Windermere Street South in Ballarat has enabled the Sturt Street Medical Centre to move across the other side of Sturt Street, thus allowing Ballarat Health Services to assume the old site for a muchneeded expansion of the Base Hospital. The development of a new warehouse site in Wendouree will give our warehouse team a more efficient working environment, and also permit the current administration building in Armstrong St to be redesigned in line with modern workplace practices.

The greatest challenge of the last year has been the workforce shortages experienced by UFS and many other organisations, particularly in healthcare, and recruitment is a high priority for the UFS team. Several outstanding UFS Pharmacy Managers have made career changes this year, including popular Buninyong Pharmacy Manager Katherine John who has taken up the role of Director of Pharmacy at St John of God Hospital and Peter Ghobros, pack room Pharmacy Manager at Bacchus Marsh. New Pharmacy Managers welcomed to UFS include Josh Cleeland at Beaufort, Shane Ingeme at Buninyong, Mary Pernes at Melton South and Crystal Molloy at Sturt Street West.

It's been a difficult decision for me to retire from full-time work and leave UFS after 21 years, however the time is right for a new CEO to lead the company to the next level. It has been terrific to welcome Matt Vagg as UFS CEO and a pleasure to work alongside him for several weeks. Matt brings an excellent suite of business skills and experience to the organisation, as well as a strong personal commitment to the values and purpose of UFS. I am exceptionally grateful to have been given the opportunity to work in this organisation during not only a period of growth and development but also several extreme challenges. I want to thank all past and present UFS staff members who I have worked with for their strong commitment to serving the members' interests and helping improve the health of our communities.

I wish to thank all the UFS Directors for their deep personal investment in UFS and for the supportive and collaborative way in which we have been able to work together over a long period of time. In particular, I thank past Board Chairs Bob Matthews, Pauline Baker, Ian Schrader, the late Anne Smail, the late Peter Duffy, Peta Clark, Jacinta Rivett, Andrew Howard and current Chair Graeme Dixon.
