BYLAW ADDENDUM REGARDING DIRECTORS EMERITUS

Section 2 of Article II is deleted in its entirety and the following substituted in its place:

Section 2. TYPES OF DIRECTORS. (a) The Board of Directors shall be composed of two (2) types of voting Directors. JON B. LOVELACE, LILLIAN P. LOVELACE, JOHN C. MAZZIOTTA, M.D., Ph.D. and WILLIAM E. DIETEL, are the Founders of this Corporation and shall be designated the "Founder Directors." All other voting Directors shall be designated the "General Directors." Except as provided in Section 3 of this Article II, each of the voting Directors' rights, powers, duties and authority shall be the same.

(b) The Board may, from time to time, elect a person who has served as a voting Director with high distinction to the position of Director Emeritus. Directors Emeritus that were Founder Directors shall serve for their lifetime. Any other director elected to the position of Director Emeritus shall serve a term of one year or such longer term as the Board may specify at the time of election, unless earlier removed by a vote of a majority of the members of the Board. There is no limit to the number of terms which a Director Emeritus may serve. Directors Emeritus may, from time to time, be invited to attend and participate in the meetings of the Board, but shall not be entitled to vote at any meetings or by written consent, shall not be counted in determining whether a quorum is present, and shall not have any other rights or responsibilities of directors of the Foundation. Directors Emeritus shall be entitled to receive minutes of every Board Meeting (other than those held in Executive Session), and shall be kept apprised of the activities of the organization by a designated representative of the Board. Persons may be nominated for the position of Director Emeritus by any director of the Foundation.

The Bylaws call for not less than five (5) board members and not more than ten (10) board members without the majority vote of Board. There are general directors-everyone else, who each serve for a three (3) year term with at least one (1) year out of service before they can be re-elected.

At the last Board meeting the position of President was eliminated in favor of the Chair who would have the powers of the President. So a Chair, Secretary and Treasurer for the organization must be appointed by the Board of Directors if any current officer is to be replaced or does not desire to continue to serve.
