

Endorsed Remote Seller of Alcohol

Pursuant to the Sale and Supply of Alcohol Act 2012, **Black Collar Distillery NZ Limited** is authorised to sell and supply alcohol on the premises situated at **215 Wiroa Road, Kerikeri 0293**, Far North District and known as "**Black Collar Distillery NZ Limited**", to any person for consumption off the premises.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

CONDITIONS

This licence is subject to the following conditions:

- (a) No alcohol is to be sold, supplied or delivered on Good Friday, Easter Sunday, Christmas Day or before 1.00pm on Anzac Day.
- (b) Alcohol may be sold only on the following days and during the following hours:
At any time of any day
- (c) **The premises is undesignated.**
- (d) A remote sale of alcohol may be made at any time on any day but is subject to the restrictions on delivery imposed by section 48 (No alcohol is to be sold, supplied or delivered on Good Friday, Easter Sunday, Christmas Day or before 1.00pm on Anzac Day) and 59 (1) (no delivery to the buyer at any time after 11 pm on any day and before 6 am on the next day).
- (e) The licensee must take reasonable steps to verify that the buyer of any alcohol by remote sale is not under the purchase age.
- (f) The following information must be displayed on the internet site in a prominent place and on every receipt issued for any alcohol sold via internet site: the license holder name, the licence number and the date which the licence expires.
- (g) The licensee must adhere to any legal requirements issued by the Ministry of Health or Director of Health under the COVID19 Public Health Response Act 2020 in regard to the management of COVID19 in New Zealand.

THE LICENSED PREMISES

The sale or delivery of alcohol is authorised in of from the premises generally. The premises, situated at **215 Wiroa Road, Kerikeri 0293**, Far North District, are more precisely identified as outlined in a plan date stamped as received by the Far North District Licensing Committee on **6 September 2022**.

DISPLAY OF LICENCE AND PRINCIPAL ENTRANCE/S

A copy of this licence must be displayed at the principal entrance to the premises. The entrance from 215 Wiroa Road is designated as the principal entrance.

DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force –

- (a) either –
 - I. Until the close of the period for which it was last renewed; or
 - II. If it has never been renewed, until the close of the period of 12 months after the day it was issued; but
- (b) if an application for the renewal of the licence is duly made before the licence would otherwise expire, either-
 - I. Until the close of the period of 3 years after the period for which it was last renewed; or
 - II. If it has never been renewed, until the close of the period of 4 years after the day it was issued.
