## Maryland Performance Products Authorized Dealer Agreement:

## Level 1 (Basic Dealer):

- Basic Dealer – No Buy In

12% Discount after completing application and providing Tax ID and Business License

## Level 2 (Direct Dealer):

#### Buy-In and Annual Volume Requirements are as follows:

- **Direct Dealer** - \$10,000 Buy-In, \$25,000 Annual Sales Minimum: Dealer to receive a 20% discount. (\*Will be reviewed annually.)

#### A. Payment Terms are as follows:

- ALL drop ship orders must be paid by card when order is placed.
- Stocking orders can be paid by card, or ACH/Wire Transfer if approved.
- Stocking orders over \$25,000 can be processed with a 50% deposit with the remainder being due when the order is ready to be shipped.

#### **B.** Shipping and Freight:

• Standard shipping will be billed per order, or we can use your UPS account if requested.

#### C. Order Processing:

- ALL orders must be sent to <a href="mailto:sales@marylandperfdiesel.com">sales@marylandperfdiesel.com</a>
- Drop Ship orders will take up to 24 hours max to process, anything expedited will be taken care of first.
- In Stock Items will be processed and shipped within 24 hours

#### D. Return Policy:

- ALL returns must be pre-approved.
- A **25%** Restocking Fee may apply.
- Shipping charges will **NOT** be refunded.
- NO returns will be accepted on custom orders.
- All exchanges must be **NEW** in the box, in re-sellable condition, no custom colors can be exchanged.
- Any returned parts **MUST** be freight prepaid returned to MPP.

#### E. Product Warranty:

- All MPP products carry a 1-year warranty against manufacturer defects.
- MPP Supplied Turbos **DO NOT** carry an implied warranty, they will be dealt with on a case-to-case basis.
