4. First Aid Measures

• **Inhalation** : Move to fresh air. If symptoms persist, call a physician.

• **Skin Contact**: Wash off immediately with plenty of water. If skin irritation persists, call a physician.

• Eye Contact : Rinse thoroughly with plenty of water for at least 15 minutes and consult a physician.

5. Fire-Fighting Measures

- Suitable Extinguishing Media: Use water spray, alcohol-resistant foam, dry chemical or carbon dioxide.

- Specific Hazards Arising from the Chemical: Carbon oxides.
- **Protective Equipment and Precautions for Firefighters:** Wear self-contained breathing apparatus and protective clothing to prevent contact with skin and eyes.

6. Accidental Release Measures

7. HANDLING AND STORAGE

Handling

Precautions for safe handling: Avoid splashes or spray in enclosed areas. Keep out of reach of children.

Requirements to be met by storerooms and receptacles: Store in cool, dry conditions in well-sealed receptacles. Avoid storage near extreme heat, ignition sources or open flame.
