



# 21% LAMB CREEP PELS

**PRODUCT CODE:** 621L

**FORM:** Mini Pellet

**MEDICATION:** Lasalocid 30 g/ton

## APPLICATION:

A highly palatable feed to get lambs to start eating dry feeds. Medicated for growing lambs maintained in confinement for the prevention of coccidiosis caused by *Eimeria ovina*, *Eimeria crandallis*, *Eimeria ovinoidalis* (*Eimeria ninakohyakimovae*), *Eimeria parva* and *Eimeria intricata*.

## FEEDING DIRECTIONS:

Feed 1 to 4.6 pounds per head per day (depending on bodyweight) to provide not less than 15 mg lasalocid nor more than 70 mg lasalocid per head per day.

**CAUTION:** The safety of lasalocid for use in unapproved species has not been established. Do not allow horses or other equines access to feeds containing Lasalocid as ingestion may be fatal.
