# 5. Fire-fighting measures

**EXTINGUISHING MEDIA** 

P370+P378 In case of fire: Use Foam, Alcohol Filming Foam, dry chemical powder, CO2

#### **FIRE FIGHTING**

Alert Fire Brigade and tell them location and nature of hazard.

## 6. Accidental release measures

#### MINOR SPILLS

## PROCEDURE FOR HANDLING

#### RESPIRATORY PROTECTION
