

What types of services fall under personal services settings?

Any service in which there is a risk of exposure to blood. Here is a list of services:

- Hairdressing and barbering
- Body and ear piercing
- Laser hair removal
- Manicures and pedicures
- Tattooing and micropigmentation
- Electrolysis
- Acupuncture
- Waxing
- Facials

How often are personal services settings inspected?

All salons and spas are inspected at least once a year. However, more inspections may be conducted, in response to a complaint or upon request.

When is a re-inspection conducted?

A re-inspection is conducted if the last inspection reveals conditions that need to be corrected.

When is an order under the Health Protection and Promotion Act (HPPA) given?

An Order under the HPPA is issued when there is a condition that exists which is or may lead to a health hazard. The requirements of the order are necessary to decrease and/or eliminate the health hazard.

- 19. Proper steps taken for cleaning equipment/ instruments
- 20. Proper use and maintenance of ultrasonic cleaner
- 21. Proper steps followed for use, storage and maintenance of disinfectants

Procedural/ Service Specific Requirements

- 22. Ear lobe piercing: proper infection prevention and control practices followed
- 23. Facials: proper infection prevention and control practices followed
- 24. Hairdressing/ barbering: proper infection prevention and control practices followed
- 25. Laser hair removal; proper infection prevention and control practices followed
- 26. Manicures/ pedicures: proper infection prevention and control practices followed
- 27. Waxing: proper infection prevention and control practices followed

Health Hazard/ Health Hazard Condition

44. Premises and maintained free from every condition that may be a health hazard
