



# MISMATCH™ ADAPTER INSTRUCTIONS



**WARNING:** Read these instructions completely before beginning installation of this product. If you lack the knowledge or tools to perform installation, please have your local professional bicycle mechanic perform the installation. Improper installation can result in loss of control or damage to the bicycle and/or serious injury or death to the rider.

#### STUFF YOU NEED:

- Shimano I-Spec<sup>™</sup> (2012 and earlier) compatible brake levers
- SRAM MatchMaker<sup>™</sup> compatible shifters

#### TOOLS:

- 4mm hex wrench
- Torque wrench

### INSTALLATION:

- 1. Open up the right brake lever clamp and insert the square nut (figure 1).
- 2. Position and attach the brake lever according to the manufacturer instructions (figure 2).
- 3. Attach the right MisMatch Adapter to the brake lever clamp using an 8mm M5 bolt and the 4mm hex wrench. Torque 4–5Nm (figures 3 & 4).
- 4. Attach the shifter to the MisMatch Adapter using an 8mm M5 bolt and the 4mm hex wrench. Torque 4–5Nm (figure 5).
- 5. Repeat these steps for the left side lever.
