Bigger than standard Presta valve nuts, the Big P-Nut is designed to provide extra leverage to better tighten tubeless valves on standard tubeless rims.

COMPATIBILITY & INTENDED USE

Problem Solvers Big P-Nut is designed for compatibility with all tubeless-compatible valve systems. If you are using the Big P-Nut with a carbon rim, see rim manufacturer's instructions for tubeless compatibility.

TOOLS

The Problem Solvers Big P-Nut is designed to be hand-tightened onto any tubeless-compatible valve and does not require any tools for installation.

INSTALLATION

- Install tubeless-compatible rim tape according to the manufacturer's instructions.
- 2. Insert the tubeless valve through the valve hole.
- Finger tighten the Big P-Nut until the valve seals against the inside of the rim.

NOTE: The larger diameter and knurling of the Big P-Nut will allow you to put extra torque on the valve. Achieving a seal between the rim and the valve does not require much effort. Be careful not to over-tighten the Big P-Nut onto your valve.

ONGOING MAINTENANCE

Inspect your Big P-Nut for signs of excessive wear, cracks, or other fatigue before every ride. If you suspect your Big P-Nut has been damaged, return it to the shop where it was purchased to be inspected by a professional bicycle mechanic.
