General instructions

Some of our trademarks are NCS^{®©}, Natural Colour System^{®©}, the NCS System logotype and the NCS Products and Solutions. The NCS Trademarks, NCS Notations or NCS System Symbols must not in any manner be changed.

- An NCS Notation must be denoted as follows: NCS S 1020-Y70R Note that the "S" in the NCS Notation is only used for the Standardised NCS 2050 Original Colours.
- A non-standardised colour is presented like this: NCS 1122-Y73R
- The year shall be the year of production in the text;
 NCS Natural Colour System® property of and used on licence from NCS Colour AB, Stockholm 2023.
- The text may be translated, without changed significance, to a local language.
- The font/type face of the copyright text may be adjusted to the font/type face used on other text.
- In relation to the licence, the name NCS® or Natural Colour System® must always be used together with the ® markings.
