Neck Breather Medical Awareness Skin Decal


For many years laryngectomees have experienced legitimate fears regarding care and protection of their tracheostoma when **temporarily hospitalized** or in other settings where medical personnel may be unfamiliar with a "total neck breather." Some tragedies and many near tragedies have occurred in such situations throughout the world. In addition, users of tracheoesophageal voice prostheses have worried about inadvertent prosthesis removal and subsequent closure of the tracheoesophageal "puncture."

The Neck Breather Medical Awareness Skin Decal (patent pending) is a unique warning system designed and developed by Eric D. Blom, Ph.D. and Mary Jane Renner, M.S.W. This temporary, non-toxic, non-irritating water transfer "tattoo" is applied directly to the surface of the skin adjacent the tracheostoma and/or on the front surface of the hand, both highly noticeable and visible areas. It temporarily replaces the shirt pocket-warning card or MedicAlert® (MedicAlert Foundation, Turlock, CA) identification jewelry or similar product commonly worn by laryngectomees. These items

are usually taken from the person upon admission to a hospital. Reference on the new skin decal to the stoma being a "hole in the neck" was purposely selected to avoid unfamiliar terminology. The skin decal is usually durable for approximately one week and can easily be removed with rubbing alcohol.

The Head and Neck Cancer Rehabilitation Institute (a 501C3 Public Charity) is distributing the "Neck Breather Medical Awareness Skin Decal." A booklet of four decals is available free of charge by contacting the Head and Neck Cancer Rehabilitation Institute. Initial funding for the decal program was contributed by Ann M. Mary Jane returned to a social work career following her rehabilitation and also became involved in volunteer work with laryngectomees through a local support group and the International Association of Laryngectomees. For the past nine years she has been on the staff of Head and Neck Surgery Associates in Indianapolis, Indiana as a patient and family counselor. This has brought her into daily contact with many patients who have undergone major surgery for head and neck cancer. She is experienced in individual, group and family counseling. Mary Jane served on the staff of the annual International Association Laryngectomees Voice Institute for fifteen years, and is a past President of the International Association of Laryngectomees. She has published and lectured extensively on laryngectomee rehabilitation and psychosocial impact of cancer and cancer survivorship. She is also an active volunteer with the American Cancer Society, the Leukemia & Lymphoma Society and The Wellness Community of Central Indiana. The Information/ Hotline will not give medical advice.
