**03 2.02 Main Duties and Responsibilities**

Without being restrictive, and subject to modification (in the latter case, by prior notice from the Employer), the Supervisor's main duties and responsibilities shall be as follows:

- to execute the duties and to assume the responsibilities normally tied to this position;
- to supervise the operations of the concerned department;
- to execute, by delegation, all or part of the powers of the ..... of the Employer, except those that cannot be delegated by law;

### **3.01 Salary**
