#### 2.01 Position Title

## *O*3 2.02 Main Duties and Responsibilities

Without being restrictive, and subject to modification (in the latter case, by prior notice from the Employer), the Employee's main duties and responsibilities shall be as follows:

 to carry out the activities relating to the installation, maintenance, evolution and support of network and related software, to provide support to the server access structure as well as some software and network management tools in the various clients' or Employer's environment;



- to provide support for the local area networks as well as their whole microprocessing components (printing, PCs, servers);
- to provide daily technical support and maintenance of the network and systems of the company and those of the customers ;
- to provide the necessary assistance to the installation and the starting up of the systems and software;
- to make the follow-up and the daily update of the servers;
- to purchase, configure and install PCs and Unix servers;
- to provide user support;

## 2.03 Immediate Supervisor
