

CONTRACT OF EMPLOYMENT
(Network Administrator)

01 BETWEEN:

(hereinafter referred to as the "Employer")

02 AND:

(hereinafter referred to as the "Employee")

(the Employer and the Employee are hereinafter collectively referred to as the "Parties")

PREAMBLE

WHEREAS the Employer wishes to hire the Employee as Network Administrator;

WHEREAS the Employee wishes to accept the employment offer after having been informed of the Employer's policies and conditions of employment;

WHEREAS the Parties wish to evidence their agreement in writing;

WHEREAS the Parties have the capacity and powers to enter into and perform the undertakings set forth in this Agreement;

NOW THEREFORE, THE PARTIES AGREE AS FOLLOWS:

1.00 PREAMBLE

The preamble hereto shall form an integral part hereof.

2.00 OBJECT

2.01 Position Title

The Employer hereby hires the Employee as Network Administrator.

03 2.02 Main Duties and Responsibilities

Without being restrictive, and subject to modification (in the latter case, by prior notice from the Employer), the Employee's main duties and responsibilities shall be as follows:

- to take charge of a heterogeneous park of workstations (UNIX, NT);
- to supervise the network expansion and the good operation;
- to take part in the development of communication tools between the various subsidiaries;

- to coordinate the purchase, installation and maintenance of the data-processing equipment;
- to carry out maintenance on NT network (..... workstations);
- to rapidly correct technical problems affecting the availability of the network components;
- to carry out the project planning of the network and operating software updates;
- to optimize and update various servers' operating software, office-oriented systems as well as the necessary tools for the remote use of software on the workstations;
- to set up and to support the communication network to serve the various regional offices;
- to evaluate new technologies as regards servers, to recommend alternate strategies and to carry out ensuing technical activities;

2.03 Immediate Supervisor

The Employee shall report directly to, in the position of, or to any other person designated by the Employer.

2.04 Work Place

The Employee's work place shall be located at, or at any other place required for the efficient operation of the Employer's business.

2.05 Driver's License and Vehicle

During the entire term of this Agreement, the Employee shall hold a valid driver's license and shall be in a position to use his vehicle for work.

3.01 Salary

In consideration for the Employee's performance of his work, the Employer shall pay the Employee an annual salary of dollars (\$.....).
