### Dans le détail :

Les analyses ont été réalisées selon les méthodes EDANA NWSP 360.1, NWSP 360.2 et NWSP 360.3  
Les concentrations seuils indiquées ci-dessous sont celles issues du codex EDANA Annex 1 version 1.3 June 2022.

Il n'a pas été détecté :

- d'HPA au-delà du seuil de 0.2 mg/kg du codex.
