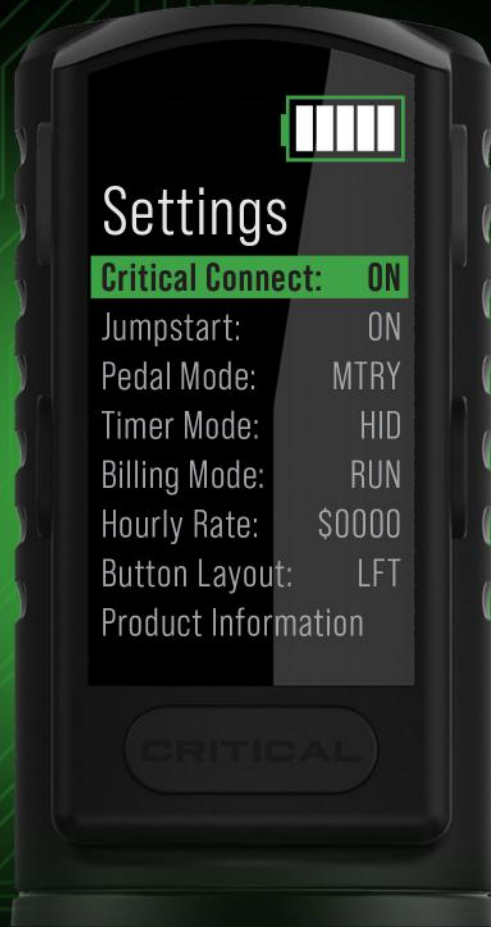

SETTINGS DEFINED

CRITICAL CONNECT:

Connect or Disconnect from Bluetooth
(Critical Connect Footswitch Required)

JUMPSTART:

Turn Jumpstart On or Off

PEDAL MODE:

If using a footswitch, you can change your output mode on the pedal to either continuous or momentary power.

TIMER MODE:

You can make your Run/Session timer visible on the main menu or hide it with a play/pause symbol.

BILLING MODE:

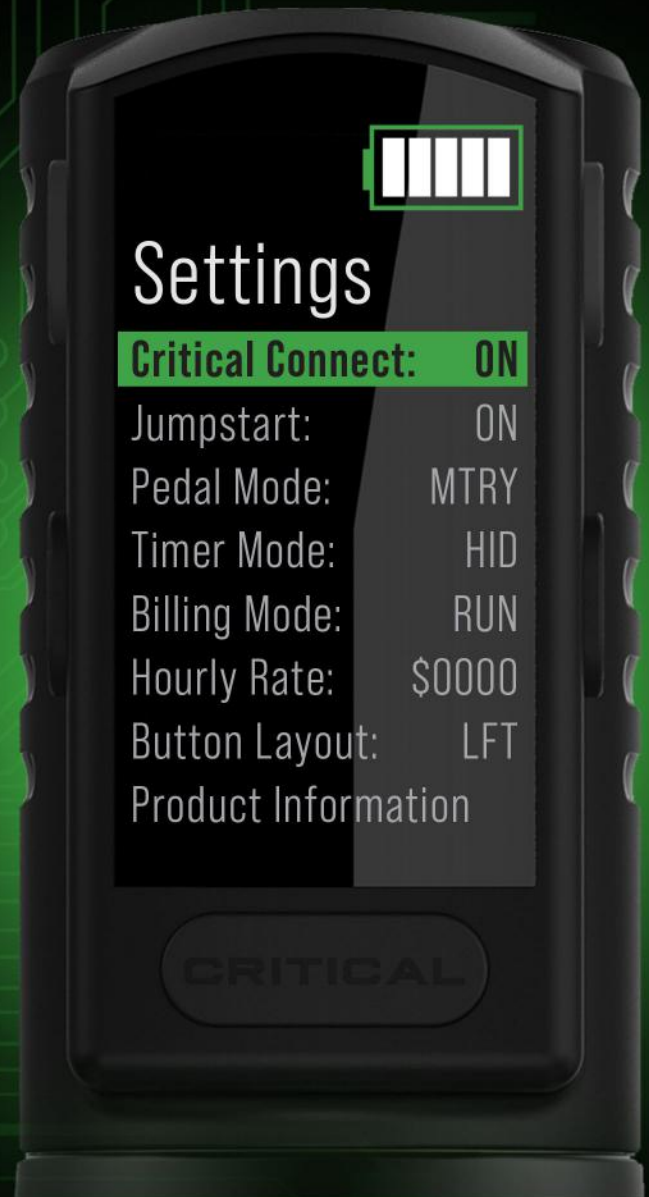
If you want to track your session time and/or hourly rate, you can do so two ways. The Session timer will record the entire session from when you manually start the timer and pause it, like a stopwatch. The Run timer will record only when the battery is active and outputting power.

HOURLY RATE:

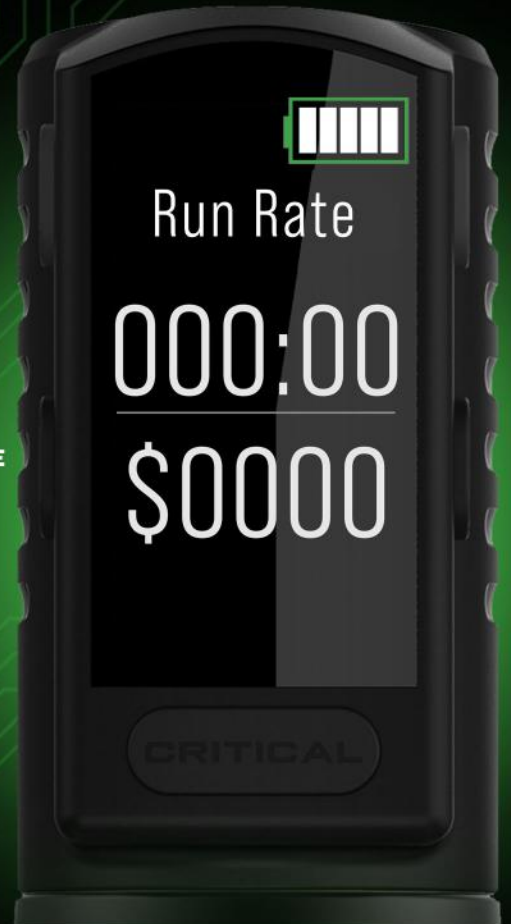
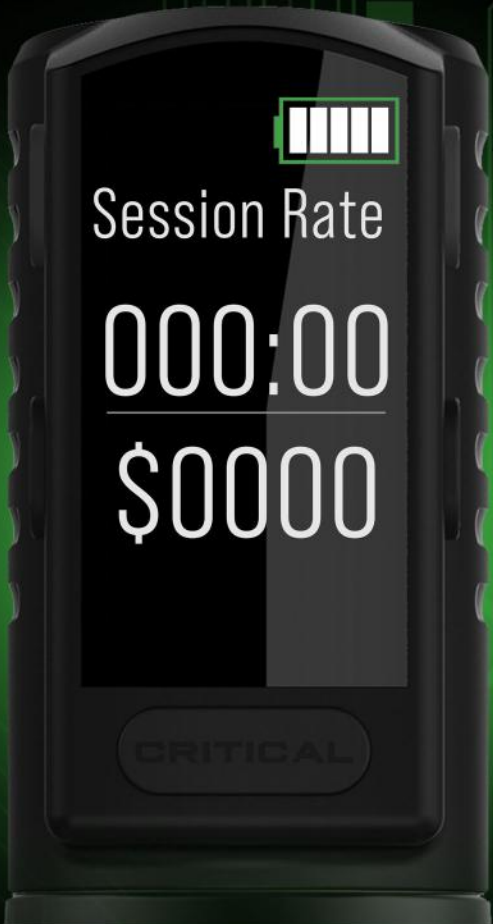
You can update your hourly charge rate here.
