## LIFETIME LIMITED WARRANTY

**Limited Warranty:** National Nail Corp. ("NNC") warrants that the CAMO Hidden Fasteners (the "Product") you purchased will be free from defects in material and workmanship for the life of the product, and are guaranteed against rust and corrosion for the life of the project. This warranty only extends to the original purchaser.

**Exclusive Remedy:** NNC will replace any defective product at no charge. This is your sole and exclusive remedy for any product defect. If NNC does not replace the product within a reasonable time, its liability to you will be limited to the purchase price of the product.

Exclusions from Coverage: You will have waived any claim for breach of warranty (1) if you do not notify NNC in writing within 30 days after you discover a defect, (2) fail to follow the instructions, requirements and recommendations, or warnings provided with the product or (3) if the product has been (a) altered, abused or misused, (b) installed or used under unusual or abnormal conditions or in violation of any building code, or (c) damaged as a result of negligence, accident, or improper installation.
