EACH PIECE IN OUR COLLECTION IS INDIVIDUALLY CRAFTED. AS A RESULT, SLIGHT VARIATIONS IN PATINA, FINISH AND GRAIN MAY OCCUR.

CLEANING INSTRUCTIONS FOR SOLID COCOBOLO WOOD

A MICROFIBER CLOTH CAN BE USED FOR CLEANING. IF YOU DESIRE A DEEPER CLEAN, USE PLEDGE OR A THIN COAT OF FURNITURE OIL. IF YOU WISH TO MAINTAIN AN ALL-NATURAL, ENVIRONMENTALLY FRIENDLY FINISH, WE RECOMMEND USING ONLY A CITRUS SOLVENT SPARINGLY ON A LINT-FREE CLOTH, SOFT BRUSH OR HAND RAG TO THE CLEAN, DRY AND DUST-FREE WOOD SURFACE. ALLOW SOLVENT TO PENETRATE THE SURFACE FOR 30-40 MINUTES. REMOVE ANY EXCESS SOLVENT WITH A CLEAN, LINT-FREE CLOTH. DO NOT ALLOW SOLVENT TO DRY COMPLETELY ON SURFACE BEFORE WIPING. WE RECOMMEND 2-3 COATS FOR EACH TREATMENT. PLEASE NOTE: SURFACE MAY HAVE A LUSTER FOR A WEEK OR SO AFTER APPLICATION. THIS LUSTER WILL FADE AS SURFACE CONTINUES TO ABSORB SOLVENT.

CLEANING INSTRUCTIONS FOR PATINATED BRASS

PATINATED BRASS PRODUCTS ARE SENSITIVE TO MOISTURE AND DIRECT HEAT. AVOID PLACING PRODUCT IN DIRECT CONTACT WITH HEATING VENTS, INTENSE DIRECT SUNLIGHT OR AREAS EXPOSED TO MOISTURE OR DENSE HUMIDITY. PATINATED BRASS CAN BE CLEANED WITH A MICROFIBER CLOTH. USE PLEDGE OR HOT SOAPY WATER TO DAMPEN A CLEAN CLOTH. AVOID USING HIGHLY ABRASIVE SCRUBBING MATERIALS, METAL BRISTLED BRUSHES, STEEL WOOL OR BLEACH-BASED CLEANERS. MATERIALS SUCH AS THESE WILL SCRATCH THE SURFACE OF THE BRASS.

ALL PRODUCTS ARE CONSIDERED TO BE IN GOOD CONDITION AND ERROR-FREE WHEN DELIVERED. CLIENT SHOULD INSPECT ALL DELIVERIES IMMEDIATELY UPON ARRIVAL, AND SHOULD MAKE NOTE OF ANY DAMAGE WHEN SIGNING FOR THE PRODUCT DELIVERY.

ALL BC WORKSHOP PRODUCTS CARRY A ONE-YEAR WARRANTY. IF CLIENT FINDS A MATERIAL DEFECT IN ANY PRODUCT, PART OR COMPONENT WITH IN ONE (1) YEAR OF PURCHASE, PLEASE CONTACT BLACKMAN CRUZ. BLACKMAN CRUZ WILL NEED TO DETERMINE IF CARE, MAINTENANCE, INSTALLATION AND OTHER FACTORS CONTRIBUTED TO PRODUCT DEFECT.
