## CLEANING INSTRUCTIONS FOR IRON WITH ACID FINISH

STAINLESS STEEL CAN BE CLEANED AND MAINTAINED WITH LUKEWARM WATER AND A MILD DISHWASHING DETERGENT SUCH AS DAWN. AVOID PRODUCTS OR SOAPS CONTAINING ANY BLEACH OR SCRUBBING, ABRASIVE CLEANSERS. CLEANING AGENTS SUCH AS THESE WILL SCRATCH THE SURFACE OF THE PRODUCT. USING A SOFT CLOTH, DAMPEN IN SOLUTION TO GENTLY REMOVE ANY DIRT OR DEBRIS BEFORE CLEANING. FOR MORE STUBBORN DIRT STAINS, USE A HOSE INITIALLY TO WASH AWAY DIRT AND RESIDUE BEFORE CLEANING.

## CLEANING INSTRUCTIONS FOR COTTON ROPE SASHING

BRUSH SASHING FREE OF ALL LOOSE DIRT AND DEBRIS WITH A SOFT BRUSH, LITE BROOM OR CLOTH. DAMPEN A SPONGE IN LUKEWARM SOAPY WATER AND A LIGHT BLEACH SOLUTION: 4-PARTS WATER TO 1-PART BLEACH. LIGHTLY DAMPEN ALL SASHING WITH SPONGE. HOSE DOWN WITH WATER AND LET SASHING DRY IN THE AIR AND SUNLIGHT.

## **CLEANING INSTRUCTIONS FOR MARBLE**

CLEAN MARBLE WITH HOT WATER AND A SOFT CLOTH. DRY THOROUGHLY WITH A SOFT, DRY CLOTH. AVOID ANY ABRASIVE SCRUBBING CLEANSERS, BLEACH-BASED PRODUCTS OR SCOURING DETERGENTS. PLEASE NOTE: BOTTLES, GLASSES AND CANS THAT CONTAIN ACIDIC AND/OR STAINING LIQUIDS MAY ETCH THE POLISH OR DAMAGE THE SURFACE OF THE MARBLE. ALWAYS USE A COASTER IN ORDER TO PROTECT THE MARBLE SURFACE.

ALL PRODUCTS ARE CONSIDERED TO BE IN GOOD CONDITION AND ERROR-FREE WHEN DELIVERED. CLIENT SHOULD INSPECT ALL DELIVERIES IMMEDIATELY UPON ARRIVAL, AND SHOULD MAKE NOTE OF ANY DAMAGE WHEN SIGNING FOR THE PRODUCT DELIVERY.
