- 1.) Prices are in US Dollars. Remote Satellite Systems® reserves the right to modify/change or delete plans as necessary.
- 2.) Only Standard IP services will be included in the allowance. All other services will be charged in addition to the monthly subscription(s) at Standard Plan rates.
- 3.) Minimum commitment periods do not include initial prorated month and begin on the 1st day of the following calendar month. For example, a twelve month period activated on March 3rd, 2017 will be in contract until March 31st, 2018.
- 4.) Initial Monthly Subscription Fee and Allowance will be pro-rated based upon the number of days active. The Additional Standard IP Monthly Usage Fee will not be pro-rated.
- 5.) There will be no pro-ration of subscriptions or allowances on deactivation and a full month's subscription will be charged and a full month's allowance will be available.
- 6.) Terminations prior to the end of the commitment period are subject to the full payment of the contractual commitment.
- 7.) The BGAN Standard Plus is restricted to Land BGAN use.
- 8.) The BGAN Standard Plus Plan includes a fixed monthly subscription charge and an additional subscription charge for the use of standard IP where usage (MB) is above 20 MB. This additional charge will be dependent on actual traffic usage, but the Monthly Subscription Fee will be invoiced even when there has been no usage for the month in question.
- 9.) Unused allowance does not carry over month-to-month.
- 10.) When the total monthly usage level goes above the 20 MB monthly included allowance, the BGAN Standard Plus Plan will be invoiced an Additional Standard IP Monthly Usage Charge, based upon the number of MBs used in total for the month.
- 11.) The Additional Standard IP Monthly Usage Charge is an additional charge over and above the normal Monthly Subscription Fee. For clarity, using 1,200 MBs worth of traffic would generate two charges for the month:
 - (a) The standard Monthly Subscription Fee
 - (b) A Large Tier Level Charge, which covers usage from 1,000 MB to 5,000 MB
- 12.) As the Inmarsat network is a contended network, Inmarsat employs a Fair Use Policy to ensure that all users behave in a responsible way to ensure that they benefit from access to the network. This includes limitations on usage of high bandwidth applications or activities to ensure that the network remains accessible. Service Aware Control & Charging (SAC-C) will be used on the BGAN Standard Plus Plan at 30,000 MB to support traffic management enabling the QoS to be significantly reduced if user exceeds the allowance.
- 13.) On asymmetric HDR services ("HDR Half Channel / 64k" and "HDR Full Channel / 64k"), the "Full Channel" or "Half Channel" refers to the uplink speed, and 64 kbps is the downlink speed.
- 14.) Voice / ISDN bills in 30 second minimums and 15 second increments.
- 15.) Streaming / HDR bills in 30 second minimums and 5 second increments.
- 16.) Standard IP bills in 0.10 MB minimums and 0.02 MB increments.
- 17.) Remote Satellite Systems Terms and Conditions apply to all Post-paid airtime subscriptions and Pre-paid airtime purchases.
