Maximum permissible exposure calculations

The Iridium GO! exec and underlying radio transmitters in the product has been evaluated under the Maximum Permissible Exposure (MPE) limits, and found to be under the MPE limits when the device is used at a distance of greater than 20 cm from the human body.

The International Agency for Research on Cancer (IARC) concluded in May 2011 that there is limited evidence to suggest a possible link between RF signals and two specific types of cancer. The IARC's conclusion is based on its review of existing studies and information.

The United States agencies responsible for setting RF exposure limits, the FCC and FDA, however, indicated that there is not sufficient scientific evidence to support a link between wireless device use and cancer and that use of wireless devices such as mobile phones according to current regulations is safe.

Batteries

Your Iridium GO! exec contains a permanent battery, which may only be removed and/or replaced by a certified technician. Do not attempt to remove the battery.

Important: Follow these guidelines when charging your battery:


- For protection and long life, the Iridium GO! exec will only allow charging when the battery temperature is between 0°C (32°F) and 45°C (113°F).
- The supplied AC charger can operate in ambient temperatures up to 25°C. At higher temperatures and during heavy load the charger will reduce or stop charging.
- New batteries are not fully charged and may take more time to charge.

Emergency calling

CHECK WITH YOUR SERVICE PROVIDER FOR LOCAL EMERGENCY NUMBERS (full international access code, country code, and phone number) for all locations outside the United States and mainland Australia. Iridium currently only supports in-country emergency call routing to 911 within the United States and to Triple Zero (000) or 112 within mainland Australia. Outside of the United States and mainland Australia, calls to emergency access numbers such as 999, are



not able to be made on the Iridium system. When placing a call to an emergency operator or local public safety answering point, always verbally report your location to assist first responders with identifying your location to provide assistance. Caller location identification is not automatically transmitted to local emergency operators through the Iridium system.

Iridium does not guarantee network availability at all times due to situations where the network is unavailable due to satellite availability, terrain, weather, or other conditions that may prevent an emergency call from being placed.

EMERGENCY CALLS WITHIN MAINLAND AUSTRALIA: Power on Iridium GO! exec, rotate the antenna towards the open sky, confirm proper registration and signal strength of Iridium GO! exec, and follow the normal protocol for dialing Triple Zero (000) on the Iridium GO! exec or using your mobile phone or using the Iridium GO! exec application on your smartphone. Verbally report the situation and your location to the operator for assistance. The Iridium service does not provide enhanced emergency calling service which automatically identifies the caller location.

EMERGENCY CALLS IN ALL OTHER LOCATIONS: You will need to obtain and dial the full international access code, country code, and phone number for the local fire, police, or ambulance depending upon the nature of the emergency. Power on Iridium GO! exec, rotate the antenna toward the open sky, confirm proper registration and signal strength of Iridium GO! exec, and follow the normal protocol for placing a call using the Iridium GO! exec or using the Iridium GO! exec application on your smartphone. Verbally report the situation and your location to the operator for assistance. The Iridium service does not provide enhanced emergency calling service which automatically identifies the caller location.

Emergency mode (SOS button)



You must configure the Emergency Mode in order for the SOS button to make an emergency call to the designated Emergency Call Recipient. Failure to configure the SOS button will result in no call being made when the SOS button is pressed. This could prevent or delay an emergency response and result in serious injury or death.

Antenna care

Use only an approved antenna. Unauthorized antennas, modifications, or attachments could damage the device and may violate government regulations. When using remote mount antenna, ensure that antenna is mounted at least 20 cm (about 8 inches) away from the user. Also, when using a remote mount antenna in order to reduce potential radio interference to other users, the antenna type and its gain should be 3dBi or less.

Charging the Device



The Iridium GO! exec utilizes a negative ground system. When using a DC power source, such as a car or boat, the power system must be a negative ground system. Do not use the device with positive ground systems. Failure to properly ground the Iridium GO! exec could cause fire or could cause the device to fail so that it is unavailable in an emergency situation, preventing or delaying an emergency response. These hazards could cause serious injury or death.



Use the Iridium GO! exec with Iridium supplied power accessories ONLY. Use of non-Iridium supplied power accessories could result in exposing the device to excessive voltage, which could cause fire or could cause the device to fail so that it is unavailable in an emergency situation, preventing or delaying an emergency response. These hazards could cause serious injury or death.

Blasting Areas and Potential Explosive Atmospheres



To avoid interfering with blasting operations, leave your device OFF when in a “blasting area” or in areas posted: “Turn off two-way radio.” Obey all signs and instructions. Failure to do so could result in injury or death.



Areas with a potentially explosive atmosphere are often but not always clearly marked. They include, but are not limited to: fueling areas such as gasoline stations; below decks on boats; fuel or chemical transfer or storage facilities; areas where fuel odors are present (for example, if a gas/propane leak occurs in an automobile or home); areas where air contains chemicals or particles, such as grain, dust, or metal powders; and any other area where you normally would be advised to turn off your vehicle engine.



Turn your device OFF, do not plug or unplug any connection into any ports of the unit when you are in any area with a potentially explosive atmosphere. Obey all signs and instructions. Sparks from your battery in such areas could cause an explosion or fire resulting in serious injury or death.

Ingress Protection

The Iridium GO! exec has ingress protection to rating IP65 when all the port covers are fully closed. This means the device is protected from dust ingress and protected against low pressure jets of water from all directions. When the ports are closed, the Iridium GO! exec can be used outside in wet or dusty weather conditions.



Make sure all port covers are fully closed. The Ingress Protection is only maintained if all the port covers are fully closed so they are flush to the housing. Failure to fully close the ports could lead to water or contaminant infiltration that could prevent the Iridium GO! exec from functioning.

Electronic devices

Most electronic equipment is subject to interference from RF energy from external sources if inadequately shielded. In some circumstances your mobile device may cause interference with other devices. Turn OFF your device in any location where posted notices instruct you to do so. For optimal performance and to be sure that exposure to RF energy does not exceed guidelines set forth in the relevant standards discussed in the above section “Maximum Permissible Exposure Calculations”, always follow the instructions and precautions.

Implantable medical devices

Persons with Pacemakers:



- Should ALWAYS keep Iridium GO! exec, any external antenna and any mobile phone more than eight (8) inches (20 centimeters) from their pacemaker at all times when the device or phone is turned ON.
- Should turn Iridium GO! exec OFF immediately if there is any reason to suspect that interference is taking place.
- Failure to heed this warning could result in serious injury or death.

Hearing aids

Some digital wireless devices may interfere with some hearing aids. In the event of such interference, you may want to consult your hearing aid manufacturer to discuss alternatives.

Other medical devices

If you use any other personal medical device, consult the manufacturer of your device to determine if it is adequately shielded from external RF energy. Consult your physician to determine compatibility with your medical device.

Do not use your device in health care facilities when any regulations posted in these areas instruct you not to do so. Hospitals or health care facilities may be using equipment that could be sensitive to external RF energy.

Extended Exposure to Loud Noise



Exposure to loud noise from any source for extended periods of time may affect your hearing. The louder the volume sound level, the less exposure is required to affect your hearing. To protect your hearing:

- Limit the amount of time you use handsfree, headsets or headphones at high volume.
- Avoiding turning up the volume to block out noisy surroundings.
- Turn the volume down if you cannot hear people speaking near you.
- Failure to heed this warning could result in serious injury.

Aircraft

Airline regulations prohibit using Iridium GO! exec while in the air. Check and comply with the policy of your airline regarding the use of your device while the aircraft is on the ground. Leave Iridium GO! exec OFF when boarding an aircraft.

Handling



Handle the Iridium GO! exec with care. It is made of glass, metal, and plastic, and contains sensitive components. If the glass is broken, or if the Iridium GO! exec is damaged, or you suspect that it is damaged, discontinue use to avoid injury or overheating and have the device repaired or replaced by a qualified service center.



The base of the Iridium GO! exec is marked with a hot surface symbol. The metal base may get hot to touch when operated in higher ambient temperatures and may remain hot for some time after use.

Renseignements Importants sur la Sécurité

Calculs de l'exposition maximale admissible

L'Iridium GO! exec et les émetteurs radio sous-jacents du produit ont été évalués en fonction des limites d'exposition maximale admissible (MPE) et jugés inférieurs aux limites MPE lorsque l'appareil est utilisé à une distance supérieure à 20 cm du corps humain.

Le Centre International de Recherche sur le Cancer (CIRC) a conclu en mai 2011 qu'il existe des preuves limitées de liens possibles entre les signaux RF et deux types précis de cancers. La conclusion du CIRC repose sur son examen des études et des renseignements existants.

Le FCC et la FDA, organismes des États-Unis chargés de fixer les limites d'exposition au rayonnement, indiquent toutefois qu'il n'y a pas suffisamment de preuves scientifiques pour établir



un lien entre l'utilisation d'appareils mobiles et le cancer, et que l'utilisation d'appareils mobiles tels que des téléphones mobiles en respectant la réglementation en vigueur est sécuritaire.

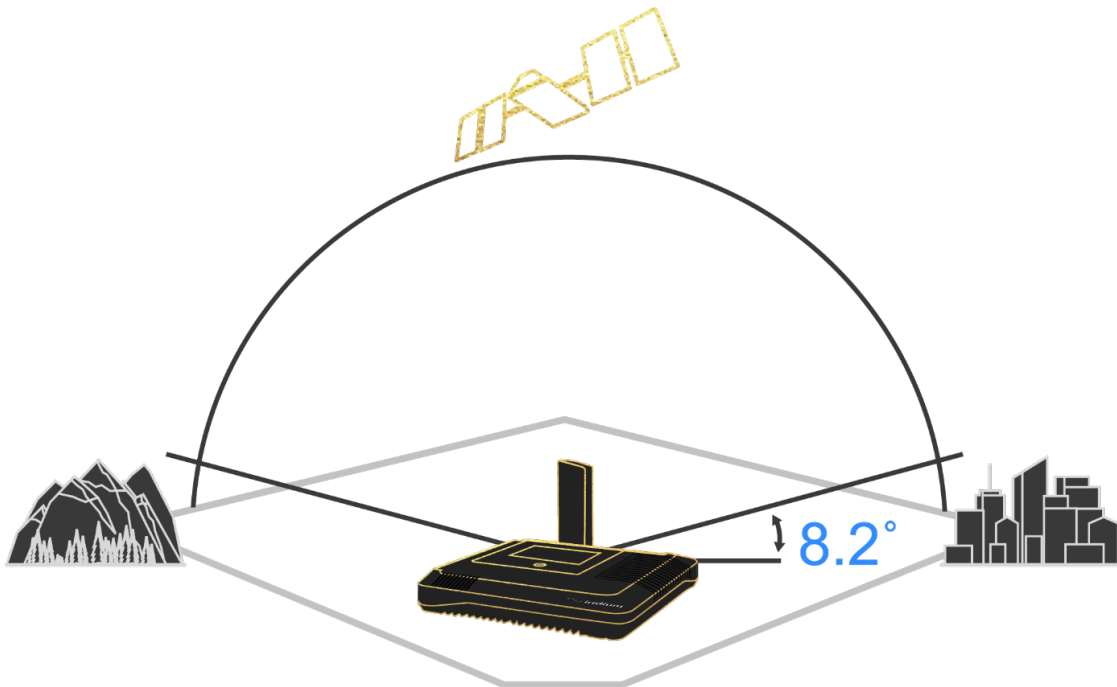

Best Practices for Optimal Performance

Iridium GO! exec requires connection to the Iridium® satellite network. The swivel antenna should be vertical to the ground and have a clear unobstructed view of the sky. For optimal performance, the antenna must be able to “see” the entire sky from approximately 8 degrees above the horizon. Nearby tall buildings or similar structures, heavily leafed trees and mountains can all degrade performance as they block the signal between the antenna and the satellites. Having a completely open view of the sky plays a very important role in maximizing performance, as the Iridium satellites move across the sky from horizon to horizon (north-to-south or south-to-north) during a connected call.



Tips on Efficient Operation

For Iridium GO! exec to operate most efficiently:

1. Keep the battery charged to ensure that the device is ready for use when needed.
2. Ensure antenna is pointed directly up while in use.
3. Make sure the antenna has a clear unobstructed view of the sky.
4. Do not touch the antenna unnecessarily when the Iridium GO! exec device is in use, as contact with the antenna may impact call quality and battery consumption.
5. Iridium GO! exec is not designed to be worn on your body. Refer to “Important Safety and Regulatory Information” on proper use.

What is the Iridium GO! exec?

Built with professionals in mind, the Iridium GO! exec provides satellite connectivity that enables you to:

- Connect multiple smart devices and PCs
- Access 2 voice calls and 1 shared data session simultaneously
- Utilize built-in speakerphone functionality
- Raise duress in case of emergency

The device has a dedicated SOS button that, when properly configured, allows quick and reliable connection to a global emergency service provider (IERCC or a user configured personal contact number). The built-in GPS receiver allows your exact location to relay to the operator.

The device has a full 4-inch color touchscreen and speaker and microphone for hands free calls and operation.

Smart phones, laptops and SIP phones can be connected to the Iridium GO! exec via the provided Wi-Fi hotspot or via a dedicated Ethernet port. Two voice calls and multiple data users can be concurrently using the device and sharing the speed of 22 Kbps uplink / 88 Kbps downlink connection.

Using data session profiles helps to avoid bill shock by minimizing background data being inadvertently sent via the satellite network where it can consume the monthly data allowance.

The Iridium GO! exec comes with AC, DC chargers and USB-C cable and includes a protective cover that clips over or under the unit.

Included Accessories and How to Use Them

AC Wall Charger:

The Iridium GO! exec comes with a 110-240v AC charger with USB-C output that allows the device to fully charge in under 3 hours. Connecting other AC chargers to the USB-C charging port may also work, but if the charger is lower power it will take longer to charge. The Iridium GO! exec will detect chargers under ~18W and will warn users that some features may not be supported.

Using the Supplied AC Charger:

Select the appropriate international adapter depending on your requirements.

- For the USA the pins just need to be folded out from the charger.
- For other countries the pins should be folded in and the appropriate adapter slid onto the folded pins until it clicks in.
- Then plug in one end of the supplied USB C cable to the wall charger and the other end to your device charging port.



NOTE: The port's IP65 rating isn't maintained when the connector is inserted

DC Car Charger

The Iridium GO! exec is supplied with a DC car charger suitable for use in 2 pin cigarette lighter sockets supplying 12-24 v often used in automobile and marine environments.

The DC charger will allow the device to fully charge in under 3 hours using the supplied USB-C cable. Connecting other DC chargers to the USB-C charging port will also work, but if the charger is lower power it will take longer to charge. The Iridium GO! exec will detect chargers under ~18W and will warn users that some features may not be supported.

Using the Supplied DC Charger

- Plug the DC charger into the automobile auxiliary power outlet. When the socket is powered, the DC charger will show a blue light.
- Connect one end of USB-C cable to the USB-C output on the supplied charger and connect the other end of the USB-C cable to your device charging port.

NOTE: The port's IP65 rating is not maintained when a connector is inserted.

Protective Cover:

This custom-built accessory snaps on easily to the top or bottom of the Iridium GO! exec for additional protection. The cover has openings on the side to allow for cords to be attached to the device with the cover either on top or the bottom.



- This cover can attach on the top of the device to help protect it from scratches etc. when being carried inside a bag with other items.
- When attached on the top of the device it will also help protect the unit from getting too hot if operated in direct sunlight.

Getting Started

Note: The images in the user manual are final or approximation to final and they are subject to change.

Step 1: Charge and Insert SIM Card to Your Iridium GO! exec

Insert SIM Card:

1. Your Iridium GO! exec uses a mini-SIM card. Make sure your SIM card is the correct size.
2. Open the SIM card flap on the side and follow icon on device for guidance on right side up.
3. Close the cover securely.



NOTE: The SIM card port on the Iridium GO! exec shares a slot for a micro-SD card. Be careful not to insert the SIM into the SD card slot. If you have trouble inserting the SIM, check that you are inserting it into the larger of the two slots.

Charging your Device:

1. Plug in and fully charge the device before first use. The device will be fully charged in under 3 hours when used with the charger and cable provided in the box.
2. The device indicates it is charging via the LED light "pulsing" in blue. Please refer to Appendix for detailed LED status
3. The Iridium GO! exec device has completed charging when the LED goes solid blue. Refer to LED status table in the Appendix

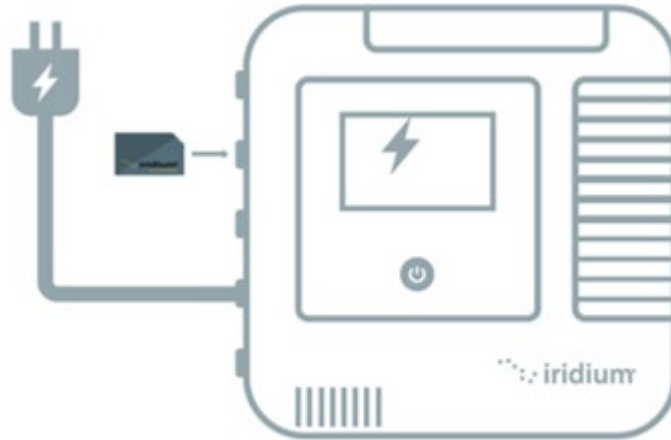
Important: The Iridium GO! exec must be connected to an active USB charger prior to first use. Turn on the device by holding down the touch power button for 2 seconds or by flipping up the swivel antenna to an upright position.

Important: Follow these guidelines when charging your battery:

- For protection and long life, the Iridium GO! exec will only allow charging when the battery temperature is between 0°C (32°F) and 45°C (113°F).



- The supplied AC charger can operate in ambient temperatures up to 25°C. At higher temperatures and during heavy load the charger will reduce or stop charging.
- New batteries are not fully charged and may take more time to charge.



Step 2: Download the Required Companion Applications

Before connecting your Iridium GO! exec to the Iridium network, first download and install the required mobile applications on smart devices using standard high-speed network.

Step 3: Set up your Iridium GO! exec

Turning the device ON: There are three different ways the user can turn on the device:

1. By pressing the touch power button for 5 secs
NOTE: If the device is powered on with the internal swivel antenna down, the device will warn the user via a pop-up dialogue if it doesn't detect an external antenna is connected
2. Lifting the internal swivel antenna from the lowered position to an upright position.
3. By connecting the charger (optional). This setting can be modified from within the settings. By default, the device doesn't power on when charger is plugged in.

NOTE: The first time you take the Iridium GO! exec out of the box, it will not turn on unless you plug it into the active charger to wake up the device.



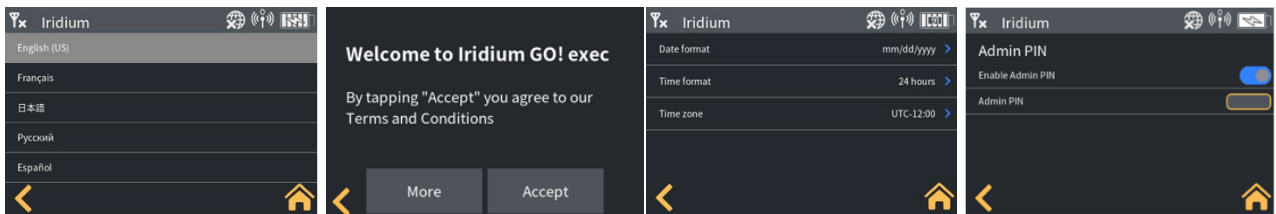

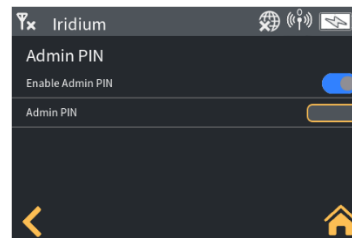
- The Iridium GO! exec supports an administrator PIN to prevent key features being controlled by anyone other than the Device Administrator. By default, the Admin PIN is disabled.
- Sensitive settings can be protected by enabling the Administrator PIN
- Toggle the Enable Admin PIN option as desired.
- Enter a 4-digit PIN. Press the yellow > button to accept.

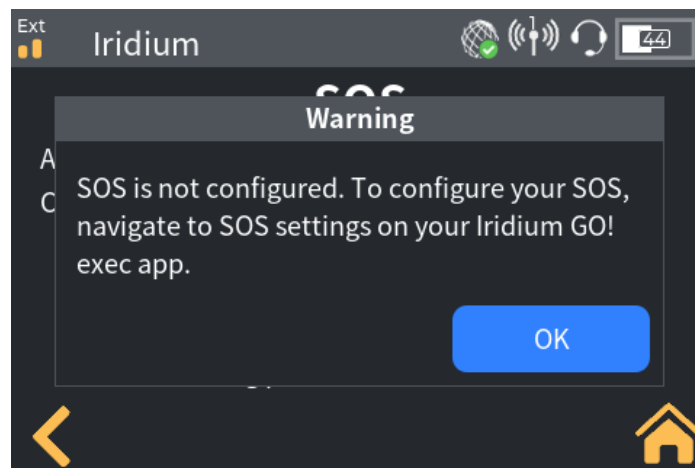


Step 5: Configure and Set Up SOS

Configuring SOS

The Iridium GO! exec offers a programmable SOS button that can be used to notify a specified personal contact or a commercial safety service provider in the event of an emergency. You must properly configure the SOS settings via the Iridium GO! exec application.

If not configured, the device will warn the user to configure, as SOS cannot be initiated if setup is not completed, and you will not be able to use the SOS button.



No Service

Once configured, an SOS can be initiated either from the Iridium GO! exec by opening the SOS cover and pressing the SOS physical button, or from the SOS icon SOS on the User Interface (UI) on the Iridium GO! exec and/or from the Iridium GO! exec application on smart device by pressing the SOS icon when paired to the Iridium GO! exec.

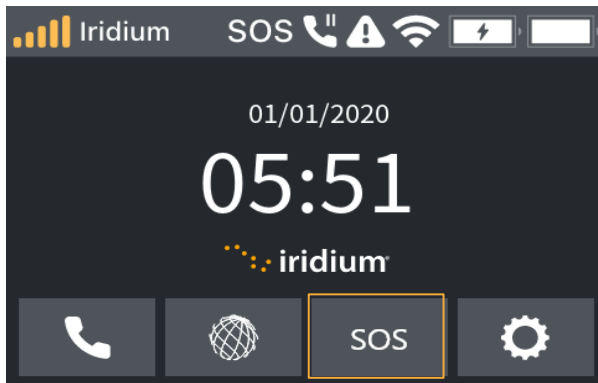

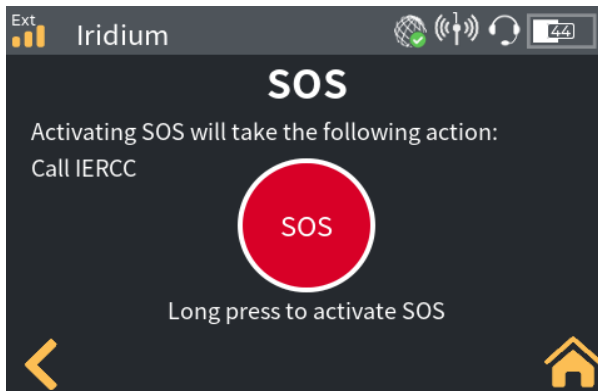

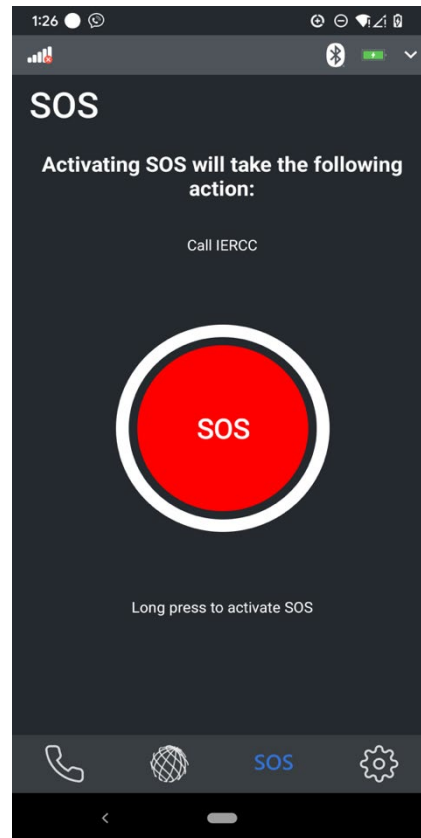

IERCC Safety Services

To support the SOS feature, Iridium has contracted with IERCC Travel Safety Group to provide an emergency response coordination service for your Iridium GO! exec at no additional charge. These



services are offered and provided exclusively by IERCC and not by Iridium, which is a separate, unrelated company. Standard airtime charges will apply to SOS calls to the IERCC; a valid Iridium SIM subscription and online registration at <https://my-geos.com/registration> is required. Please review the privacy policy and terms of use for [IERCC Travel Safety Group](#) before using this service as these are the terms that will govern your relationship with IERCC.

Configuring SOS settings



You must configure the SOS feature in order for the SOS to make an emergency call to a designated Call Recipient. Failure to configure the SOS feature will result in no call being sent when the SOS button is pressed. This could prevent or delay an emergency response and result in serious injury or death.

Use the Settings menu in the Iridium GO! exec application to configure SOS while paired to the Iridium GO! exec. Only one SOS emergency contact setting can be stored per Iridium GO! exec, so multiple users will all share the same SOS settings. It is important to plan accordingly. The SOS settings will provide the option to use or not use the IERCC service.

NOTE: The ability to modify SOS Settings is provided to admin users in the event an admin pin is set.

To use IERCC service:

1. You must first register at <https://my-geos.com/registration> from a web browser on your computer or smart device.

NOTE: To register, you will need your Iridium line 1 phone number (Please refer to the device information under the settings menu for the line 1 phone number) and Iridium GO! exec IMEI (shown on the device label on the base of the Iridium GO! exec).



2. After registration, access SOS Settings on the Iridium GO! exec app, select Use IERCC, and enter the 5-digit authorization code provided by IERCC, then Submit. (See section SOS Settings)

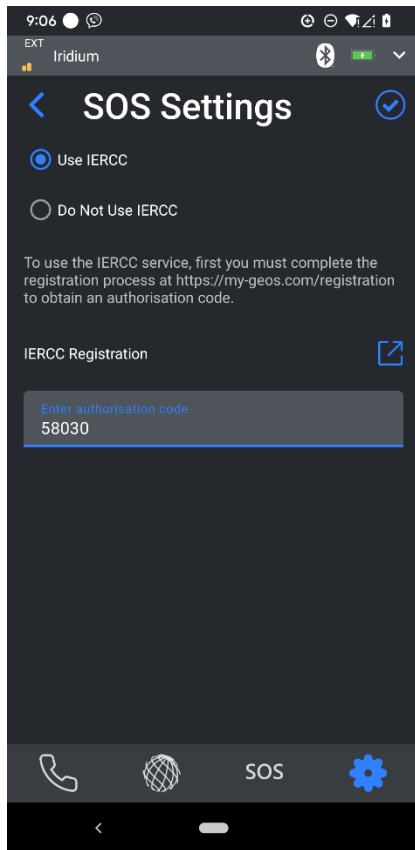

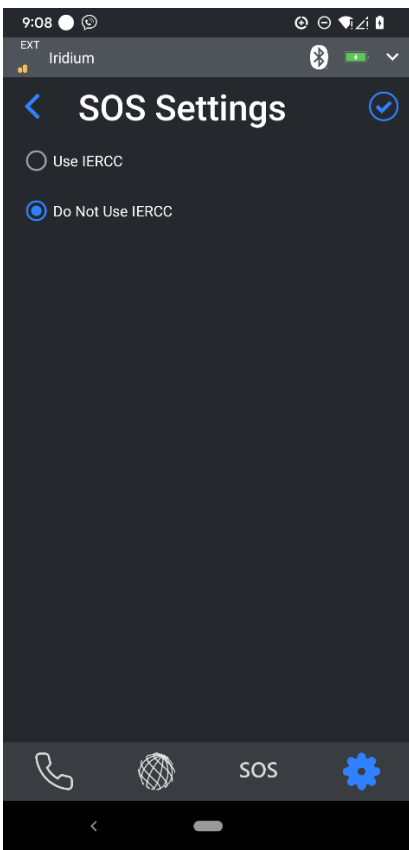

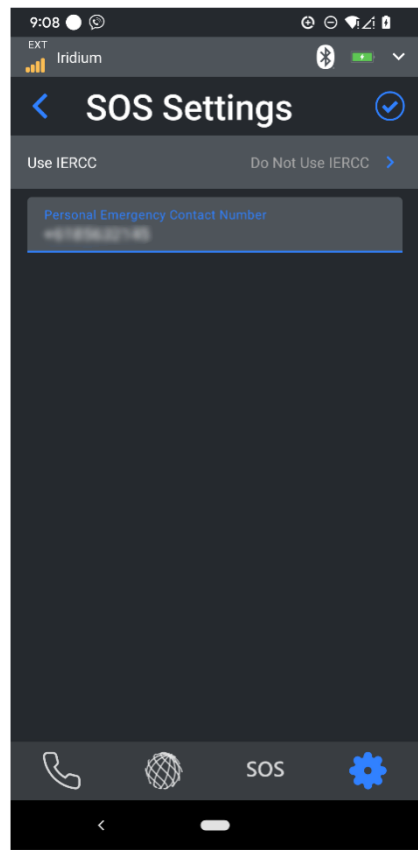

2. Go to Settings: Device Settings: Admin settings menu on your Iridium GO! exec application.
3. Select SOS Settings.
4. Select Personal Emergency Contact, enter contact details and Save.
5. Go outside, find a clear view of the sky away from trees and buildings.

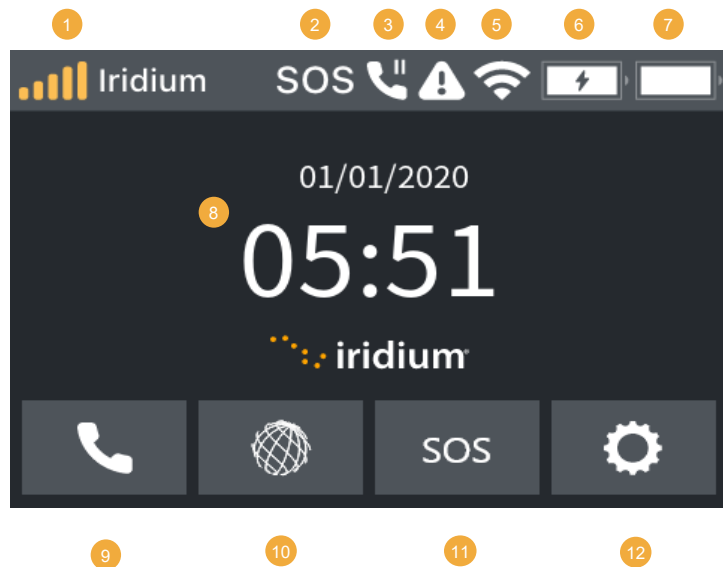
NOTE: Only digital headsets are supported. If you have a 3.5 mm headset you can connect it to the Iridium GO! exec by using a digital 3.5 mm to USB-C adapter (not provided). Note that analog adapter is not supported.

NOTE: Once a headset is plugged in, all system sounds will also be heard through the headset, with the exception of incoming call ringing signal that is played in both the headset and the Iridium GO! exec speaker.

Status Bar Overview










The Iridium GO! exec shows a status bar across the top of the display regardless of what else is being displayed. This shows the user the status of the Iridium GO! exec instantly from any screen. The status bar presents the following information.




1. **Satellite modem state (on/off)**

Indicates whether the satellite modem is turned on or not. The modem will always be on except in cases where the Iridium GO! exec is attempting to operate outside its temperature range.

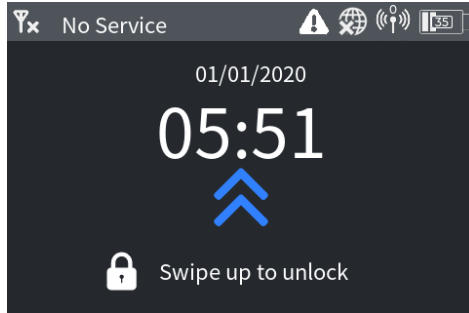


2. **Voice call activity** (Line 1, Line 2) 
Indicates if a line is being used or not.
3. **Voice mail available** 
Indicates there is voicemail available for one or two lines.
4. **Iridium Network registration status** (Registered / Not Registered)
Indicates whether or not the Iridium GO! exec has been able to communicate with the Iridium satellite network. When an antenna is available the Iridium GO! exec will always attempt to connect to the Iridium satellite network where possible. If the status bar is indicating Not Registered by displaying a X icon, see the Troubleshooting Guide for possible solutions.
5. **Internet session status**  / 
The Internet session status will show Connected  any time an Application User or Device user starts an internet session. See section Connection Manager for details on how to access the internet via your Iridium GO! exec.
6. **Wi-Fi status (on/off)** 
The Iridium GO! exec Wi-Fi can be turned on and off from the Device by the administrator.
7. **Number of Wi-Fi users** connected to the Iridium GO! exec Wi-Fi. 
The number of Wi-Fi clients currently connected to the Iridium GO! exec Wi-Fi.
8. **Charging status** of the externally connected smart device 
9. **Charge level of the device battery** 
Indicates the current charge level of the device battery, the charging or not charging status, battery not connected, and any battery faults.
10. **Active SOS status SOS**
The Device shows active SOS status irrespective of the trigger source.

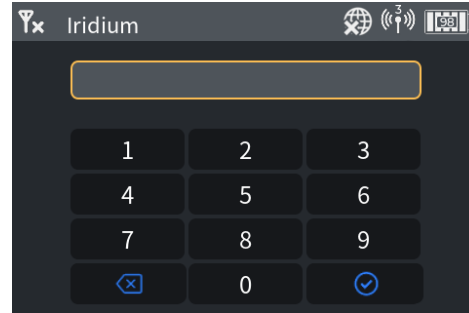
Standby Screen

When not in use the Device switches to standby mode with a lock screen. User should swipe up  to unlock the Device. This prevents accidental touches and if a 4-digit device lock PIN or admin PIN has been enabled the Device shall request the user to enter the configured PIN. User is also warned if an invalid PIN is entered. The Device screen will also show pop-up warnings if

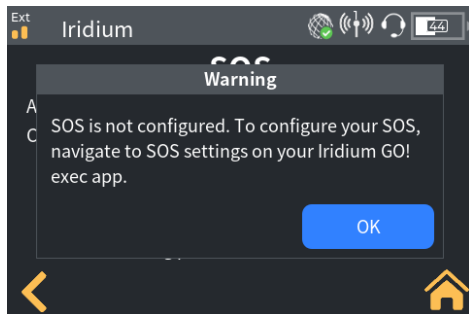

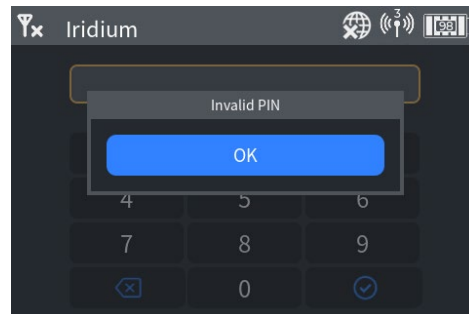

Voice Calls

Voice calls can be made from the Device via the keypad  or the quick dial list .

To make an outbound call from the Device, navigate to the home screen and select the phone  icon.

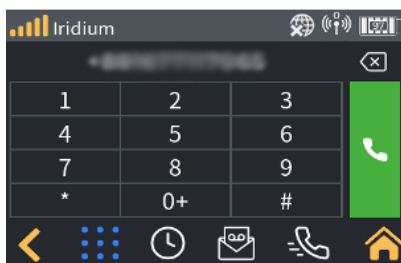
NOTE: If the Device screen is locked, swipe up and enter the lock screen password to access the home screen. Enter the required phone number including the +country code and press the green call button. The Iridium GO! exec will start dialing the number, then ringing and once call is picked up will display the active call screen.

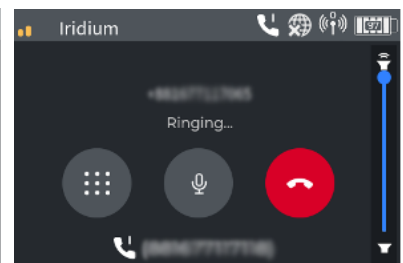
The Iridium Certus® 100 service supports 2 voice lines on one SIM card. User can opt in to have one line or both lines provisioned on their SIM card. Device is aware of how many lines have been provisioned and reacts accordingly. The device defaults to Line 1 i.e. green button on device defaults to calling from Line 1 if both lines are available, and automatically switches to Line 2 if Line 1 is already in use. This default setting can be changed from “Line reference” under Settings/Admin settings/Line reference in the device or by the companion app.

The active call screen indicates:


- The name associated with the call (if listed in the quick dial list)
- The current call duration
- The line in use.

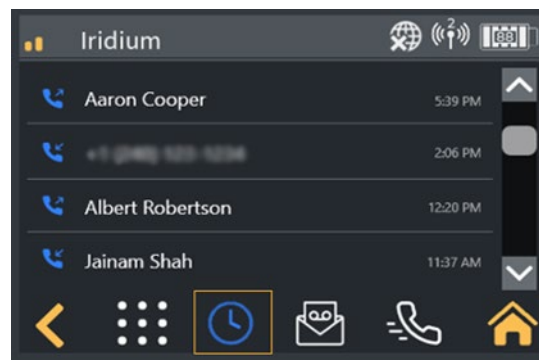

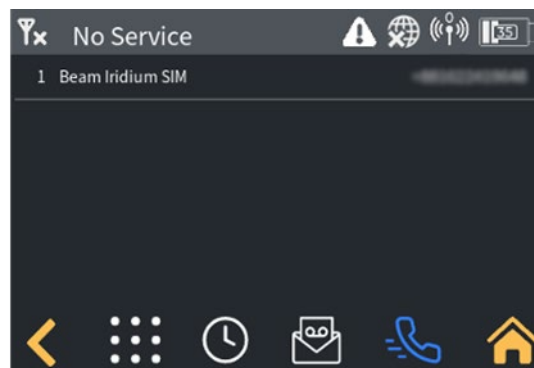

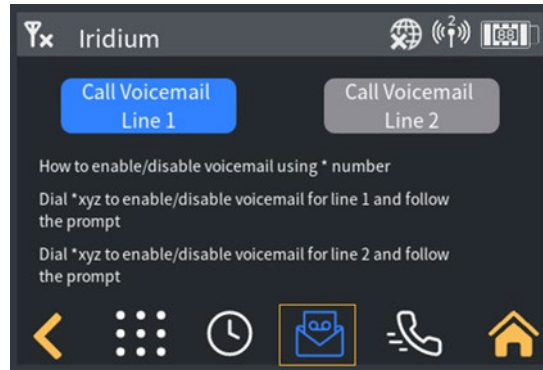

Receiving Voice Calls – Accepting or Rejecting

When an incoming Voice call is received, the device will automatically navigate to the incoming call screen and play the ringtone for the user. The user can answer the call by pressing the green answer button or decline the call by pressing the red decline button.

If the device user is currently in an active call when an incoming call is received on the other line, the device will display the second incoming call without playing a ringtone.

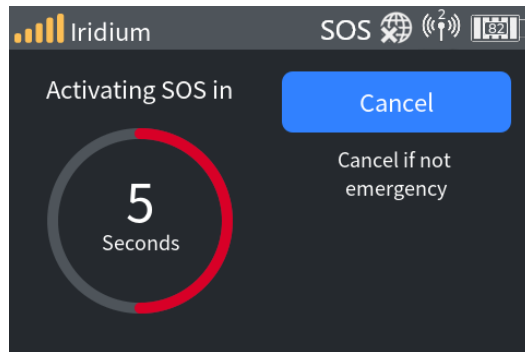
Selecting the SOS icon on the device home screen will display the SOS trigger screen on the Device. Press and hold the SOS button for at least 3 sec. The Device will begin to play the pending countdown timer and show the countdown on the screen.

During the countdown period the SOS event may be cancelled without alerting the designated Emergency Service Provider (ESP). If the call was unsuccessful, the user will get an option to redial (or to cancel).

The user can then use the device microphone and speaker to converse with the emergency contact.

The Device user can also start an SOS event by pressing and holding the physical SOS button for at least one second. The Device will begin to play the pending countdown timer and show the countdown on the screen.

NOTE: When triggering an SOS event via the physical SOS button, the Device can be on or off. If the Iridium GO! exec is off, it will first power up and then continue to start the SOS event. When the countdown time expires, the SOS will enter the active phase and begin dialing the designated ESP.

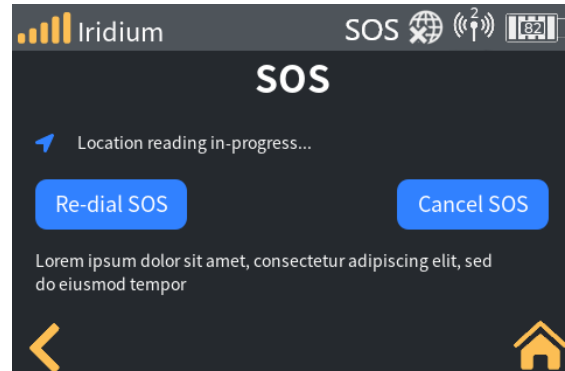
While the Iridium GO! exec is in the active SOS event and the Iridium GO! exec has an outbound call to the ESP, it will show the current latitude and longitude (so the Device user can relay this to the ESP).

The Device user can only end the current call to the ESP from this screen.

NOTE: The SOS event remains active even after the call to the ESP is concluded. To close an active SOS event, the user must explicitly select the “Cancel SOS” button.

If the user is in the United States or Australia, they can also dial 911 or 000 emergency number, respectively, whether they have a valid SIM card or not.

NOTE:

1. To ensure the SOS call reaches the emergency contact, triggering SOS voice call shall terminate all non-SOS voice calls in progress on line 1 and/or line 2 to allow the SOS call to get through. The SOS call shall only use line 1.
2. The user cannot initiate a new emergency call while an SOS call is in progress.
3. To ensure the user safety, initiating an emergency call such as calling 911 or 000 shall terminate all non-emergency voice calls in progress on line 1 and/or line 2 to allow the emergency call to go through. The emergency call shall use line 1 or line 2.

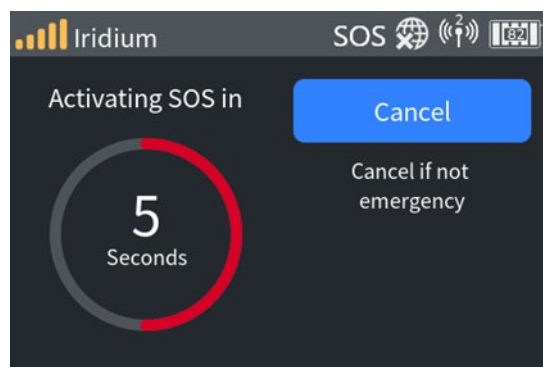

To cancel the SOS event, the Iridium GO! exec user must explicitly cancel the SOS via the Cancel button on the SOS active screen.

To cancel the SOS event, press and hold the physical SOS button for at least one second. The Iridium GO! exec will display the SOS active screen. The SOS can be cancelled by pressing the Cancel button.

Internet

Connecting to the Iridium GO! exec device

There are 2 ways to connect to the device:

Wireless via Wi-Fi:


- User can connect any smart device or laptop using the Wi-Fi. The user would then be able to manage their internet connection via the device's touchscreen UI and use the desired PC or smart device application.

Wired via Ethernet:

- User can use the ethernet port to connect to another device using an ethernet cable. The user would manage their internet connection via the device touchscreen UI and use the desired applications on their laptop.



Connection Manager

Once the Iridium GO! exec indicates it is registered on the Iridium network, it supports up to 88 Kbps data speeds for downlink and 22 Kbps for uplink. To start an internet connection, select the Internet icon  from the home screen. The device comes equipped with a Connection Manager feature that offers the users the ability to manage data usage by the following:



1. Selecting a Web/App profile

Any Device that connects to the Iridium GO! exec network (Wi-Fi or Ethernet) can access the internet through the Iridium GO! exec. To optimize your internet connection (and speed), the user can use the Web/App Profile. Select the Web/App Profile that best suits user's need from the Web/App Profile drop down menu.

Select "All Open" if you are unsure. See Web/App Profile for hints on using profiles. See section Creating and Managing Custom Web/App Profiles for details regarding customized Web/App Profiles. You can also change a session's Web/App Profile while a session is active.

2. Selecting a session duration

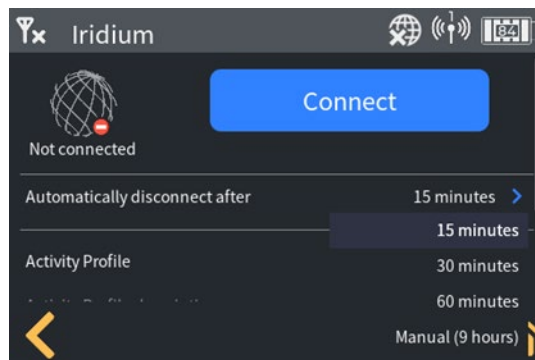
You can select a duration for your internet connection to control the usage and costs. The Iridium GO! exec will close the internet connection when this duration expires. This can be useful if you are busy with other tasks and forget to close the session manually. You can also extend a session choosing a new duration while a session is active.

3. Starting the session

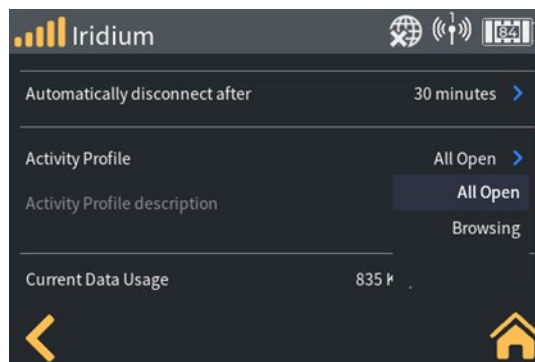
To start the session, press the large blue button marked "Connect". The Iridium GO! exec will show "connecting" while it is connecting to the internet and then "Connected". See *FAQs for Troubleshooting options if your Iridium GO! exec cannot connect to the Internet.*

4. Stopping the session

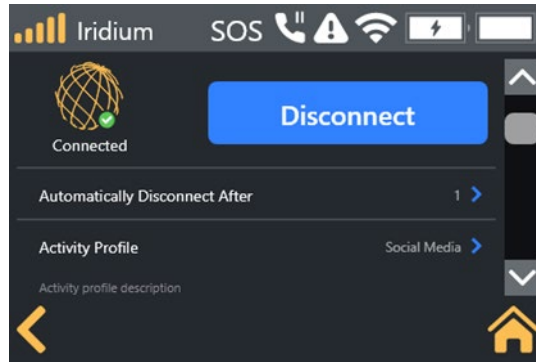
If a session is active, you can stop the session by pressing blue button marker "Disconnect". This will close the satellite internet connection immediately. To restart the session, simply press the blue button now marked "Connect".

Settings/Admin settings/DNS Config/Enable DNS Caching

DNS caching can reduce data usage while accessing the internet via satellite and also speed up this access. By default, it is enabled. Under normal circumstances the DNS cache should remain enabled.



The DNS cache should only be disabled to aid troubleshooting should there be any difficulties accessing the internet via satellite data. The DNS cache can be enabled/disabled by toggling the enable/disable switch.

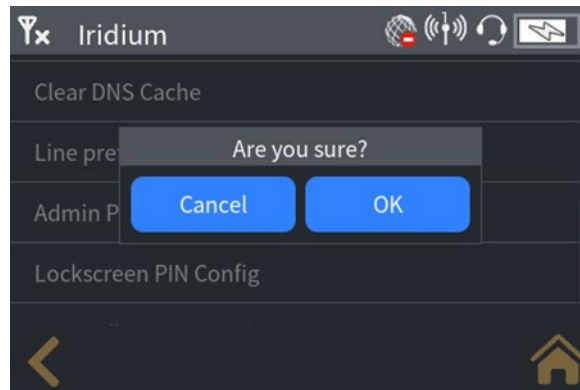

Pressing the button for >10 seconds while the unit is powered on will force the unit to perform a factory reset. The unit will automatically shut down and then reboot. During rebooting it will show the following screen to indicate it is performing the factory reset. 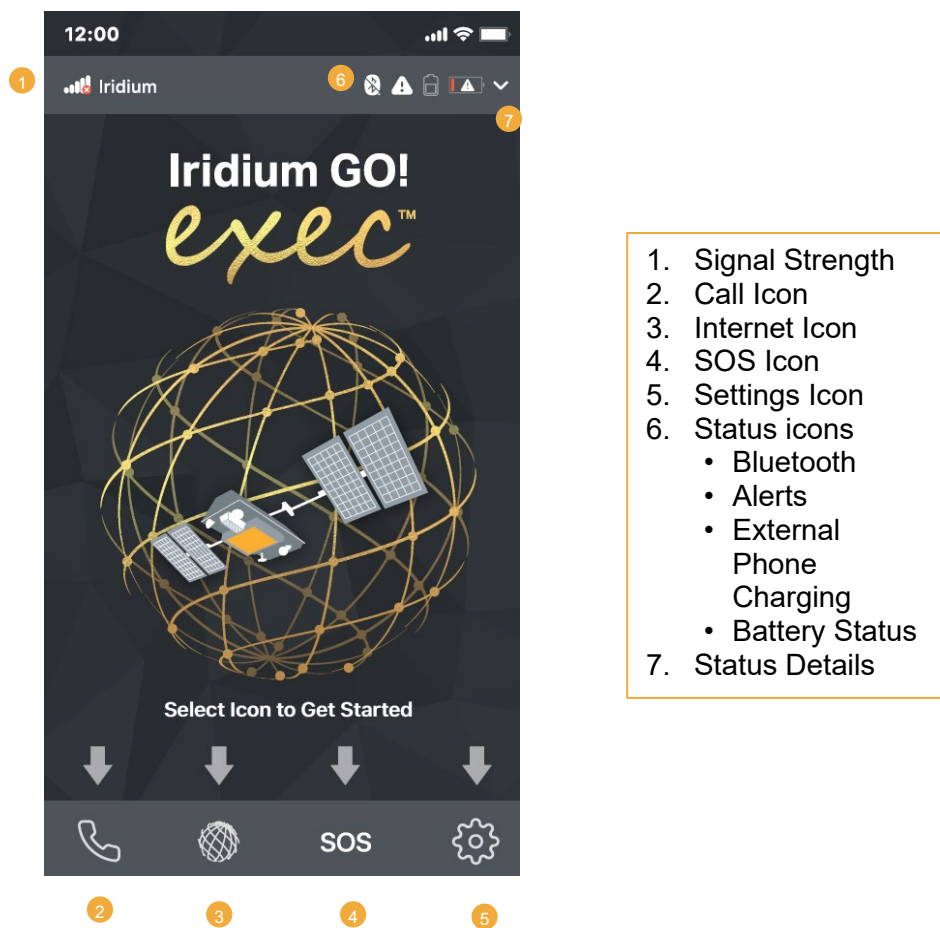
Power Bank Mode

The Iridium GO! exec can charge a Smart Device via the Data USB-C port. Charging is limited to a maximum rate of 5v @1A. The Iridium GO! exec will protect itself from excessive battery drain during external Smart Device charging and will stop charging when the internal battery reaches 22%.

Running the Iridium GO! exec App for the First Time (Onboarding)

The Iridium GO! exec App will guide the user through the following set of onboarding screens when run for the first time:

Terms and Conditions – The user can read the Terms and Conditions attached to using the App by clicking the Terms and Conditions link. The Terms and Conditions must be accepted to use the App.



NOTE: If there is a software update available for the Iridium GO! exec, the App will generate a pop-up notification and ask the user if they would like to update now or later.

Permissions – The App will list all permissions it requires with a brief explanation for each one. Pressing Continue will then request the user to respond for each in turn.

On an Android or an iOS device the user may choose:

- While using the app
- Only this time
- Don't allow

NOTE: It is advised the user permits all requests to avoid any restrictions using the App later.

Tip Screens - Once permissions have been granted, the App will display a series of useful tips. The user can skip these if desired by pressing the Skip button.

Preparing for connection of the Iridium GO! exec App and Iridium GO! exec.

a. Bluetooth connection

Before using your Iridium GO! exec App, you should enable Bluetooth on your smart device. Your Iridium GO! exec App will automatically make a Bluetooth connection to the Iridium GO! exec once the Wi-Fi connection is established. A Bluetooth connection ensures your smart device can receive incoming calls even if the Iridium GO! exec App is in the background.

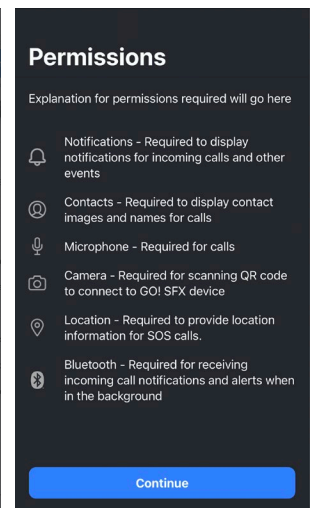
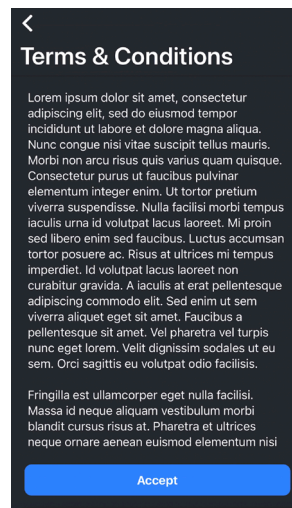
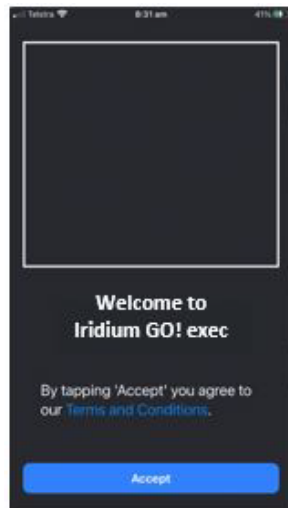

When the Iridium GO! exec App is not connected to the Iridium GO! exec, the Phone, Internet and SOS icons will be disabled. The Settings icon can still be operated with a reduced list of settings available.

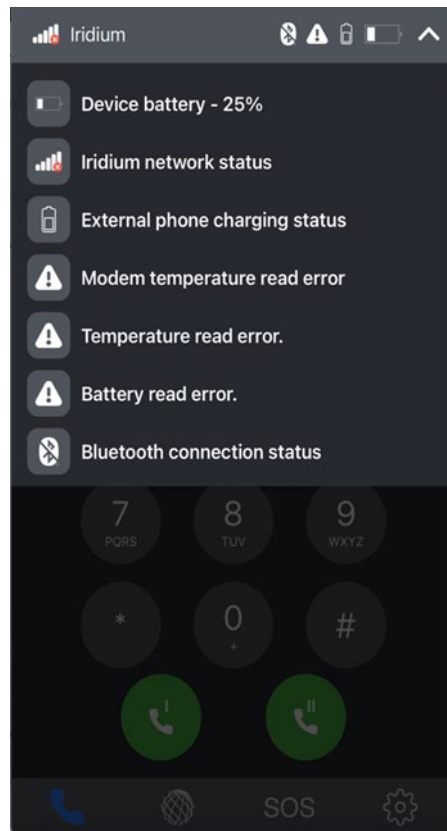

1. Satellite Signal Strength

The current satellite signal strength is indicated on a scale of 1 to 5 bars.

When there is no signal available, the signal strength will show an X overlaid on the antenna bars

Antenna Usage:

The satellite antenna being used is indicated above the signal strength.

INT – The internal antenna is being used.

EXT – The external antenna is being used.

2. Iridium Registration

When the Iridium GO! exec has sufficient signal to register on the network, the word “Iridium” will be displayed next to the signal bars.



3. **Bluetooth Icon**

The Bluetooth icon indicates whether the smart device App is connected to the Iridium GO! exec Bluetooth.

If the Bluetooth icon has a line through it, the smart device App is not connected to the Iridium GO! exec.

4. **SOS Icon**

The SOS icon indicates the Iridium GO! exec is currently in an SOS event.

5. **Phone Icon**

The Phone icon indicates voice lines currently in use. Attempting to use that line via the App will result in an error.

6. **Warning Icon**

The warning icon indicates the Iridium GO! exec has encountered a fault that the user should be aware of. The user can expand the status bar for more information on any warnings.

7. **Internet Icon**

The internet icon indicates there is currently an active internet session.

Select the internet button in the bottom tab bar to see the Web/App Profile , time remaining or disconnect.

8. **External Device Charging**

The Iridium GO! exec device is charging an external device plugged into the headset/external charging port. This icon can also be shown as a headset when the user has plugged in a USB-C digital headset to the port.

9. **Battery Icon**

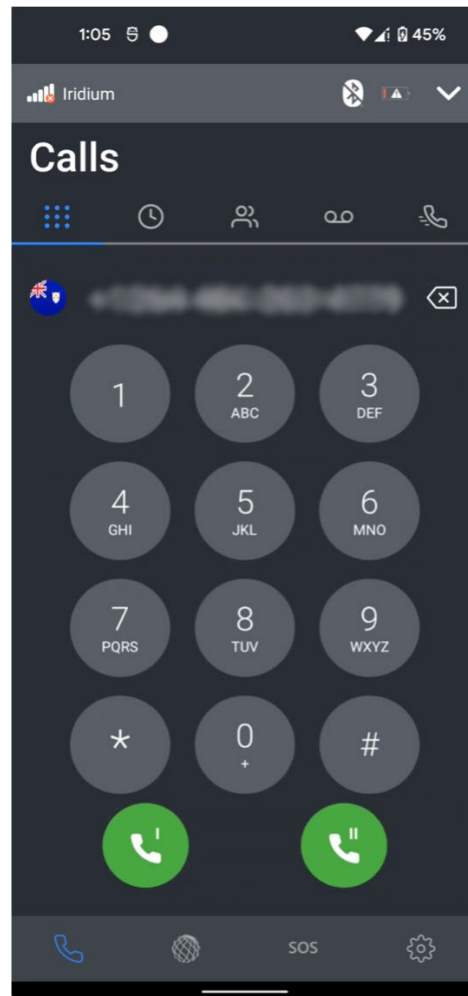
The battery icon indicates the Iridium GO! exec batteries current level of charge. When full the battery is shown filled in white. As the charge drops the white area is decreased to indicate the % of charge remaining. When the charge is less than 10% then the remaining charge is shown in a red color. The user can expand the status bar and see the remaining charge as a percentage.

App Screen Functions

Once your Iridium GO! exec App has successfully connected to the Iridium GO! exec, the App will display the home screen. The home screen has a bottom navigation tab bar containing a row of tabs for selecting any of the major features:

- Phone
- Internet
- SOS
- Settings

By default, the home screen will display the Phone screen. The phone screen encompasses a number of sub-screens which are displayed in the top navigation tab bar.

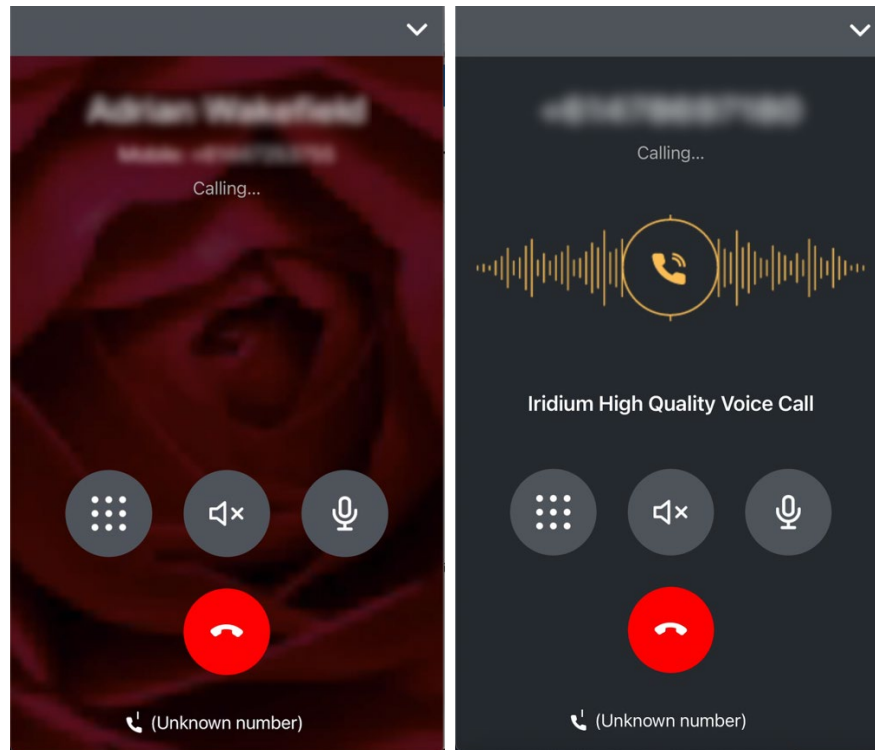

Outbound voice calls

Voice calls are made by selecting the dial pad  from the Home/Phone screen top navigation keypad tab.

The outbound number should be entered with the international direct dial prefix. If smart dialing is configured, the prefix is not required. (See [Smart dialing](#)). When the number is entered correctly, the call is started by pressing the green dial button for either Line 1 or Line 2. (Red buttons indicate the line is in use). If all the available lines are in use, the App User will need to wait until a line becomes free.

The active call screen will be shown while the call is in progress. The active call screen has a button to allow:

- Access to the dial pad (for navigating voice mail systems etc.)
- Hanging up the call
- Muting the microphone
- Switching between normal phone, speaker phone and Bluetooth headsets (if already connected to the smart device)

Emergency calls

Your Iridium GO! exec can make emergency calls to the following commonly recognized emergency numbers: 000 (Australia), 911 (United States) and 112 (European Union).


To make an emergency call simply dial the emergency call number as you would any normal call.

NOTE: Emergency calls do not require the international direct dial prefix.

Emergency calls can be made regardless of line usage. If both lines are busy and they are not making either emergency calls or SOS calls, an emergency call will be made after the lowest priority call is terminated by the Iridium GO! exec.

NOTE: Emergency calls may also be made regardless of the state of the SIM card, i.e., the SIM card can be faulty, invalid or even not present in the Iridium GO! exec.

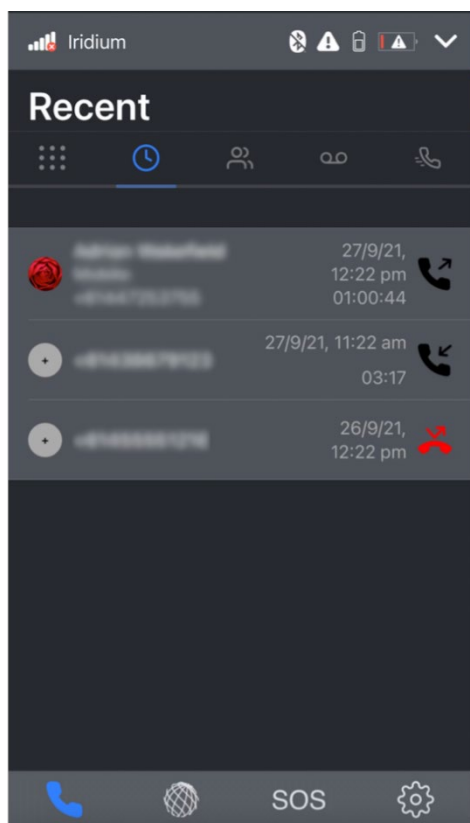

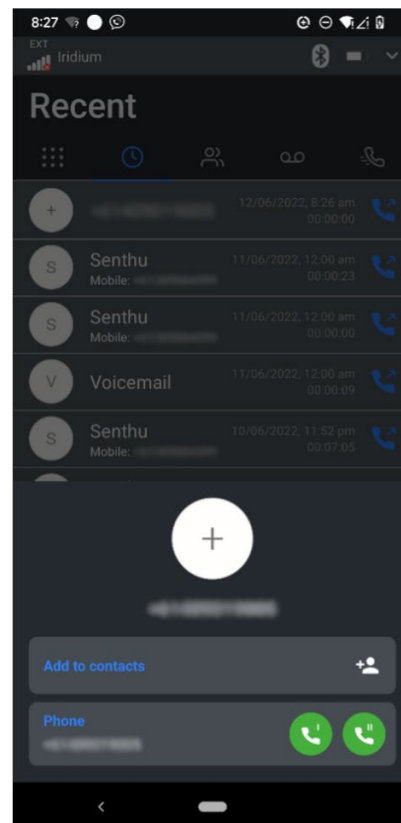

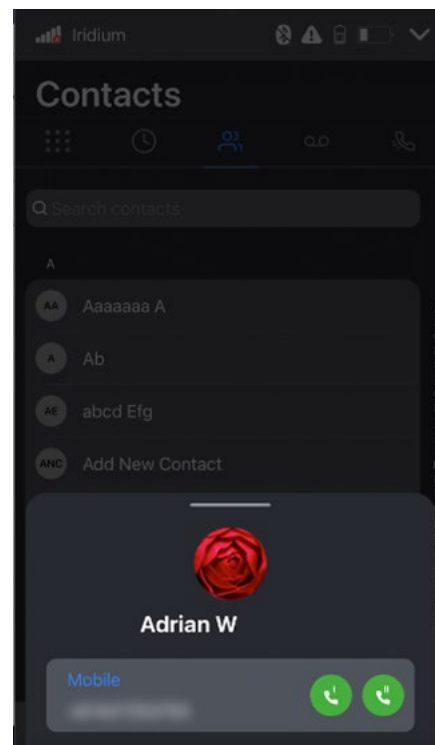

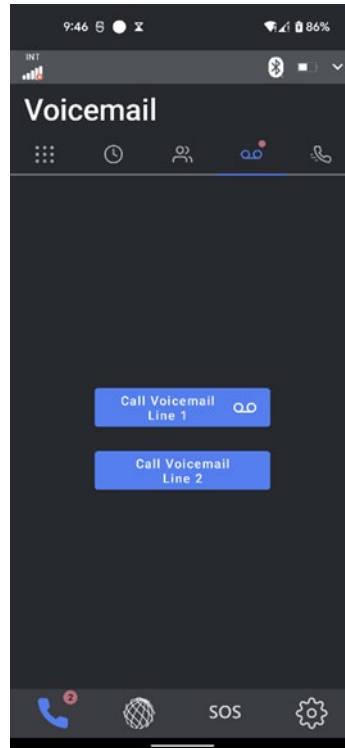

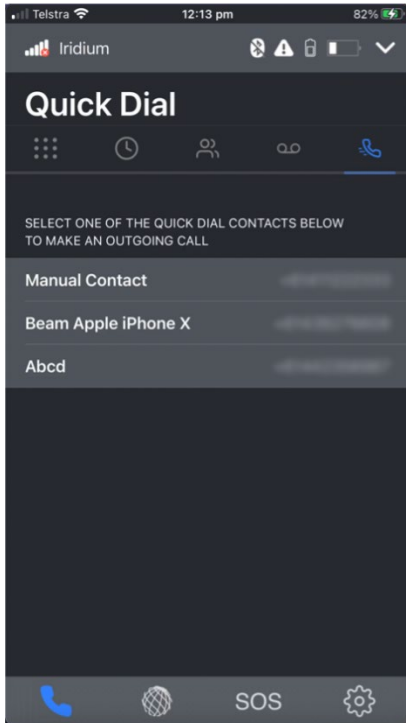
Quick Dial

The Iridium GO! exec App provides a quick dial feature. Numbers that are regularly called can be stored in the Quick Dial list for fast retrieval.

The Iridium GO! exec App User needs to configure the Quick Dial list via Settings/Device Settings/Admin Settings/Call/Quick Dial.

New contacts can be manually added or retrieved from the Contact list.
Up to 10 quick dial contacts can be added.

NOTE: The quick dial entries are stored on the Iridium GO! exec and shared across all connected Iridium GO! exec applications.



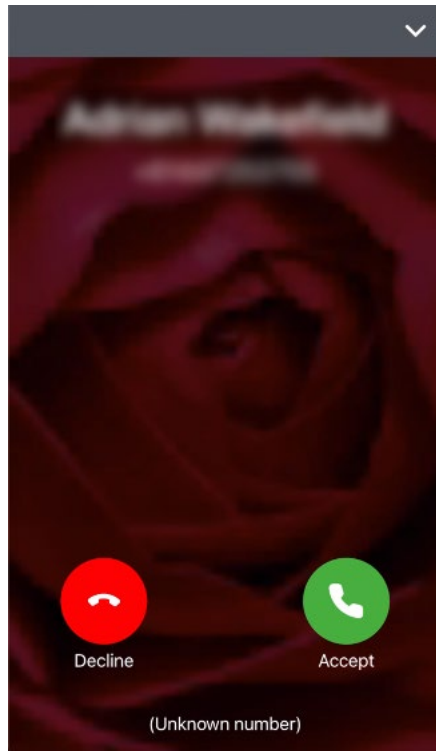

Accepting/Rejecting Calls

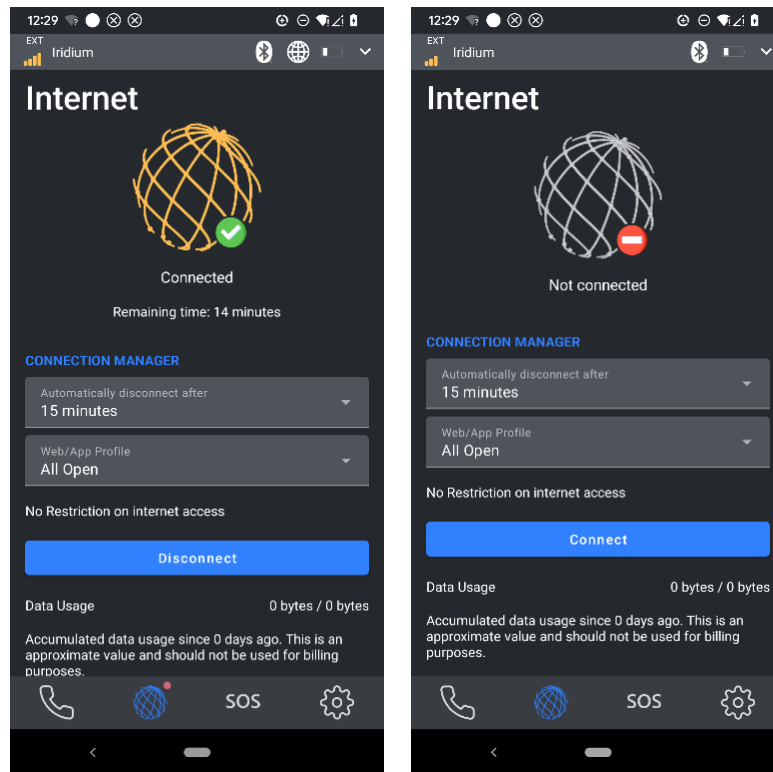
To manage the internet access on the Iridium GO! exec, the App User should select the globe icon  from the bottom navigation tabs.

As satellite data is more expensive than cellular data, it is important to only allow the data you want to go over the satellite network. Iridium's Connection Manager helps you control and manage how you use the internet.

The Connection Manager consists of three items:

- **Automatically Disconnect After:** Allows you to select the duration of your internet call. Additional time can be added as required.
- **Web/App Profile :** Allows you to select the appropriate app or website link you wish to use. Only one Web/App Profile can be selected at a time. The Web/App Profile can be changed while the data connection is active.
- **Data Usage Counter:** Displays the accumulated data usage. The counter can be reset from the Settings option on the Iridium GO! exec app. This is not meant to be used for billing purposes and is just an indicator for how much data is used.

NOTE: Changing the Web/App Profile when a data session is already active will also change the profile selected for any other users connected to the device and using the Iridium GO! exec device.

Using Web/App Profiles for data sessions:

As satellite data is more expensive than cellular data, it's important to only allow the data you want to go over the satellite network. Some Web/App Profiles set the rules to allow or block traffic from going over the satellite network, so it's important to choose the right profile for your data connection. These profiles can be accessed from the:

- Iridium GO! exec device - On the Internet screen, tap the Web/App Profile drop down arrow to see the list of available profiles. Once a profile and session time is selected, press the Connect button to start the data session.
- Application – On the Internet screen, tap the Web/App Profile drop down arrow to see the list of available profiles. Once a profile and session time is selected, press the Connect button to start the data session.

NOTE – When a data session is in progress the active profile can be changed at any time from the Iridium GO! exec device or the Application.

The device/app will come with preset Web/app profiles for some commonly used applications, which are pre-configured firewall settings and also an option for adding advanced custom defined profiles.

Hints while using built in Web/App profiles:

- Some applications reply on iOS and Google Push notifications to inform users of new messages. Push notifications will work on All Open profile only.
- To receive timely notification of incoming messages its recommended to keep the app in the foreground.
- If you have trouble connect or starting up an application with a specific profile, then try switching back to 'All Open' profile to get it going then switch back to the specific profile.

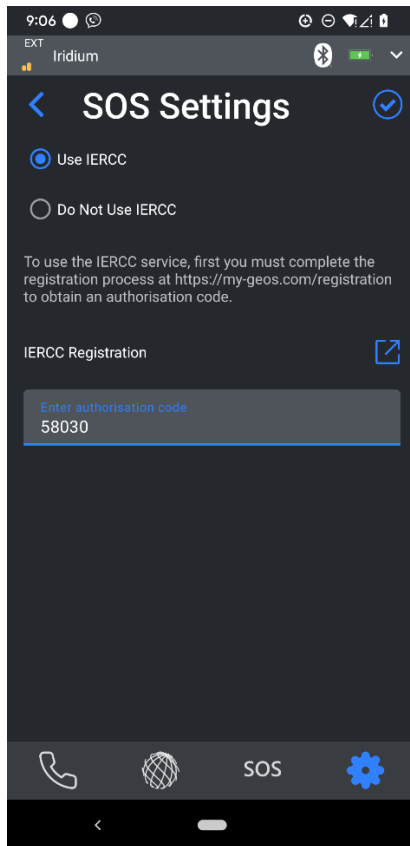

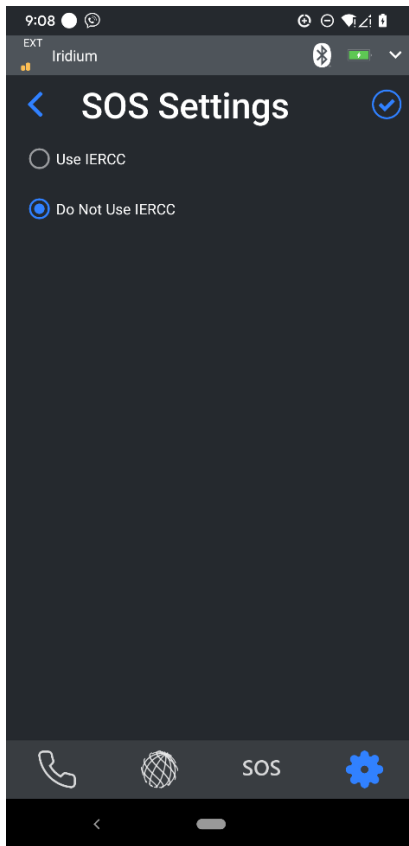
The SOS settings menu allows the Iridium GO! exec user to configure the Emergency Service Provider (ESP) of their choice. The ESP will then be called when an SOS event is triggered either by the Iridium GO! exec App or the Device.

If the ESP is IERCC, the user must provide the authorization code provided by IERCC during the registration process. For the settings to take effect the blue tick icon must be touched.

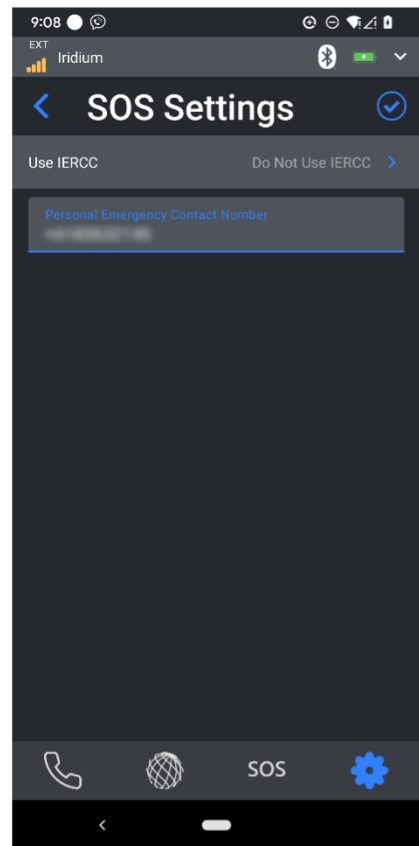
No authorization code is required when specifying non IERCC ESPs. Instead, the user must specify a custom emergency contact number to call. For the settings to take effect the blue tick icon must be touched.

Starting an SOS

An SOS event can be raised directly from the Iridium GO! exec App. SOS can also be generated in 2 ways on the Iridium GO! exec device itself, from the device physical SOS button or from the device UI. (For more information, refer to section SOS Calling).

Make sure the Iridium GO! exec App is connected to the Iridium GO! exec Wi-Fi.

Make sure you have configured an Emergency Service provider (see section SOS Settings)

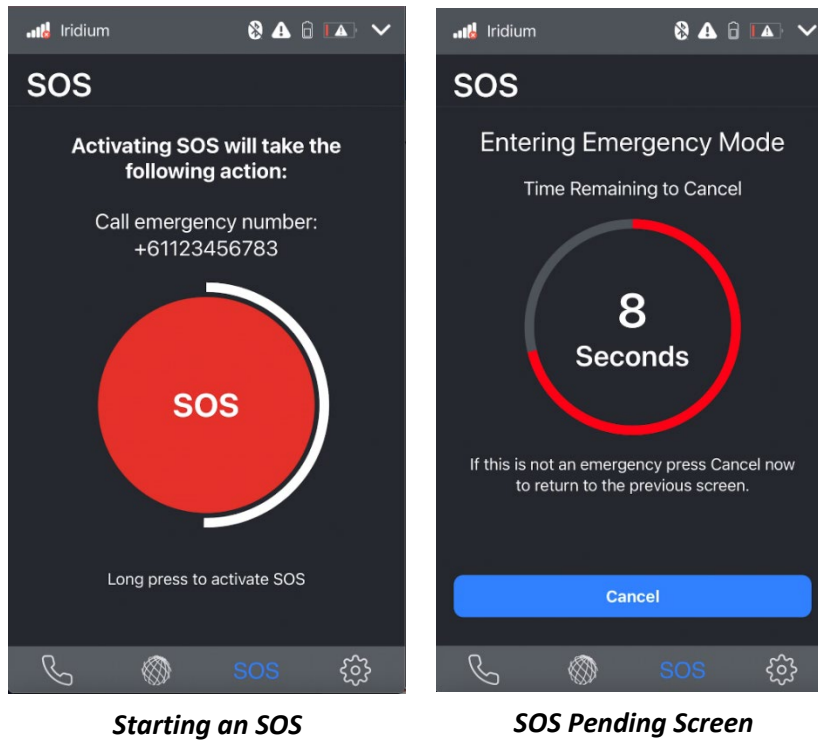
You must configure the SOS button in order to initiate an SOS call to a designated Call Recipient. Failure to configure the SOS button will result in no call when the SOS button is pressed. This could prevent or delay an emergency response and result in serious injury or death.

NOTE: If an SOS is already active, the Iridium GO! exec App will not allow another to be started. Select the SOS tab (**SOS**) from the bottom tab bar.



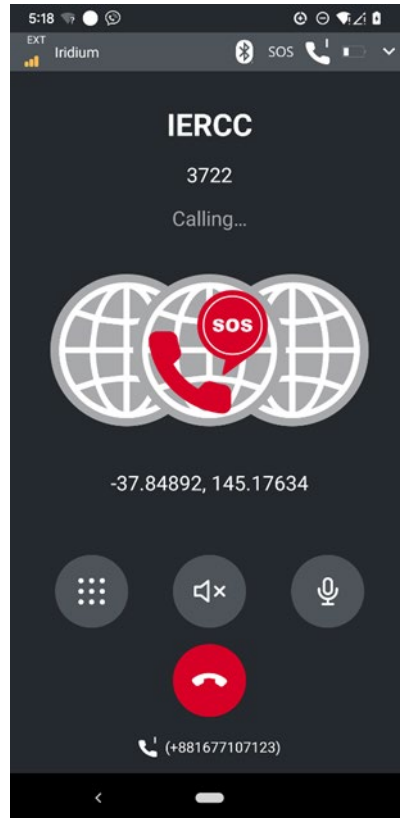
Press and hold the SOS button until the countdown ring expires.

The Iridium GO! exec will then show a pending screen with a timer.

If you wish to abort the SOS event without making contact with your designated Emergency Service Provider (ESP) you can press cancel prior to the pending timer expiring.

Once the pending timer expires, the Iridium GO! exec will display the outgoing call screen indicating:

- The contact details of the ESP you have configured
- Your current location

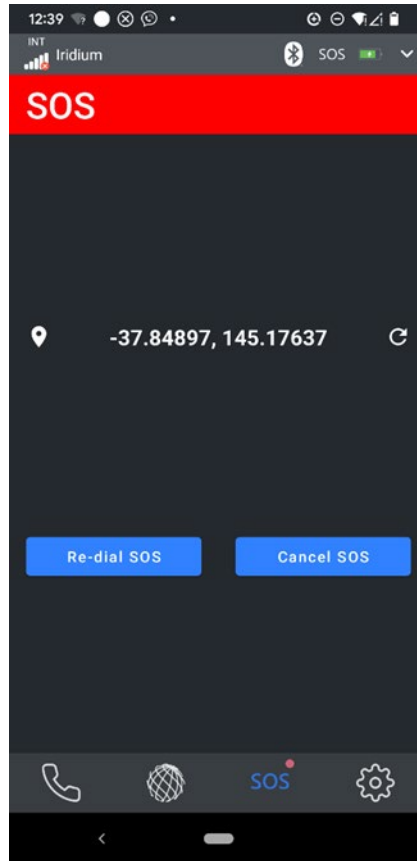


Emergency Service Provider

The Iridium GO! exec App will automatically initiate an outbound call to your designated ESP. The ESP operator will assist you with your emergency. When they ask for your location, please tell them the Latitude and Longitude numbers shown on the screen.

Terminating the call will show the SOS active screen.

NOTE: Terminating the SOS call does not cancel the SOS event.

The SOS active screen allows you to redial your ESP or cancel the SOS event. You can also access any other feature at this time. The SOS event will remain active as signified by the red top banner until cancelled.

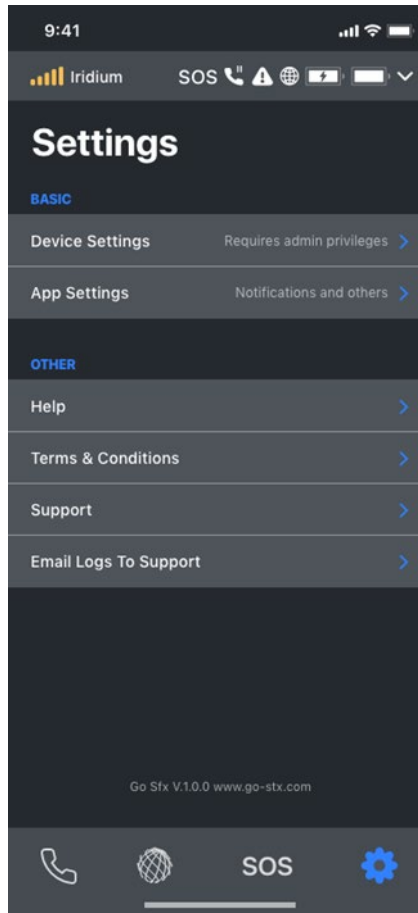
Cancelling an SOS

NOTE: There are two ways the Iridium GO! exec App signifies an active SOS event

- The Title bar will be displayed in RED (normally it is white text on a black background)

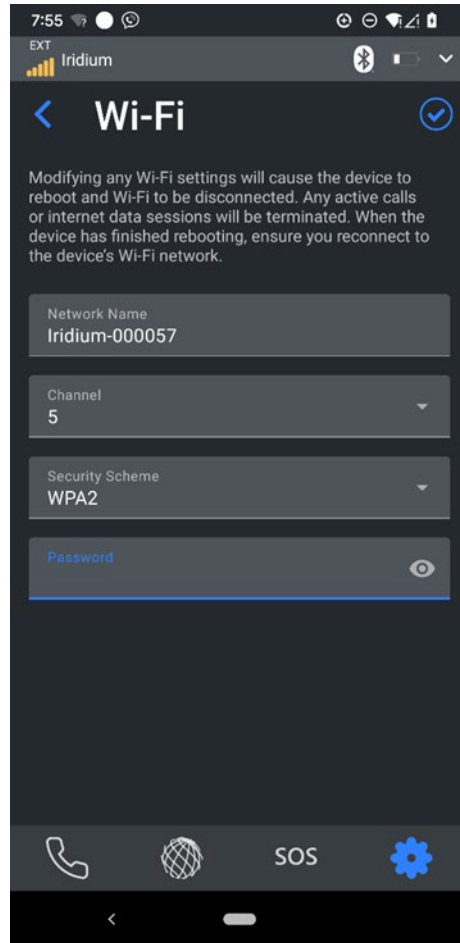

Wi-Fi Settings Menu

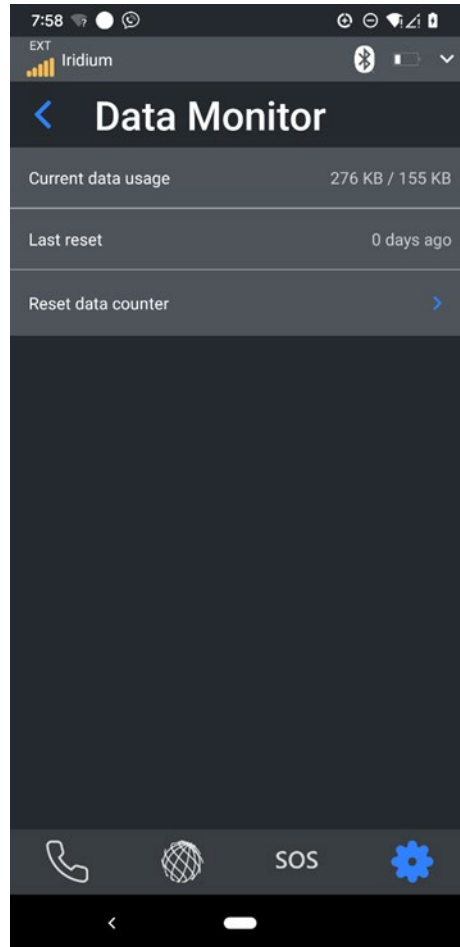
Wi-Fi QR Code Settings

This menu allows enabling or disabling permission for the device to display the Wi-Fi credentials as a QR code. If enabled the Wi-Fi SSID name and password can be easily viewed on the Iridium GO! exec LCD screen.

Billing and Data Monitoring

Aggregated usage data (across all users) for the Iridium GO! exec is shown for upload/download data and time since the data counter was last reset.

The App User can also reset the data counter via this menu.

Routing Related Configuration

All settings related to internet access can be configured under this menu.

Web/App Profiles

Internet sessions run with an associated Web/App Profile. The App User can edit the pre-defined profiles or add their own user defined profiles.

Note: Creating and editing custom Web/App Profiles requires some networking and firewalling knowledge. The following sections assumes the reader has some base knowledge in these areas

Each profile can be configured as follows:

- Profile name
- Description
- DNS blocking enable/disable
- Rule policy (Allow All Except or Block All Except)
- Profile rules IP address or Domain with wildcards
- Profile rule: port (single, range, all)
- Protocols (TCP, UDP or both)

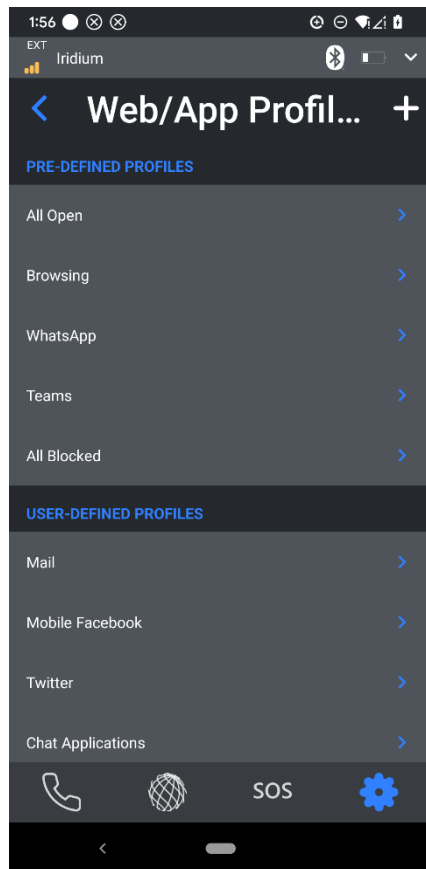
From the Application setting: Device Settings menu choose Web/App Profiles to see the full list of redefined profiles and user defined profiles.

- Press the '+' button in the top right corner to add a new profile.
 - Provide a name and description for the profile.
 - Use the *Rule policy* to set if the rules will allow or block the traffic
 - Use the + button in the *Profile Rules* section to add rules to the profile.
 - Each rule added needs to define
 - An IP address (or range) or a domain.
 - A set of ports to be allowed or blocked.
 - Whether the rule impacts TCP, UDP or both types of traffic.
- Up to 20 rules can be defined in any profile.
- Up to 10 used defined profiles can be added.

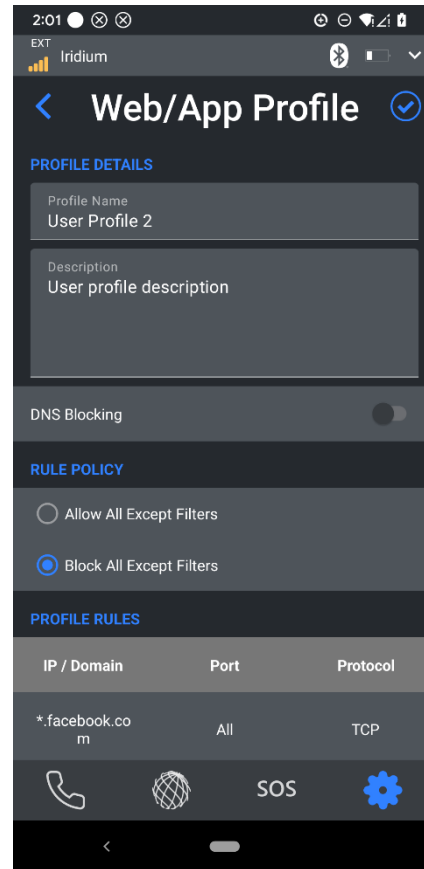
Additional Notes for Custom Profile Creation

Creating and managing Web/App Profiles

- **DNS Blocking**
 - If Enabled DNS queries from LAN clients will NOT be passed to the satellite network.
 - If Disabled DNS queries from LAN clients will be passed to the satellite network.
- **Rule Policy**
 - 'Allow All except Filters' = Blacklist - Allow all traffic except the traffic defined in the rules
 - 'Block All Except Filters' = Whitelist - Block all traffic except the traffic defined in the rules.
- **Profile Rules**
 - Rule IP Address/Domain Name = A single IP address or domain including wildcards. eg 201.130.12.220 or 201.130.12.* or *.facebook.com
 - Rule Port = Any port (or range) within the standard ports 0-65535.
 - Web/App rules can be deleted and copied. Swipe left on the rule to show the 'Delete' and 'Copy' actions
- **Profile management**

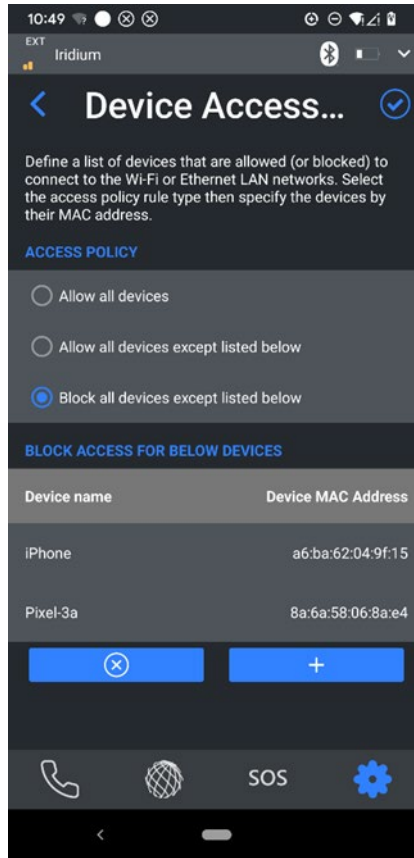

Device Access Control

Your Iridium GO! exec can be configured to allow only certain devices to connect to it. Device access is based on the MAC address of the smart Devices Wi-Fi or Bluetooth adapter. When setting the MAC address, the App User can either directly enter the MAC address manually or select one from a list of devices currently connected to the Iridium GO! exec.

Options for defining access are

- Allow all
- Allow all except (blacklist)
- Block all except (whitelist)



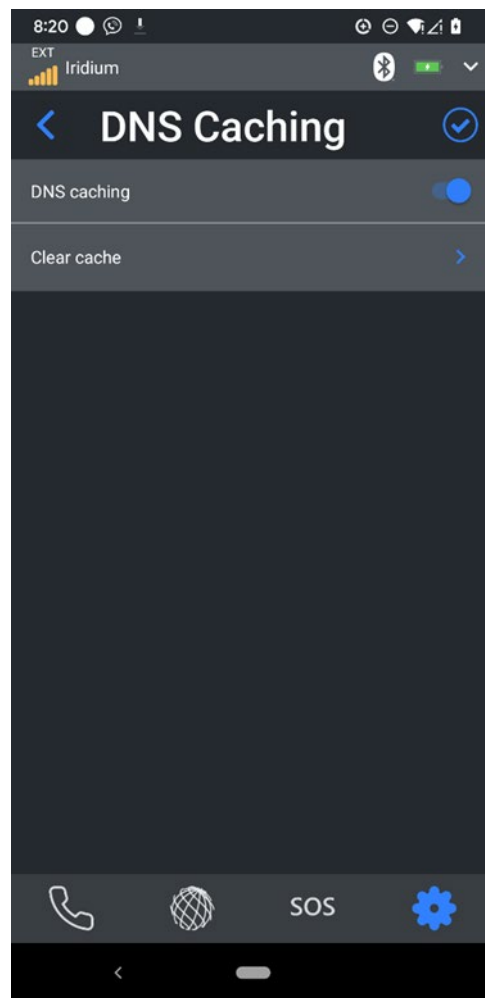
Example of specifying a list of devices allowed to connect to Iridium GO! exec.

DHCP Settings

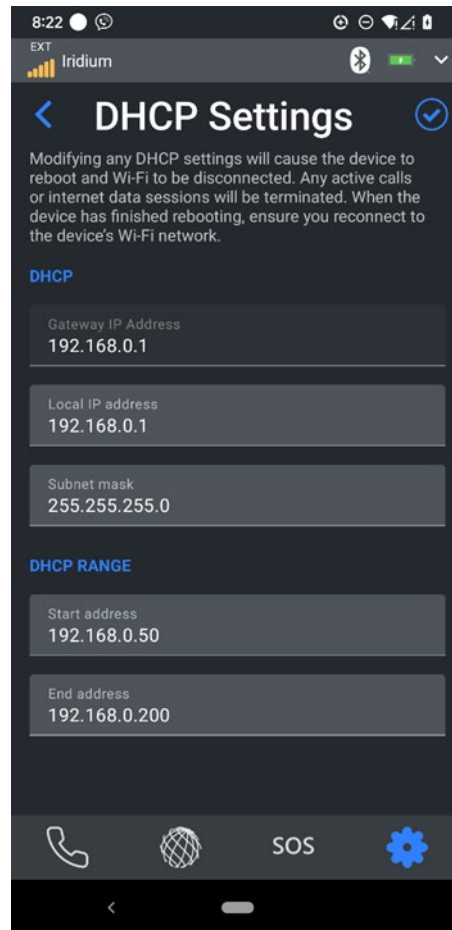
The following DHCP server settings can be configured in the Iridium GO! exec via this menu:

Local IP address. The IP address of the Iridium GO! exec on the network. The default value is 192.168.0.1

NOTE: The Gateway IP address will track the local IP address configured above.

Subnet Mask. The subnet mask defines how many bits of the host IP address are allocated to the subnet. This would typically be 8 bits. The default value is 255.255.255.0

DHCP Range. The DHCP range defines the range of IP addresses the Iridium GO! exec DHCP server can allocate to clients connected to the Iridium GO! exec local network. For the settings to take effect the blue tick icon must be touched. The default range is from .50 to .200.

(showing the default settings)***

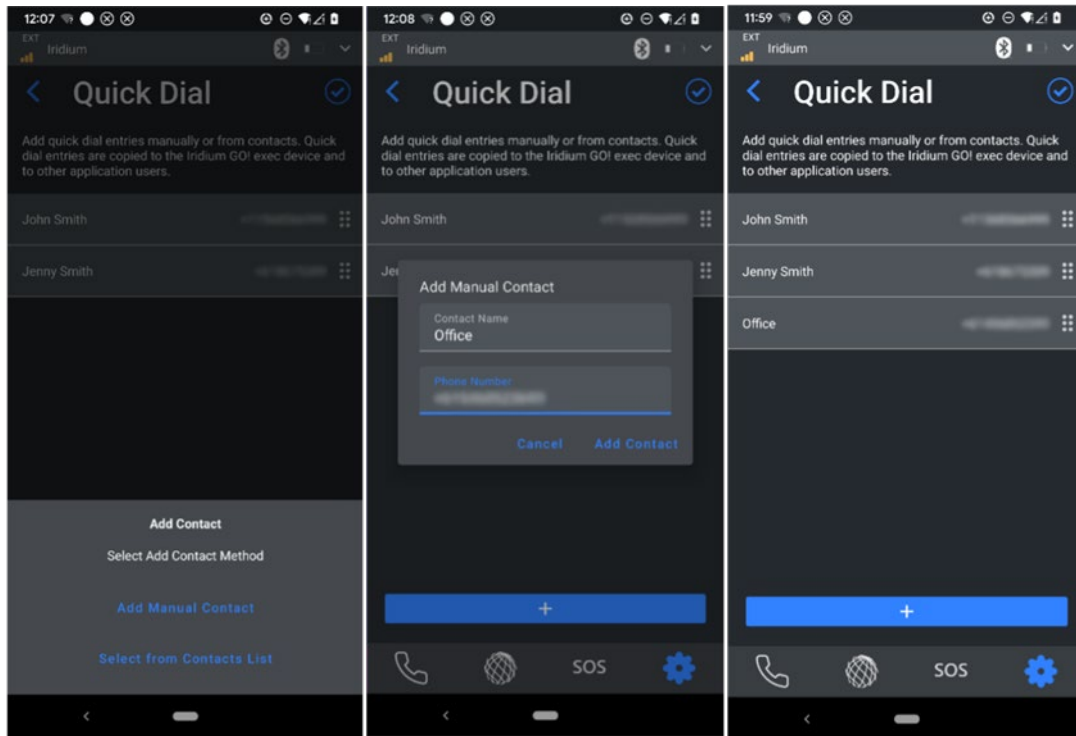
NOTE: Modifying any DHCP settings will cause the device to reboot and Wi-Fi to be disconnected. After reboot the user must ensure to connect the smart device Wi-Fi to the Iridium GO! exec network again. On some smart devices it may be necessary to **Forget** the older network before you can successfully connect to the modified network.

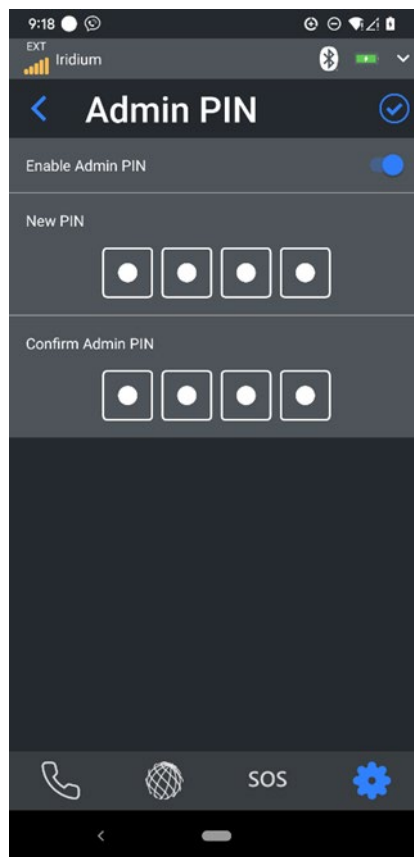


Example Device Information Screen

Admin PIN

The Admin menu allows the App User to enable or disable the Admin PIN in the Iridium GO! exec. When enabled, the user must provide the PIN to access Admin settings in the Iridium GO! exec and the application. When disabled, no admin PIN is required.

The admin PIN is a 4-digit number where each digit may be 0-9. For the settings to take effect the blue tick icon must be touched.

Software Update

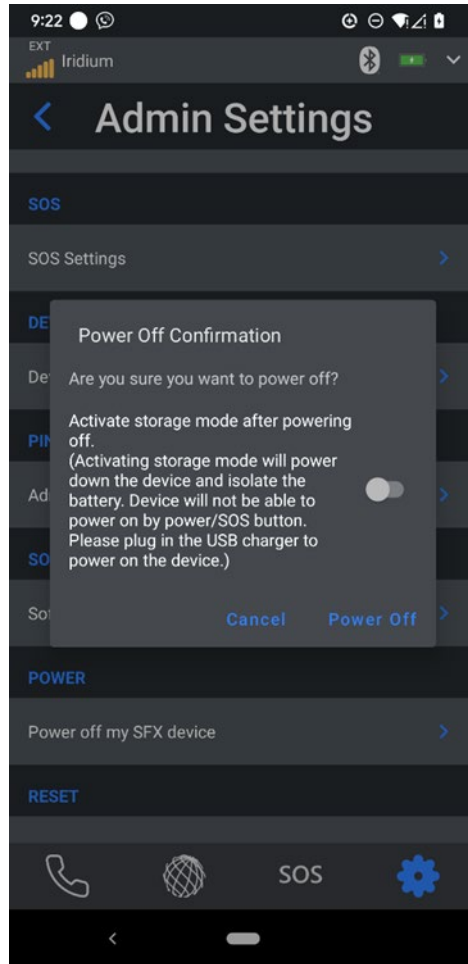
The Iridium GO! exec can complete a software update via the Iridium GO! exec App. Normally the Iridium GO! exec App will notify the user each time the App connects to an Iridium GO! exec if there is a firmware update available. This menu provides a means of updating the firmware if the previous requests have been denied.

NOTE: The Iridium GO! exec will reboot when the update completes, dropping all Wi-Fi connections, voice calls and data sessions in the process.

Power off Iridium GO! exec

The Iridium GO! exec user can power off the Device using this menu. If the device is going to be off for an extended duration (i.e. over a couple months), the device should be powered off with storage mode enabled. Storage mode reduces the battery drain while on the shelf and prolongs battery life.

NOTE: If the Device is put into storage mode, a charger will be required to power it on again.



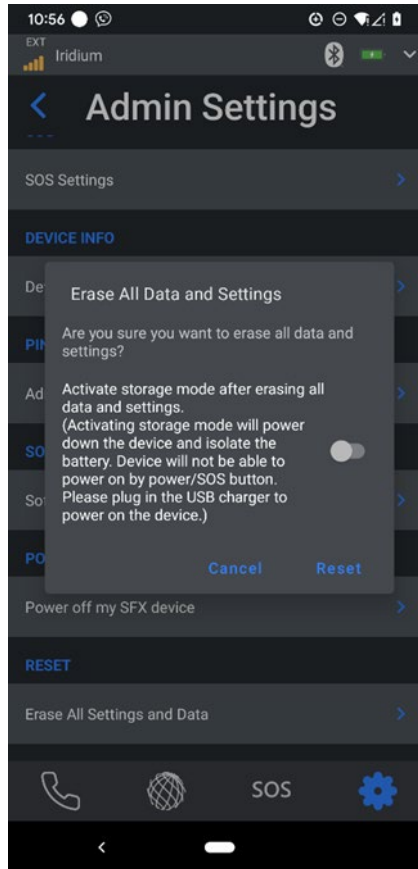
Settings Menu for Powering off the Iridium GO! exec.

Reset

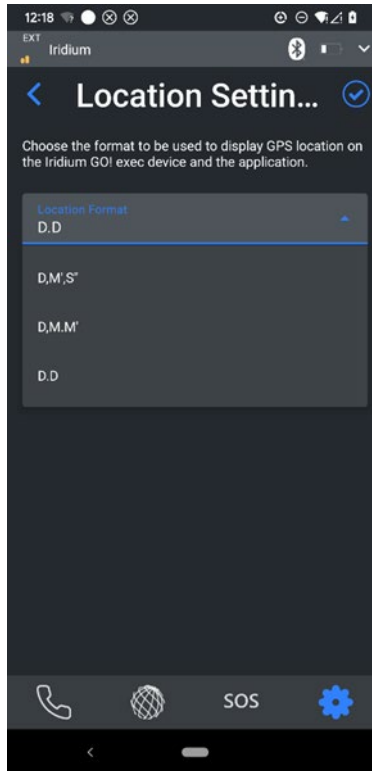

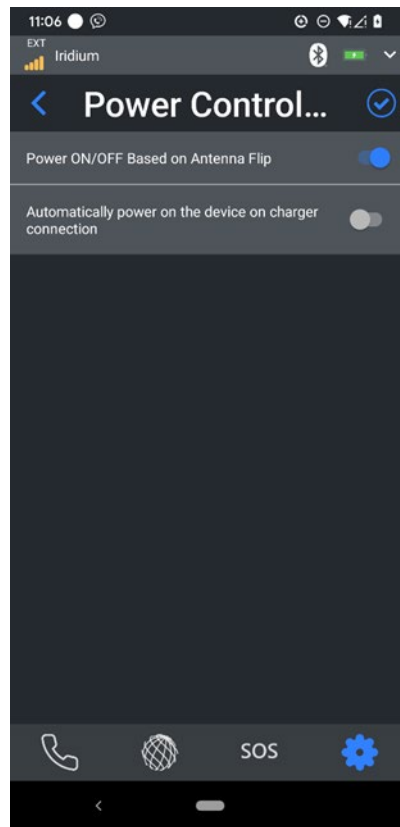
Power control via the raising/lowering of the built-in satellite antenna can be configured.

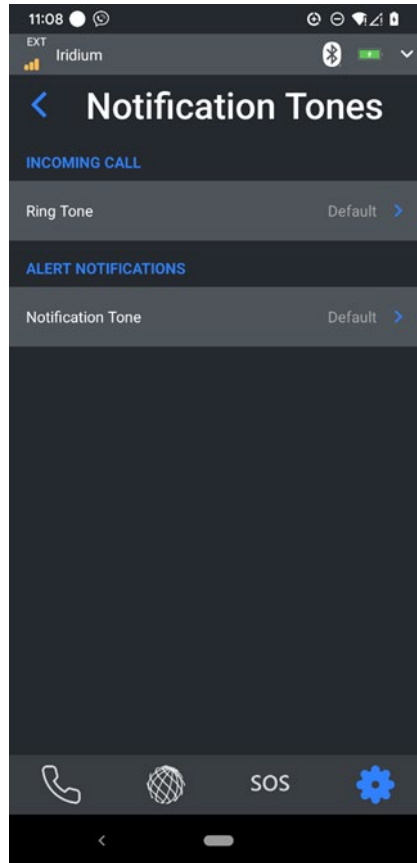

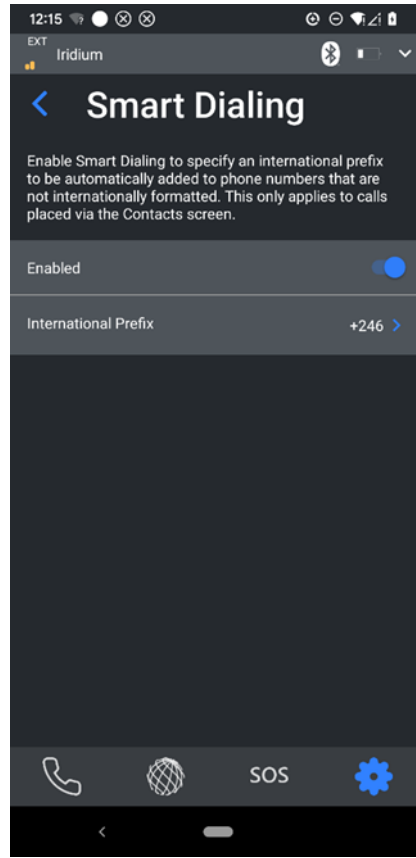


Notification Tone Menu

FAQs

1. How do I use my own application?

a. Apps needing browsing/internet access:

- Connect your smart device to the Iridium GO! exec Wi-Fi network.
- Use the Iridium GO! exec Application or Device to start a data session (and choose an appropriate Web/App Profile).
- Use your own application as you usually would to access the internet via the satellite network.

b. App for SIP voice calls:

- Connect your smart device to the Iridium GO! exec Wi-Fi network.
- Configure your SIP voice calling application to connect to the Iridium GO! exec SIP server.



- Server Name is the Device IP address (by default 1921.68.0.1) or domain name iridiumgo2.lan.

Port (if required) = 5060

2. What are Web/App Profiles and how do I create them?

- a. As Satellite data connections are slower and more costly than typical internet connections, it's important to only allow the data you want to go over the satellite network. Web/App profiles set the rules to allow or block traffic from going over the satellite network. There are a range of preset profiles already in your Iridium GO! exec. Or if you want to create your own profiles you can do so from Settings->Device Settings->Admin Settings->Web/App Profiles menu in the Iridium GO! exec application.

3. My device won't turn on, what do I do?

- a. Plug the Iridium GO! exec device into a compliant charger to check the battery is charged. If the LED lights up, then press the power button to turn the unit on. Lifting/lowering the antenna will also power on/off the unit (unless disabled in the Device Power Config menu)
- b. If the unit still does not start, then press the reset button located inside the SIM cover. You will need a small paper clip or pin to press the button through the small hole.
- c. If the unit still does not start, then try a factory reset by pressing the reset button for >10 seconds. **NOTE:** This will also erase all setting on the device and set it back to factory defaults.
- d. If the unit still does not start, then contact Iridium support at +1.480.752.5155 or toll free: +1.866.947.4348.

4. How do I initiate SOS?

Note: the SOS can only be initiated if the Emergency Mode is configured.

- a. SOS can be raised by
 - Lifting the flap marked SOS and pressing the SOS button for >1 seconds. The unit will turn on if it is not already on.
 - Press the SOS icon on the Devices LCD home screen, then press and hold the onscreen SOS button for 3 seconds.
 - Use the Iridium GO! exec Application to raise and SOS by pressing the SOS icon on the application home screen then press and hold the onscreen SOS button for 3 seconds.

NOTE: When raising an SOS be sure the Iridium GO! exec Device's antenna is lifted, and the unit has a full view of the sky or ensure an external antenna is plugged in.

5. How do I share my Iridium GO! exec with friends/family?

- a. If you share your Iridium GO! exec with a friend or family be sure to provide them the screen pin (if enabled so they can unlock the device). You may choose to also share the admin pin (if enabled).
- b. They can download and install the Iridium GO! exec application to their smart device and also use this to connect to the Device Wi-Fi to make calls and data connections. The Iridium GO! exec can connect to up to 4 devices at the same time.

6. Can I make 2 calls simultaneously?

- a. Yes, the Iridium GO! exec allows two calls at the same time. These can be from any combination of the Device and smart application or SIP phones (either connected over Wi-Fi



or the ethernet port)

7. Can I make calls and use data simultaneously?

- a. Yes, the Iridium GO! exec can allow two calls and a data connection. The quality of the voice call maybe lower when two calls and a data session are active.

8. Can multiple users use the data simultaneously?

- a. Yes, the Iridium GO! exec can allow multiple devices to use the data connection simultaneously, but the satellite data connection is limited speed so more connections mean slower throughput for each person. Also note that only one Web/App profile can be active at any time. So all users will use the last set Web/App profile.

9. Does Iridium GO! exec support SMS or SBD®?

- a. No, the Iridium GO! exec does not support SMS or Short Burst Data® (SBD®). But using the data connection allows Social Media and Instant Messaging applications like WhatsApp, Messenger, etc. can be used for messaging.

10. How do I find my service provider?

- a. Your service provider is the company from which you purchased your Iridium GO! exec. They can best advise on any billing and technical questions you may have. If your device was given to you and you don't know who provisioned it, you can go to iridium.com and search in the Where to Buy section for a new service provider.

11. How do I ensure I efficiently manage my data usage?

- a. It's important to ensure you use the most appropriate Web/App profile when making data connections, as the Web/App profile will allow you to do the Web/App profile you want to achieve and prevent other applications on your PC or smart device from also using internet data in the background. Also be sure not to leave the connection running when it is not required. To assist with this, the Connection Manager provides you a drop-down box to choose a session time.
- b. You can monitor your upload and download usage from the data connection screen (scroll to the bottom). **NOTE** the counts here are approximate values and should not be used for billing purposes.
- c. The usage counter can be reset from the Administrator menu or from the Iridium GO! exec Application
- d. You can also monitor your data usage in the Settings: Device Settings: Admin Settings: Billing and Monitoring menu in the Iridium GO! exec application.
- e. It is also suggested you change the network type on your smart device or laptop to "Metered" or "Low Data Mode" so the amount of background data is minimized.

12. How do I use the protective cover provided in the box?

- a. The protective cover has three uses:
- b. Placed over the top of the Iridium GO! exec it acts as a scratch protector during travel. It will protect the Touchscreen, LCD and upper surface from any damage if the Iridium GO! exec comes in contact with rough or sharp objects while in a bag, suitcase or vehicle.
- c. Placed over the top of the Iridium GO! exec while the unit is on it can protect the Iridium GO! exec from direct sunlight to allow the unit to be operated in hotter environments.
NOTE: The LCD and touchscreen will not be accessible with the protective cover on. The Iridium GO! exec can be turned on/off by lifting/lowering the antenna and data / calls can be placed and answered using the Iridium GO! exec application.



- d. Placed underneath the Iridium GO! exec it can protect the Iridium GO! exec device's base from being scratched when the unit needs to be operated outside on rough surfaces like the ground, rocks or vehicles.
