
What is CD Ordering?

One of our newest features in our Web Tracker solution is Controlled Drug Ordering and Tracking. The system is fully functional across UH Bristol NHS Foundation Trust as of June 2020.

This product in Web Tracker allows for ordering of controlled drugs as well as managing stock and tracking controlled medicines. This allows you to process orders safely and track deliveries up to its destination in a full digital solution.

From Arrival to Destination

Step 1

Book in your prescriptions

Step 3

Track deliveries as they are scanned with bluetooth wireless scanners throughout their journey

Print your label and place it on the specific prescription


Easily locate your prescriptions

The solution can be configured to fit your current business processes or amended to suit a best-practice approach.







Search Medicine

You're a quick search away from finding the right medicine in the system. By just typing in the name of the Controlled Drugs your team straight away finds the medicine they wish to order.

Simplified Medicine Workflow

Rather than clunky, paper-heavy books, the system brings you a simplified flow to manage your Controlled Drugs.



Safety checks for CD order

Book. Approve. Schedule.

For CD orders in particular the right safety procedures are of high importance.

The CD Ordering system prompts you to authorise booked-in prescriptions. Without authorisation from for example a dedicated registered nurse CD orders cannot go through.

This safety check ensures you comply with the regulation as set out by the Care Quality Commission (CQC), and allows you to prove you have done so.

Once approved you can schedule your booked in prescription in full knowledge you've done the necessary checks.



Verification check

The person who places an order can enter their Royal College number. This is used to verify the person placing the order is registered.


This information can be permanently stored on the system for the duration of the registration as well as the verification date. This helps future orders to be processed smoothly.

Compliance with dm+d

The Dictionary of medicines and devices (dm+d) is the recognised NHS standard for communicating medicines information.

Our CD Ordering platform adheres to the standards set out in the dm+d.

As NHS organisations make use of this dictionary on different systems, the CD Ordering system will be intuitive for your staff.
