APPLICATION RATES:

Swine Manure: Apply 2.5 Gallons per 2,400 head hog building each month. Apply each month that you have missed since pump-out as a "shock" treatment. For example, on a 2,400 head building if it has been 4 months since the last manure pump-out apply 10 gallons as a shock treatment then beain majintenance of 2.5 allons per month.

Dairy Manure: Apply 2.5 gallons per 250 head (1 gallon per 100 head) each month. For best results concentrate product application during months when the lagoon is not frozen. If you miss application months in the winter due to frozen lagoons apply missed product as a shock treatment in the soring when lagoons thaw.

Crop Residue: Apply directly to residue at a rate of 1 to 2 quarts per acre with adequate water for coverage. Apply as soon after harvest as possible.

FOR BEST RESULTS:

- Apply product directly to sections of the hog house that have the highest solids accumulation.
- Begin program with a minimum of 3 months remaining until pump-out
- Do not apply in dairy washout systems that contain high levels of anti-bacterials.
