After Nitty Gritty has completed all the works under this contract, it shall provide a work completion certificate to the Client, by either email or hand delivery as confirmation of completion of the works. The Client shall sign as confirmation the said work completion certificate and send it back to Nitty Gritty within 7 days. Failure of the Client to respond to such work completion certificate within the aforesaid 7 days it shall be construed as acceptance and confirmation of the work completion by the Client thereby dissolving all liability from Nitty Gritty.
- 27. If completion of works is delayed by bad weather, public disorder or force majeure event or any other reason, which reasonably justifies an extension of time, Nitty Gritty shall be entitled to an extension, by such period as is reasonably required for it to progress and to complete the works.
- 28. The defects liability period will be 3 Months from the completion certificate issue date.

PAYMENT TERMS AND CONDITIONS
