, Artist, and Crossroads Art Center LLC agree to the following contract:

**INITIAL**

\_\_\_\_\_ **Artist has applied and been approved to exhibit their original artwork.**

\_\_\_\_\_ **Advertising and selling on Crossroads Art Center website:** Artist will sign a one-year contract. The contract will begin on the 1st of the month following the signing of the contract. Payment is due at the signing of the contract. The annual cost for juried artists is \$350. This fee includes setup of the artist’s page and uploading of 30 pieces of art/product. When art/product sells from the website, the artist will send new images/info to replace the sold art/product at no additional cost to the artist. The artist may refresh up to 10 products every two-months. There may be an additional charge for replacing more than 10 products or for replacing more frequently than every two-months. Sales commission is 15%; the artist receives 85%.

## TERMS & CONDITIONS

Crossroads Art Center, LLC (“Crossroads Art Center,” “Crossroads,” “the art center,” “we,” or “our”) provides a service for advertising, selling and purchasing original works of art and commercially exploiting digital images of works of art (the “Services”) through our website, accessible at [www.crossroadsartcenter.com](http://www.crossroadsartcenter.com)(the “Site”). These Terms govern your access to and use of the Site and Services, and constitute a binding legal agreement between you and Crossroads Art Center.

Certain areas of the Site and your access to certain Services may have different terms and conditions posted or may require you to agree with and accept additional terms and conditions. If there is a conflict between these Terms and the terms and conditions posted for a specific area of the Site or for specific Services, the latter terms and conditions shall take precedence with respect to your use of or access to that area of the Site or Services.

YOU ACKNOWLEDGE AND AGREE THAT, BY ACCESSING OR USING THE SITE OR SERVICES OR BY SELLING OR PURCHASING A WORK ON OR THROUGH THE SITE OR SERVICES OR BY POSTING ANY CONTENT ON THE SITE, YOU ARE INDICATING THAT YOU HAVE READ, UNDERSTAND AND AGREE TO BE BOUND BY THESE TERMS, WHETHER OR NOT YOU HAVE REGISTERED WITH THE SITE. If we modify these Terms, we will post the modification on the Site or provide you with notice of the modification. We will also update the “Last Updated Date.” By continuing to access or use the Site or Services after we have posted a modification on the Site or have provided you with notice of a modification, you are indicating that you agree to be bound by the modified Terms. If the modified Terms are not acceptable to you, your only recourse is to cease using the Site and Services.

### Eligibility

The Site and Services are intended solely for persons who are 18 or older. Any access to or use of the Site or Services by anyone under 18 is expressly prohibited. By accessing or using the Site or Services you represent and warrant that you are 18 or older.

### Feedback

You acknowledge and agree that all Feedback will be the sole and exclusive property of Crossroads Art Center and you hereby irrevocably assign to Crossroads Art Center and agree to irrevocably assign to Crossroads Art Center all of your right, title and interest in and to all Feedback, including without limitation all worldwide patent rights, copyright rights, trade secret rights, and other proprietary or intellectual property rights therein. At Crossroads Art Center’s request and expense, you will execute documents and take such further acts as Crossroads Art Center may reasonably request to assist Crossroads Art Center to acquire, perfect and maintain its intellectual property rights and other legal protections for the Feedback.

### Member Content

In addition to submitting listings for Original Works of Art and Digital Works, Crossroads Art Center may, in its sole discretion, designate areas of the Site in which Members can post, upload, publish or submit text, graphics, audio, video, images of works of art or other content on or to the Site (individually or collectively, “Features”). “Features” excludes any images of Original Works of Art or Digital Works for which a Member submits a listing, as described under “Seller Terms and Conditions” above. Crossroads Art Center does not claim any ownership rights in any such Feature Content and nothing in these Terms will be deemed to restrict any rights that a Member may have to use and exploit any such Feature Content. By making available any Feature Content on or through the Site and Services, (i) you grant Crossroads Art Center a worldwide, non-exclusive, transferable, royalty-free, commission-free license to crop, resize, publicly display, publicly perform, distribute, broadcast and transmit such Member Content on or through the Site and Services in any form, medium or technology now known or later developed, for the purpose of promoting Crossroads Art Center, the Site and Services, and (ii) you grant directly to other Members the right and license to view your Feature Content on or through the Site and Services only in connection with such Member’s authorized use of the Site and Services. You reserve all other rights and licenses in and to any Feature Content that you make available on or through the Site and Services.

You acknowledge and agree that you are solely responsible for any Feature Content that you make available on or through the Site. Artists agree not to do any of the following:

- Post, upload, publish, submit or transmit any text, graphics, images, software, music, audio, video, information or other material that: (i) infringes, misappropriates or violates a third party's patent, copyright, trademark, trade secret, moral rights or other intellectual property rights, or rights of publicity or privacy; (ii) violates, or encourages any conduct that would violate, any applicable law or regulation or would give rise to civil liability; (iii) is fraudulent, false, misleading or deceptive; (iv) is defamatory, obscene, pornographic, vulgar or offensive; (v) promotes discrimination, bigotry, racism, hatred, harassment or harm against any individual or group; (vi) is violent or threatening or promotes violence or actions that are threatening to any other person; (vii) harms minors in any way; or (viii) promotes illegal or harmful activities or substances.
- Use, display, mirror or frame the Site, or any individual element within the Site, Crossroads Art Center's name, any Crossroads Art Center trademark, logo or other proprietary information, or the layout and design of any page or form contained on a page, without Crossroads Art Center's express written consent;
- Access, tamper with, or use non-public areas of the Site, Crossroads Art Center's computer systems, or the technical delivery systems of Crossroads Art Center's providers;

The limitations of damages set forth above are fundamental elements of the basis of the bargain between Crossroads Art Center and you. Some jurisdictions do not allow the exclusion or limitation of liability for consequential or incidental damages, so the above limitation may not apply to you.

These Terms constitute the entire and exclusive understanding and agreement between Crossroads Art Center and you regarding the Site and Services and these Terms supersede and replace any and all prior oral or written understandings or agreements between Crossroads Art Center and you regarding the Site and Services.

#### **Assignment**

You may not assign or transfer these Terms, by operation of law or otherwise, without Crossroads Art Center's prior written consent. Any attempt by you to assign or transfer these Terms, without such consent, will be null and of no effect. Crossroads Art Center may assign or transfer these Terms, at its sole discretion, without restriction. Subject to the foregoing, these Terms will bind and inure to the benefit of the parties, their successors and permitted assigns.

#### **Notices**

Any notices or other communications permitted to required hereunder, including those regarding modifications to these Terms, will be in writing and given: (i) by Crossroads Art Center via email (in each case to the address that you provide) or (ii) by posting to the Site. For notices made by e-mail, the date of receipt will be deemed the date on which such notice is transmitted.

#### **General**

The failure of Crossroads Art Center to enforce any right or provision of these Terms will not constitute a waiver of future enforcement of that right or provision. The waiver of any such right or provision will be effective only if in writing and signed by a duly authorized representative of Crossroads Art Center. Except as expressly set forth in these Terms, the exercise by either party of any of its remedies under these Terms will be without prejudice to its other remedies under these Terms or otherwise. If for any reason a court of competent jurisdiction finds any provision of these Terms invalid or unenforceable, that provision will be enforced to the maximum extent permissible and the other provisions of these Terms will remain in full force and effect.
