

# **Technical Data Sheet PolyGloss 85**

### **Product Description**

One Stop Epoxy PolyGloss 85 is a tough high solids two component floor coating system. Easy mix ratio one part resin to one-part catalysts by volume (1:1). Excellent UV and Chemical Resistance. This product is **FOR PROFESSIONAL APPLICATORS ONLY. NOT FOR DIYERS OR HOMEOWNERS.** Time is of the essence when using Polyaspartic. Polyaspartic by nature is a very fast moving product requiring experience and skill to apply properly. If you are not an experienced installer, do not use this product.

### **Surface Prep & Priming:**

Grind concrete floors to CSP-3, vacuum dust, wipe with Denatured alcohol. If moisture is present floor may require application of Moisture Vapor Barrier.

#### **Mixing**

Add One Part A to One Part B by volume (1:1). Full Kits of PolyGloss 85 should be mixed for 2 minutes with mechanical mixing. Wearing spike shoes immediately pour mixed material on the floor.

#### **Application – Concrete Base Coat**

Pour mixed material on the floor in 12" ribbons and spread using a 5-7 mil notched squeegee. While wearing spiked shoes back roll with 3/16" premium lint-free roller.

### **Application – Full Flake Floor Top Coat**

Pour mixed material on the newly installed flake floor in 12" ribbon and spread using a flat red rubber squeegee. While wearing spiked shoes pull product tight covering the entire flake floor. Have a second person back roll with 3/16" premium lint-free roller as soon as person using squeegee has moved out of the way. Time is of the essence. Polyaspartic by nature is a very fast moving product requiring experience and skill to apply properly. If you are not an experienced installer, do not use this product.

#### **Dry Time and Recoat**

Tack-free in 2 - 4 hours, fully cured in 24 hours Recoat window is within 24 hours Heavy Foot Traffic 48 hours Vehicular traffic 48 hours Before applying additional coats or finish coats, sand the surface and wipe it down with denatured alcohol or acetone. If you are resealing a flake floor you will need to sand the floor smooth to achieve proper bonding.
