Narrative Description: The incumbent in this position shall be an aircraft maintenance professional that shares our passion for safety and excellence in operations. The duties performed by this position will generally be aircraft maintenance and program support including, but not limited to, conducting aircraft maintenance actions, conducting aircraft maintenance and program support, coordinating and interfacing with logistics management/supply chain ensuring parts and equipment orders are processed and tracked, supporting the Maintenance Manager in coordination with vendors and/or contractors and other duties as directed. The incumbent must be skilled and knowledgeable in FAA regulations, Environmental Protection Agency (EPA) regulations and Organizational Safety and Health Administration (OSHA) regulations. The incumbent in this position must possess an FAA Mechanics Certificate with Airframe and Powerplant ratings (A&P), Inspection Authorization (IA) is preferred. Experience with rotorcraft, specifically Schweizer H269C-1 (S300CBi) and Robinson R-44 preferred. Experience performing aircraft maintenance under FAR Parts 43 and 145 supporting operations under Parts 91 and 141 preferred. The incumbent in this position shall have excellent organization and time management skills as well as possess skills in written and verbal communications. The incumbent shall have experience in Microsoft Office software.

The incumbent in this position must be eligible to work in the United States and must pass initial background screening and Transportation Security Administration (TSA) training. This position requires a valid state/local government Driver's License.
