Enrollment and payment of your deposit for the tour, establishes your acceptance of the terms.

This tour is based on rates, tariffs and ground costs in effect May 9, 2016; TOUR PRICE IS BASED ON A MINIMUM 20 PASSENGERS for prices to be valid. If group size is less at 19-15 passengers a \$150 per person supplement may apply to the price. If group size is less than 10 travelers, the tour may be cancelled due to lack of participation. Tapestry Tours reserves the right to add a surcharge if the dollar declines by more than 2% against the foreign exchange rates in effect on date when your tour was booked.

INCLUDED IN PRICE: Round trip airfare from gateway as per brochure, Taxes and fuel charges totaling \$710.00 (subject to increase by airline up to 30 days prior to departure) Superior First Class hotels including breakfast & dinner daily (coffee and or tea included with breakfast only). Comprehensive daily sightseeing per itinerary including all entrance fees to all sites included. Private deluxe motor coach with licensed driver and government licensed English speaking guide. Pre-collected – worry free tips for all services provided throughout at \$150 per person.

ACCOMMODATIONS: Prices are based per person double occupancy (two people sharing a room) **SINGLE ROOM SUPPLEMENTS: \$930.00** please note that single rooms are often smaller than doubles. **NOT INCLUDED:** Optional Travel Insurance; Miscellaneous fees such as individual transfers, passports, laundry, beverages at meals; (these extra items will be billed to you before leaving the hotel, or restaurant), lunches throughout land tour; excess baggage and items of personal nature; Any increase in taxes fuel charges and/or fees imposed after the printing of this brochure by airlines.

PAYMENTS: A deposit of \$500 per person is required at time of registration either by credit card or check. Final payment must be made in the **form of a check only (credit cards are not accepted other than the \$500 initial deposit. Call us with additional assistance on payments).** Final payment including **OPTIONAL TRAVEL INSURANCE PREMIUM** is due by **01/24/2017**. Registrations received after **01/24/2017 must be accompanied by full payment. Installment payments are accepted and updated statements will be forwarded with each payment received.** If Tapestry Tours does not receive the full and final payment by the due date you will be automatically cancelled from the tour and your initial deposit of \$500 will be forfeited (unless other arrangements have been made). Please check your statement for specific due dates.

FLIGHT TIMES: All flight times and routing are subject to change by the airlines without advance notice. Tapestry Tours is not responsible for such changes or delays and does not reimburse expenses resulting from such delays. If you are making your own flight arrangements from your city to meet up with the group departure city, we recommend you purchase a ticket which can be changed without large penalties. Passengers are responsible for reconfirming their flights with the airline 24 hours prior to departure.

AIRLINE TICKETS & ROUTING: Air transportation is restricted to the services of any IATA and ARC carrier in economy class based on non-refundable fare from the departure city stated in brochure. Airfares used are based on contracted group fares and are highly restrictive. Payments for and restrictions on airline tickets are governed by the applicable fare. Cancellation fees levied by the airlines are applicable if you cancel or change your air ticket for any reason after purchase of air ticket. Ticketing must be completed 45 days prior to departure. **All travelers are responsible to provide their names as they appear in their passport***. Group fares do not permit deviations; passengers who wish to deviate may arrange their own airfare. An airline credit will be given to those passengers who arrange their own airfare. LAND ONLY PRICE: \$2,875 per person. If you choose to purchase a land only package and arrange your own domestic and international flight independently, Tapestry Tours, will not be responsible for any flight schedule changes. When purchasing domestic or international tickets, all changes/penalties and fare differences will be paid by the client.

CANCELLATION FEES: If tour is cancelled due to lack of participants by 1/17/17 a charge of \$85 per person will be deducted from the amount refunded for administrative fees. Any cancellation from day of registration up to January 24, 2017 there will be a cancellation fee of \$250 to cover non-refundable administrative fee per person plus **airline penalties**. You will also be charged a single room fee if your cancellation forces your roommate into a single room. For cancellation within 1/18/17 – 1/31/17 you will be subject to a 50% penalty or \$250 whichever is greater. Cancellation from 1/25/17 to day of departure 5/5/17 are subject to a penalty of 100% of tour price. All cancellation requests must be received by Tapestry International Tours in writing. On or after the day of departure there is no refund for any services not used. **We strongly recommend you purchase travel insurance.**
