**IF YOU ALREADY HAVE A CRUNCH ACCOUNT WITH ENVIROBANK** and would like to convert your points for donation to Katie Rose Cottage Hospice, you can do this with our Containers for Change account number **C10113049** - On the REWARDS page scroll down and click on the EFT PAYMENTS tab, then QUEENSLAND SCHEME PAYMENT and VIEW REWARD –this page will let you know how many credits you have – click CONTINUE- Decide on REDEMPTION AMOUNT – then CHECKOUT NOW and type in our Containers For Change Account Number – **C10113049** – The money will be deposited straight into our bank account – Thank you for your support

# IF YOU DON'T HAVE AN ACCOUNT - ITS EASY TO SET UP

1) Register with CRUNCH - www.envirobank.com.au

This will take you to the front page – we would suggest you first find your nearest drop off location - then sign up.

Here you just enter your name, postcode and email address You will then be sent an email to register your account – you just tap on "complete my registration" You then need to think of a password and confirm.

- If you haven't already done so then you need a Envirobank collection bag for your containers – these can be found at your collection depot or look on site to find other places you can pick up bags such as in Noosa – Sandy Bolton MP Office or Coles Peregian
- 3) Fill your bags with eligible containers below
- Once you are at your deposit station and have your account opened on your mobile – click on RECYCLE, confirm your location, then scan or type in your bag code.
- 5) You will be awarded credits once the bag has been checked
- 6) You can then convert theses points to cash for Katie Rose cottage by following the steps above \*\*

# NO NEED TO SET UP AN ACCOUNT - JUST USE OURS C11013049

- Find good quality, strong bags (but not black bin bags) that will not split whilst full if thrown around. Fill them with eligible containers \*Please note that these bags are not returnable\*
- 2) Take to your nearest depot, print out a ticket to stick on the bag, and deposit in the large bins. Your nearest depot can be found by visiting www.containersforchange.com.au for example, in Noosaville it is Caltex Tewantin (44 Doonella Street), You will have to print out your ticket in the service station shop where the machine is placed just inside the door.
- 3) Your bags will be collected and counted, the monies will go directly into our Katie Rose Bank Account Thank you for your support

# **Eligible beverage containers**



Most aluminium, glass, plastic, steel and liquid paperboard beverage containers between 150ml and three litres are eligible for a refund when returned to a container refund point. To be eligible the beverage container must:

- Have contained a beverage product that is not excluded from the scheme. For example, cordials and plain milk are not included in the scheme so containers that have held these products are not eligible for a refund
- Display the refund mark. This is so that the container refund point operator can see if the container is part of the scheme. Most containers will already have a refund mark for SA and NT and these containers are eligible under Containers for Change. Beverage manufacturers have until 1 December 2019 to display the new refund mark on their containers

#### **Excluded beverage containers**

There are some beverage containers that are not eligible for a refund. Generally excluded containers are those that are less than 150ml and greater than three litres. Other excluded containers include:

- Any plain milk containers
- Any glass containers which have contained wine or pure spirits
- Containers 1L or more which have contained flavoured milk, pure fruit or vegetable juice, cask wine or cask water
- Concentrated/undiluted cordial or syrup containers
- Sachets above 250ml which have contained wine
- Registered health tonics

Excluded containers, such as plain milk bottles and glass wine bottles, can still be recycled through existing kerbside collection or drop-off services.
