Flash Jewellery and our manufacturers will provide a healthy and safe workplace for all employees. Workers shall have access to clean drinking water, hygienic facilities and ventilated workspaces. Fire safety & evacuation plans shall be maintained & updated regularly.

Environment ———

Flash Jewellery and our manufacturers will conduct all operations and services in compliance with local and internationally recognised environmental practices. We will incorporate principles of sustainability into business & encourage all employees to express fundamental environmental concerns.

Harassment & Bullying ———

Flash Jewellery and our manufacturers require all employees to be treated with dignity and respect. No employee shall be subject to harassment, bullying or abuse, whether that be in physical, verbal, sexual or physiological form.
