Review of Results for Third Quarter - 3 Months Ended 31 March 2007 (3Q07)

Group operating revenue for the third quarter grew 43% to S\$65.7 million against the same period in 2006. Net profit after tax rose to S\$3.3 million from S\$1.6 million.

Turnover - Geographical

• Southeast Asia - Singapore, Malaysia, Thailand

The Southeast Asian markets continued to grow and posted an overall increase of 52% in turnover over 3Q06.

For the fashion retail and distribution division, sales increased by 67% mainly from GUESS, RAOUL, LA SENZA, GAP and export sales to an associated company. Most brands continued to record double-digit growth in existing stores. Newly introduced brand, GAP, contributed 40% to the increase while sales to an associated company contributed 17% to the increase.

For the timepiece division, there was a 15% increase in revenue with contributions coming from technical and life-style brands through existing distribution channels and new doors opened in the reporting quarter.

North Asia – Hongkong, Taiwan, China

Overall, the timepiece turnover declined by 2%. Hongkong and China markets grew by 4% but turnover from Taiwan declined by 15% due to the political unrest in the country thus affecting consumer spending. Sale of GIRARD-PERREGAUX timepieces in China continued to grow by 40%.

Associated Companies

Indonesia continued to be a growth market with domestic sales increasing by 29% over 3Q06.

All 9 entertainment outlets in St James Power Station which were opened at end December 2006 have seen encouraging patronage.

Margin and Operating expenses

Gross margin remained relatively constant at 41.4% for this quarter compared to 41.3% in 3Q06.

In tandem with the growth in revenue through new stores opened, entry into the Thailand market and the introduction of GAP, operating expenses increased by 47% with major increases coming from staff cost, rental and higher advertising spend to launch GAP.

Balance Sheet

The Group's Balance Sheet remains strong with cash of S\$68 million against total borrowings of S\$32 million. It registered a zero gearing and a net asset value per ordinary share of 35.5 cents.

The Group will continue its efforts to maintain its momentum to grow its market share in the region.

As earlier planned, a total of 35 new stores have been opened in the territories in which the Group operates, with a further 8 more stores to be opened by the end of the financial year Timepiece distribution will continue to grow, with an emphasis on technical brands in China.

With its current cash position and further anticipated cash from exercise of balance of warrants to shares (warrants will expire in July 07), the Group is constantly evaluating various options for the effective utilization of these funds. To-date, 64% of warrants have been converted to shares.
