IFRA Category 4	Products related to fine fragrance: Hydroalcoholic and non-hydroalcoholic fine fragrance of all types e.g. Eau de Toilette, Parfum, Cologne, solid perfume, fragrancing cream, aftershaves of all types; Ingredients of perfume and fragrance mixtures for cosmetic kits; Scent pads; Scent strips				
IFRA Category 5A	Body lotion products applied to the body using the hands (palms), primarily leave on: Foot care products e.g. creams, powders; Insect repellent for application to the skin; All powders and talc (excluding baby powders and talc)				
IFRA Category 5B	Face moisturizer products applied to the face using the hands (palms), primarily leave on: Facial toner; Facial moisturizers and creams

Products not intended for direct skin contact, minimal or insignificant transfer to skin: Candles of all types; Laundry detergents for machine wash with minimal skin contact (e.g. Liquid tabs, pods); Automated air fresheners and fragrancing of all types e.g. concentrated aerosol with metered doses, plug-ins, electrical, incense, liquid refills (cartridge); Air delivery systems; Cat litter; Cell phone cases; Deodorizers/maskers not intended for skin contact e.g. fabric drying machine deodorizers, carpet powders; Fuels; Insecticides e.g. mosquito coil, paper, electrical, for clothing, excluding aerosols/sprays; Joss sticks or incense sticks; Dishwash detergent and deodorizers - for machine wash; Olfactive board games; Paints; Plastic articles (excluding toys); Scratch and sniff; Scent pack; Scent delivery system (using dry air technology); Shoe polishes; Rim blocks (Toilet)
