

THEATRICAL CONTACT LENSES AND COSMETIC COLOR CONTACT LENSES

It is important to know that all contact lenses are regarded as medical devices regardless if the contact lens has a “prescription power” or “no prescription power”.

All contact lenses must be sold in a way that is compliant with all laws, federal, provincial and local. Laws may vary from province to province and local to local. These rules require, among others, that theatrical and cosmetic lenses should not be sold to anyone under 18 years of age. If any Ripsters Halloween Shop customer fails to comply with FDA rules and regulations, federal, provincial and local laws regarding the sale of contact lenses, that customer agrees to fully indemnify and hold harmless Ripsters Halloween Shop from any claim or action.

All contact lenses are to be sold and used with the assistance and guidance of an eye-care professional. An individual should not wear contact lenses unless they have had an eye exam and have been trained in the proper techniques of contact lens insertion, removal and care. The customer acknowledges and agrees that Ripsters Halloween Shop only provides the contact lenses and is not involved in such assistance and guidance described above.

Contact lenses, even with proper use and prescription, can cause a variety of eye injuries and conditions, including but not limited to, infection, redness of the eye, corneal ulcer and scarring of the eye. Certain infections if left untreated can cause vision loss. Other risks in wearing contact lenses include, but are not limited to, conjunctivitis, corneal swelling, allergic reaction or abrasion.

Ripsters Halloween Shop shall not be bound by any representations or warranties, including warranties of merchantability and/or contact lenses sold, whether express, tacit or implied by stature or law, or whether made by any employee of Ripsters Halloween Shop, that are not recorded in writing in this agreement. Ripsters Halloween Shop shall not be liable in terms of this agreement in delicto, contract, warranty or otherwise for any indirect, special or consequential damages or loss suffered by the customer or any third party or any direct damages or loss suffered by the customer or any third party which arise out of or are pursuant to any negligent act or omission of Ripsters Halloween Shop.

Theatrical or cosmetic contact lenses should not be worn while operating a motorized vehicle.

All contact lenses sold by Ripsters Halloween Shop are daily wear lenses. This means that the lenses cannot be worn while sleeping. The actual wearing schedule for any contact lens must be determined by the individual wearer's eye care provider. Solutions and care regimens are not the responsibility of Ripsters Halloween Shop but the individual wearer's eye provider.

CONTACT LENSES ARE NOT TO BE WORN BY MULTIPLE PERSONS, EVEN FOR MOVIES OR THEATRICAL USE. CONTACTS SHOULD NOT BE SHARED WITH OTHER PEOPLE UNDER ANY CIRCUMSTANCES.
