## **USA Limited Warranty**

THE WARRANTY BELOW HAS BEEN DRAFTED TO COMPLY WITH FEDERAL LAW APPLICABLE TO PRODUCTS MANUFACTURED AFTER JULY 4, 1975.

This warranty is extended only to the original purchaser/user of our products when purchased new and unused from Invacare Corporation or a dealer. This warranty is not extended to any other person or entity and it is not transferable or assignable to any subsequent purchaser or owner. Coverage under this warranty will end upon any such subsequent sale or other transfer of title to any other person.

This warranty gives you specific legal rights and you may also have other legal rights which vary from state to state.

Invacare warrants its product to be free from defects in materials and workmanship for the time periods listed in the following table.

Product repairs shall not extend this warranty - coverage for repaired product shall end when this limited warranty expires.

This warranty does not include any labor or shipping charges incurred in replacement part installation or repair of any such product. This warranty only applies to the labor for repairs performed by the Invacare Service Department or an Invacare service center. It does not apply to the labor performed by the purchaser or user. ATTEMPTING TO SERVICE THE PRODUCT BY ANYONE OTHER THAN AN INVACARE-CERTIFIED TECHNICIAN WILL VOID THIS WARRANTY.

For warranty service, please contact the provider from whom you purchased your Invacare product. In the event you do not receive satisfactory warranty service, please write directly to Invacare at the address on the back cover. Provide provider's name, address, model number, date of purchase, indicate nature of the defect and, if the product is serialized, indicate the serial number.

Invacare Corporation will issue a return authorization. The defective unit or parts must be returned for warranty Additional product information can be found in the user manual, which is available on the Invacare website.
