While legal databases are a daily tool for lawyers, MAIK opens the door to in-house expertise, allowing you to access essential know-how from specific cases.

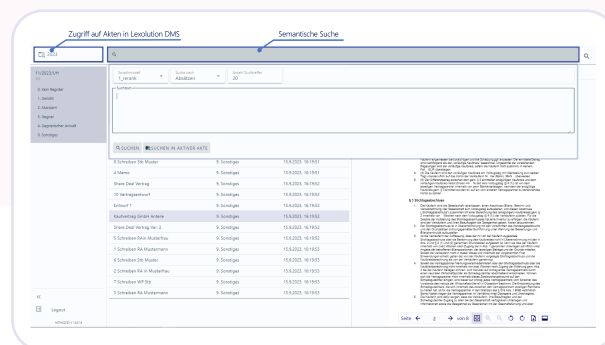
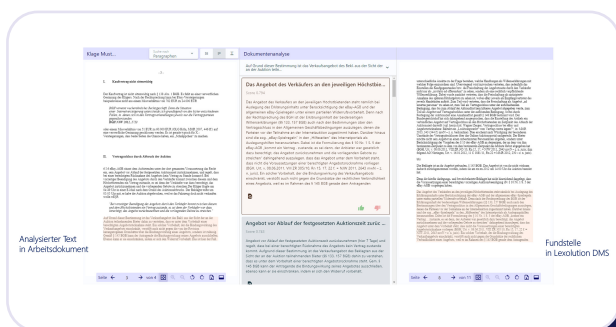


MAIK opens the door for young associates to access the expert knowledge archived in the firm. This not only relieves the partners, but also leads to optimised results.

Thanks to the interface to Lexolution DMS, MAIK searches through the files and documents contained therein. No copy of the documents is made, nor is any data exchanged externally. The search indices are continuously updated. While you manage your documents in Lexolution DMS as usual, the interface takes care of the search provision and automatic indexing.
