4. First-aid measures

Inhalation

Move to fresh air. Get medical attention immediately.

Skin contact

Take off immediately all contaminated clothing. Immediately flush skin with plenty of water. Call a physician or poison control center immediately. Wash contaminated clothing before reuse. Wash clothing separately before reuse.

Eye contact

Immediately flush eyes with plenty of water for at least 15 minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Call a physician or poison control center immediately.

Induce artificial respiration with the aid of a pocket mask equipped with a one-way valve or other proper respiratory medical device.

Large Spills: Stop the flow of material, if this is without risk. Dike the spilled material, where this is possible. Absorb in vermiculite, dry sand or earth and place into containers. Following product recovery, flush area with water.

Small Spills: Wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to remove residual contamination.
