Lip products of all types (solid and liquid lipsticks, balms, clear or coloured etc.); Children's toys	IFRA Class 1 Limit
Deodorant and antiperspirant products of all types including any product with intended or reasonably foreseeable use on the axillae or labelled as such (spray, stick, roll-on, under-arm, deo-cologne etc.); Body sprays	IFRA Class 2 Limit
Eye products of all types (eye shadow, mascara, eyeliner, eye make-up, eye masks, eye pillows, etc.) including eye care and moisturizer; Facial make up and foundation; Make-up remover for face and eyes; Nose pore strips; Wipes or refreshing tissues for face, neck, hands or body; Body and face paint (for children and adults); Facial masks for face and around the eyes	IFRA Class 3 Limit
Hydroalcoholic and non-hydroalcoholic fine fragrance of all types (Eau de toilette, parfum, cologne, solid perfume, fragrancing cream, aftershaves of all types, etc.); Fragranced bracelets; Ingredients of perfume kits and fragrance mixtures for cosmetic kits; Scent pads, foil packs; Scent strips for hydroalcoholic products	IFRA Class 4 Limit

Candles of all types (including encased); Laundry detergents for machine wash with minimal skin contact (e.g. liquid tabs, pods); Automated air fresheners and fragrancing of all types (concentrated aerosol with metered doses (range 0.05-0.5mL/spray), plug-ins, closed systems, solid substrate, membrane delivery, electrical, powders, fragrancing sachets, incense, liquid refills (cartridge), air freshening crystals); Air delivery systems; Cat litter; Cell phone cases; Deodorizers/maskers not intended for skin contact (e.g. fabric drying machine deodorizers, carpet powders); Fuels; Insecticides (e.g. mosquito coil, paper, electrical, for clothing) excluding aerosols/sprays; Joss sticks or incense sticks; Dishwash detergent and deodorizers – for machine wash; Olfactive board games; Paints; Plastic articles (excluding toys); Scratch and sniff; Scent pack; Scent delivery system (using dry air technology); Shoe polishes; Rim blocks (toilet)	IFRA Class 12 Limit
