Enclosed is a payment of \$50.00 payable to SFA, Chapter 38 for the initiation fee of \$10.00 and dues of \$40.00. To maintain my membership, I agree to pay the annual dues of \$40.00 no later than 31 January each year; if paid after 31 January, I agree to pay an additional \$5.00 reinstatement fee for a total of \$45.00.
