### CONSIGNOR AGREEMENT

**FURNISHINGS:** All items must be CLEAN, free of odor, pet hair and in “Ready to Sell” condition.

**CONSIGNMENT PERIOD:** Nine weeks. After nine weeks, any unsold item will be considered an Expired Item.

**EXPIRED ITEMS:** Select desired option for items not sold by the end of your consignment period:

- Donate items (or as indicated on inventory sheet.)
- Consignor will retrieve unsold items. (Must be retrieved within 7 days)

**PICK-UP DATE:** The day the Consignment Period ends. **Note: PICK-UP DATE on Inventory Sheet**

\*\* Items left 7 days past Pick-up Date will be donated or sold at a reduced price. Consignor will receive 15% of net proceeds if sold.

**PRICING:** Consignor’s items will be priced by Wabi Sabi Shop. A 17% processing fee is added to each item. *Fees will not affect the agreed upon selling price. Fees will not be shown on inventory list nor included in split.*

Markdowns will automatically occur every 3 weeks as described below. (*Additional reductions may apply during special sales.*)

**CONSIGNOR PAYMENTS & FEES:** A one-time \$15 account set-up fee will be deducted from your first check.

You will receive for all Furniture: 50% by check

You will receive for other items: 40% by check

Checks may be picked up at the shop on the 10<sup>th</sup> - (*of the month following the sale*).

*OPTIONAL*  Please mail my checks. (*\$2 fee will be deducted.*)

**As the consignor, I acknowledge:** All items presented are mine to sell and are free of all liens and encumbrances. Wabi Sabi Shop is not responsible for theft, damage, or loss by fire, water or any other loss to merchandise.
