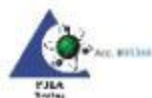
Laboratory note: The estimated concentration of the unknown peak in the sample is 11.6%. Currently PharmLabs Laboratory can not confirm an unidentified peak in your chromatogram due to interference (only with highly concentrated DE products) from which we believe to be either (1S)-THC or (1R)-THC. At this time there are no reference standards available for (1S)-THC. (1S)-THC is a different compound from the main (1S)-THC cannabinoid and, therefore, these two compounds may have different efficacies. Using the most advanced instruments and techniques available, the separation of (1S)-THC and (1R)-THC is problematic for the scientific community as a whole. PharmLabs believes the unidentified peak to be a combination of (1S)-THC and (1R)-THC with the majority, if not all, of the concentration being (1S)-THC. Total (1S)-THC Concentration is estimated to be 49.6%.
