**Our work-training and adult development programs teach people with disabilities the attitudes and behaviors that are needed to be successful in any job or community. Our Employment Resource Centers teach work skills through various packaging and assembly tasks, teaching culinary skills through our food service training program, providing document imaging and destruction services, among others. As part of their training, individuals served by this program receive wages based on their productivity. Our Job Discovery Program is a school-to-work transition program that offers students with intellectual disabilities the opportunity to experience careers and receive wages based on their duties. Our Fine and Performing Arts program develops social interaction and peer relationships. Artists**

**The Service Contracts provide community-based employment and training opportunities for individuals with intellectual and other disabilities. Opportunity Village operates a number of "small businesses" where over 70% of the workers are people with disabilities. They clean over 8.0 million square feet of government and commercial office space. They serve over 229,000 meals every year to the airmen at Nellis AFB. They operate the postal service center for Nellis AFB and handle all secure and non-secure mail. They provide restroom attendant services for McCarran International Airport. Most of the individuals served by this program make wages at or above the Federal minimum wage and are eligible for health insurance and other benefits.**
