If a refund needs to be made via bank transfer, we process your bank details. The legal basis is the necessity to fulfill a legal obligation.

We also store information about returns for accounting purposes according to our legal obligations.

If you are a sole trader, we process your personal identification number to fulfill our contractual obligations to you.

We may also use your email address and telephone number for direct marketing, based on our legitimate interest in marketing our products to existing customers.

Payments on our website are handled by third-party payment services responsible for payment information.

# **Recipients of Newsletters**

If you subscribe to our newsletter, we process your email address to send out the newsletter based on our legitimate interest in marketing.
