**Trail Rules & Regulations**

---

**GENERAL TRAIL RULES & ETIQUETTE**

- All trail users and passengers shall have a valid SRRA user permit sticker.
- The user permit sticker is always to be affixed to the left side of user's helmet below the goggle line by either permit adhesive or Velcro tape.
- User must have permit plainly displayed and readily available.
- Any rider shall have a permit in their possession when on the trail and shall present it when asked by a SRRA Ranger or law enforcement officer.
- Lost or stolen permits should contact the SRRA office at (276) 807-7581.
- Unless otherwise stated in rules, everyone shall wear a DOT, SNELL or other approved helmet.
- Trails are open from sunrise to sunset unless otherwise designated.
- Trails may be closed or rerouted for any reason deemed appropriate or as needed for maintenance and/or safety reasons.
- We recommend gloves, goggles, boots and protective gear to maximize your trail experience.
- During hunting season "blaze orange" is encouraged for all trail users.
- Obey all trail rules and regulations and exercise proper etiquette on all SRRA property.
- Riders shall obey posted speed limits, trail boundaries, and requests from SRRA Rangers.
- Adult supervision is required for those under age 18.
- All riders are required to stop when signaled by a SRRA ranger or law enforcement officer.
- If underage, a parent or guardian shall sign a liability waiver for that individual.
- A valid Driver's License or Photo ID is required to sign waiver and to purchase a permit.
- All applicable Federal and State laws will be enforced and shall always be adhered to by all users.
- Drive or ride at a speed reasonable for conditions and adhere to all directional and speed limit signs—not to exceed 25 mph.
- No drugs or alcoholic beverages may be consumed or carried on SRRA property.
- No firearms or fireworks.
- Obey all signs, gates, and barriers.
- Stay on marked trails, only enter and exit the trail systems at a trailhead, community or other approved connectors.
- Do not enter a "no trail," "no entry" or any other gated area.
- Stay out of streams and all non-designated wetlands or water collection areas.
- No fires and no camping on the trails.
- Dogs must always be leashed when on all SRRA Systems.
- Vehicles, equines, and bikes shall be under control and appropriate to the rider's age, size, and experience.
- DO NOT LITTER. Have respect for nature and the surrounding environment. Pack out what you pack in.
- As a best practice, don't be on the trails alone. Always bring along a partner.
- Park only in designated areas.
- SRRA is not responsible for any lost or stolen property.
- DO NOT stop, stand, or loiter at any gas well location or equipment location whatsoever. These are potentially dangerous and doing so could result in injury or death.
- NO PHOTOGRAPHS shall be taken of any machinery, equipment, gas wells, structures, or other commercial equipment on any trail whatsoever.
- Activities are subject to video surveillance, particularly as related to any commercial site located on or near the trail system.

**SPECIAL SAFETY REQUIREMENTS FOR ALL MOTORIZED VEHICLES**

- No person shall drive an ATV/UTV unless that person meets the minimum age recommendation specified by the ATV/UTV manufacturer for the ATV/UTV that is being driven.
- No passengers on any machine unless the machine is manufactured for the driver and a passenger.
- The number of passengers carried on a side-by-side utility type vehicle shall be limited by the number of manufacturers installed seat belts.
- Speed Limit is limited to 25 mph.
- Individual and machine liability insurance is encouraged for all riders.
- Unauthorized 4x4 road vehicles, rock crawlers, rail buggies and dune buggies are not allowed.
- Follow all rules and regulations identified in UTV owner's manual and rules and regulations listed below:
- Utility Type Vehicles can only be operated on designated trails.
- Machines may not be self-constructed.
- UTV shall be equipped with a steering wheel from the manufacturer.
- UTV shall be equipped with ROPS (Roll-Over Protection System) from the manufacturer.
- Machines shall be equipped with manufacturer seat belts and shall be in good working order.
- Low-pressure tires required - Max 20 psi at manufacturer's recommended inflation.
- All participants shall abide by all the manufacturer's requirements regarding the age and size of operators and passengers.

**EQUINE TRAIL RULES**

- An equine approved helmet is required for those under the age of 18. Helmets are strongly recommended for all riders.
- Young or inexperienced riders and/or horses are not to be on the trail without an experienced rider and equine.
- A Negative Coggins test is required for all equines using the trails.
- This shall be presented upon request by any SRRA Ranger or law enforcement officer.
- If required by rider's state of residence, a health certificate for equines shall be presented upon request.
- The state of Virginia requires all out of state equines to have a health certificate.

**JEEP TRAIL RULES**

- Helmets are not required but Driver and Passengers are encouraged to wear Helmets.
- All Jeeps and 4x4 vehicles that are tagged and street legal will be permitted on Jeep Trails.
- Any non-tagged vehicle that isn't classified as an ATV, Side by Side, UTV, Adventure Bike, Dirt Bike or Dual Sport Bike IS NOT permitted on trail.
- No Riders in the Bed of Trucks.
- Driver and Passengers must be in a manufacturer approved seat with seat-belt fastened.
- Riders are responsible for removing damaged vehicles from the trails and SRRA must be notified.
- Riders are responsible for containment and cleanup of any spill fluids or glass and SRRA must be notified.
- Bicycles Are Allowed

---

**SHOOTING SPORTS RULES**

- You must always check in before using facility.
- You must always have your permit with you.
- No firearm is to be used on any range other than the range designate for that discipline—No guns on archery range and no bows on the gun range.
- Stay in designated areas on the range.
- Never shoot at glass or other non-biodegradable targets on any range.
- Always keep firearms pointed downrange and only fire directly downrange.
- Never crossfire at a target.
- All firearms must be unloaded, broken open and/or display empty chamber flag until you are on the firing line ready to fire.
- Hearing and eyewear protection are required on gun range only.
- Use only SRRA traps and targets—Absolutely no personal/hand traps allowed.
- Pick up your brass, hulls and trash.
- No hunting.
- Rude and unsportsmanlike conduct including but not limited to use of profanity, willful vandalism, fraud or failure to follow rules will result in suspension, loss of membership and where appropriate prosecution.
- Follow specific rules posted on signs at ranges.
- Parents must supervise and accompany children 18 and under at all times.
- Broadheads to be used only in designated areas.
